DIFFICULT IN THE RECENT HISTORY OF U.S.-PERUVIAN BILATERAL RELATIONS. IT WAS MADE EVEN MORE CHALLENGING BY THE

ABSENCE OF AN AMBASSADOR AFTER ANTHONY QUAINTON'S DEPARTURE IN AUGUST. ON APRIL 5 PRESIDENT FUJIMORI DISSOLVED THE CONGRESS AND JUDICIARY AND SUSPENDED THE CONSTITUTION. HE SOUGHT TO JUSTIFY HIS ACTIONS BY POINTING TO A CORRUPT JUDICIARY AND A CONGRESS THAT DID NOT REPRESENT THE ELECTORATE. THE UNITED STATES RESPONDED BY IMMEDIATELY SUSPENDING THE LION'S SHARE OF ASSISTANCE TO PERU, ALTHOUGH HUMANITARIAN ASSISTANCE AND SELECTED NARCOTICS PROGRAMS WERE ALLOWED TO CONTINUE.
