2. COLETTA YOUNGERS, SENIOR ASSOCIATE OF THE WASHINGTON OFFICE ON LATIN AMERICA, VISITED PERU THE WEEK OF JULY 12. SHE PARTICIPATED IN A CONFERENCE ON VIOLENCE IN PERU, MET WITH PUBLIC MINISTRY OFFICIALS AND HUMAN RIGHTS GROUPS, GAVE MEDIA INTERVIEWS, AND PAID A CALL ON THE EMBASSY.
