2. POST ASSUMES THAT INS HAS ALREADY CHECKED WITH THE DEPARTMENT OF STATE REGARDING THE POLITICAL SITUATION IN PERU AND IS AWARE THAT THE PARTIDO APRISTA PERUANO IS THE PARTY IN POWER AND THE SENDERO LUMINOSO IS A MAOIST TERRORIST ORGANIZATION. SENDERO HAS ASSASSINATED A NUMBER OF LOCAL OFFICIALS, AND ANY GOVERNMENT OR APRA PARTY OFFICIAL COULD BE CONSIDERED A POTENTIAL TARGET OF THE GROUP. SENDERO THREATS AGAINST GOVERNMENT AND PARTY OFFICIALS ARE COMMON, AND ALTHOUGH POST IS NOT FAMILIAR WITH INS CRITERIA FOR POLITICAL ASYLUM, WE DO NOT BELIEVE THIS KIND OF THREAT SHOULD BE CONSIDERED SUFFICIENT FOR APPROVAL OF A POLITICAL ASYMUM APPLICATION.
