1. (U) SUMMARY: SENDERO LUMINOSO (SL)
DESTROYED A FOOD WAREHOUSE IN VILLA EL SALVADOR
TWO DAYS AFTER THE VISIT OF CODEL HATFIELD, BUT
THE TWO EVENTS ARE PROBABLY UNRELATED. IN OTHER
INCIDENTS TWO PERUVIANS DIED AS SENDERO
CONTINUES TO TARGET DEVELOPMENT PROJECTS.
END SUMMARY.

SL GOES AFTER FOOD PROGRAM

- 2. (U) THE LIMA PRESS CREDITED SL TERRORISTS FOR BOMBING THE OFFICES OF THE POPULAR WOMEN'S FEDERATION (FPM) IN THE "PUEBLO JOVEN" OF VILLA EL SALVADOR ON SEPTEMBER 10. THE BOMB DESTROYED A TWO WEEK STOCK OF FOOD STORES USED FOR FEEDING UP TO THO THOUSAND NEEDY FAMILIES AND THE VASO DE LECHE SCHEME. NO INJURIES WERE REPORTED, BUT THE OFFICES AND A VEHICLE USED (FOR FOOD DISTRIBUTION WERE DAMAGED.
- 3. W) THE BOHBING OCCURRED TWO DAYS AFTER CODEL HATFIELD VISITED VILLA EL SALVADOR. THE CODEL (WITH 16 AMERICANS) VISITED A FEEDING PROGRAM CENTER. BUT NOT THE ONE BOMBED. A VILLA EL SALVADOR COMMUNITY LEADER AND FORMER MAYOR TOLD US ME TMOUGHT THE BUHS WAS NOT RELATED TO THE U.S. DELEGATION; ME THOUGHT THAT IT WAS PART OF SL'S WELL-ESTABLISHED POLICY OF ATTACKING

DEVELOPMENT AND ASSISTANCE PROJECTS. VILLA EL SALVADOR OFFICIALS CONCEDE SLOPERATES IN THE "PUEBLOS JOUENES" BUT INSIST THAT THE MAJORITY OF THE PEOPLE OPPOSE TERRORISM

4. (U) THE ATTACK WAS THE SECOND AGAINST THE VASO DE LECHE PROGRAM IN THE LIMA AREA WITHEN TWO WEEKS. AN SL ASSASSINATION TEAM APPEARS

UNITED NATIONS-CONNECTED OFFICER KILLED

5. (W) THE UN OFFICE OF INFORMATION IN LIMA TOLD US THAT AN EMPLOYEE OF A UN-FINANCED AND SUPPORTED DEVELOPMENT COOPERATIVE IN THE HUALLAGA VALLEY WAS SNOT TO DEATH BY UNKNOWN SUBURESIVES APPROXIMATELY TWO WEEKS AGO. HE EMPHASIZED THAT THIS PERSON WAS NOT DIRECTLY CONNECTED TO THE UN OPERATIONS IN PERU, AND AS SUCH THE UN INFORMATION OFFICER SAID HE DID NOT EVEN KNOW THE VICTIM'S MAME. THIS UN SOURCE CONFIRMED THAT NO UN EMPLOYEE HAD BEEN KILLED IN RECENT DAYS REF. TELCONI.

- S. (U) AN AID EMPLOYEE WHO OFTEN GOES TO THE HUALLAGA VALLEY REPORTED THAT A LOCAL COOPERATIVE OFFICER NAMED MUNOZ AND THREE OTHER CAMPESINOS WERE KILLED ON AUGUST 28 IN AN SL DOMINATED "RED ZONE" NEAR UCHIZA IN SAN MARTIN DEPARTMENT. MUNOZ APPARENTLY HAD HIS THROAT CUT AND THE OTHERS WERE KILLED "LIKE THE BULLS" WITH A HOLE PUNCHED INTO THE BACK OF THEIR NECKS, REPORTEDLY DURING A TYPE OF MACABRE SL RITUAL.
- 7. CLOUD COMMENT: SL IS LIKELY TO CONTINUE
