THE DETAINEES HAVE DENOUNCED THE INCIDENTS TO THE SPECIAL COMMISSION OF ATTORNEYS IN CHARGE OF THE INVESTIGATION OF "DISAPPEARED" PERSONS IN AYACUCHO. MEMBERS OF THE SPECIAL COMMISSION OF ATTORNEYS ALLEGEDLY VISITED THE LOS

CABITOS MILITARY BARRACKS FOLLOWING REPORTS THAT RECENTLY RELEASED PRISONERS HAD SEEN SOME OF THE "DISAPPEARED" IN DETENTION AT THE BARRACKS. ALTHOUGH NO DETAINEES WERE FOUND AT THE BARRACKS, AMNESTY REPORTS THAT OTHER PRISONERS HAVE TESTIFIED THAT THE BARRACKS WERE OFTEN EMPTIED WHEN VISITORS WERE EXPECTED. AMNESTY PROVIDED THE FOLLOWING DETAILS REGARDING THE SEVEN INDIVIDUALS.

- 3. ELIAS SULCA MUNALLA, AGE 16, STUDENT, WAS DETAINED AT HIS PARENTS HOME IN THE MAGDALENA NEIGHBORHOOD OF AYACUCHO ON 11 DECEMBER 1987 BY A COMBINED UNIT OF THE CIVIL GUARD AND THE ARMY. THE DETENTION WAS WITNESSED BY HIS PARENTS WHO SAID HE WAS DRIVEN TO THE LOS CABITOS MILITARY BARRACKS.
- 4. CESAR GARCIA AMORIN, AGE 25, DENTAL TECHNICIAN, WAS DETAINED ON 3 DECEMBER IN THE CITY OF AYACUCHO BY MEMBERS OF THE POLICE INTELLIGENCE AND THE ARMY. PRISONERS RELEASED FROM THE LOS CABITOS MILITARY BASE ON 12 DECEMBER STATED THAT THEY HAD SEEN HIM THERE IN A VERY POOR STATE, WITH SIGNS OF HAVING BEEN BEATEN.
- 5. PRIMITIVO PANIAGUA INCA, AGE 60, JUSTICE OF PEACE, (JUEZ DE PAZ) FROM HUALLA, HUANCAPI, ICTOR FAJARDO PROVINCE, WAS DETAINED AT HIS HOME ON 12 OCTOBER BY SOLDIERS OF THE MILITARY BASE OF HUALLA. PANIAGUA'S UNCLASSIFIED
