U.S. ASSISTANCE PROGRAMS TARGETTED ON SHARED U.S./PERUVIAN COUNTERNARCOTICS OBJECTIVES. YOUR VISIT WILL GIVE US A VALUABLE OPPORTUNITY TO FOCUS HIGH LEVEL GOP ATTENTION ON WHAT MUST BE DONE IN ORDER TO SAFEGUARD OUR ESP/FMF PROGRAMS. I HOPE YOU WILL ADDRESS THE FOLLOWING ISSUES WITH PRESIDENT FUJIMORI:

-- NATIONAL REGISTRY OF DETAINEES: WE WOULD LIKE PRESIDENT FUJIMORI TO GIVE HIS MILITARY AND POLICE CLEAR INSTRUCTIONS TO COOPERATE FULLY IN ESTABLISHING A CENTRAL REGISTRY OF DETAINEES TO BE MANAGED BY THE ATTORNEY GENERAL'S OFFICE. AS SPELLED OUT IN CONGRESSIONALLY-MANDATED CONDITIONS, PERU MUST PUBLISH A LIST OF DETAINEES WE INTERPRET THIS TO MEAN SOME FORM OF PUBLIC ACCESS TO THE REGISTRY. WE ARE DEVELOPING A TECHNICAL ASSISTANCE PACKAGE AND ARE WORKING WITH VARIOUS GOP AUTHORITIES BUT WE NEED A PERSONAL PUSH FROM FUJIMORI. MEETING THIS REQUIREMENT IS A CONDITION FOR DISBURSEMENT OF THE THIRD TRANCHE OF OUR MILITARY AND ECONOMIC ASSISTANCE.

-- PROGRESS ON NINE HUMAN RIGHTS CASE: THE CONGRESS HAS ASKED FOR PROGRESS IN THE PROSECUTION OF NINE DOCUMENTED HUMAN RIGHTS CASES. SO FAR ONLY TWO CASES ARE EVEN IN COURT WITH NOBODY CHARGED IN THE OTHER SEVEN CASES. THIS IS A CRITICAL TEST OF THE GOP'S CAPACITY TO PROSECUTE HUMAN RIGHTS VIOLATORS. ADEQUATE PROGRESS ON THESES CASES IS A CONDITION FOR THE RELEASE OF HALF OF OUR MILITARY ASSISTANCE WE

-- FUJIMORI SPEECHES DENIGRATING HUMAN RIGHTS ORGANIZATIONS: IN SEVERAL RECENT SPEECHES, THE PRESIDENT HAS SEVERELY CRITICIZED HUMAN RIGHTS GROUPS FOR THEIR FAILURE TO DENOUNCE TERRORIST OFFENSES, AND THEIR PLAYING OF GOP ABUSES.

FUJIMORI HAS STOPPED SHORT OF CHARGING HUMAN RIGHTS GROUPS - SUCH AS AMNESTY AND AMERICA'S WATCH - AS BEING "USEFUL FOOLS," OR "LEGAL ARMS" OF THE TERRORISTS, BUT HIS TREATMENT OF THIS ISSUE UNDERCUTS THE GOP'S IMAGE ABROAD. LOCAL HUMAN RIGHTS ACTIVISTS FEAR THAT PARAMILITARY GROUPS MAY TAKE FUJIMORI'S WORDS AS A GREEN LIGHT TO ATTACK THEM.

-- BARRIOS ALTOS MASSACRE: PRELIMINARY INFORMATION SUGGESTS THAT ELEMENTS ASSOCIATED WITH GOVERNMENT SECURITY FORCES MASSACRED 17 CIVILIANS ON NOVEMBER 3. THE PUBLIC INVESTIGATION IS GOING NOWHERE, ALTHOUGH THE GOP INTERNAL INVESTIGATION IS APPARENTLY IDENTIFYING THOSE RESPONSIBLE. WE DO NOT KNOW FUJIMORI'S THINKING ON THIS ISSUE, BUT FAILURE TO NIP UNLICENSED, PARA-MILITARY DEATH SQUADS IN THE BUD COULD LEAD TO AN EL SALVADOR STYLE NIGHTMARE. WE SHOULD ENCOURAGE FUJIMORI TO STOP PARA-MILITARY GROUPS BEFORE THEY DEVELOP MOMENTUM.

-- NARCOTICS PERFORMANCE: WE CAN CONGRATULATE THE GOP FOR GIVING THE ARMED FORCES AN ROLE IN
