4. POLITICAL ASSASSINATIONS AND EXTRAJUDICIAL KILLING: OVER THE YEAR TO DATE, SENDERO ASSASSINATIONS EXCEED THOSE OF THE SECURITY FORCES BY A FACTOR OF 7 TO 1. (YOU WILL NOTE THAT MORE THAN A THIRD OF THE EXECUTIONS ATTRIBUTED TO THE MILITARY OVER THE PAST TEN MONTHS APPEAR TO BE BUNCHED IN OCTOBER. HOWEVER, THE COORDINATOR INDICATED THAT 30 OF THE REPORTED 34 ARE BASED ON ONE REPORTED INCIDENT IN TOCACHE, SAN MARTIN. THE COORDINATOR INCLUDED THE FIGURE IN ITS STATISTICS BECAUSE OF REPEATED PRESS ACCOUNTS, BUT HAS BEEN UNABLE TO INDEPENDENTLY CONFIRM THIS NUMBER. EMBASSY NOTES THAT THE COORDINADORA'S ACKNOWLEDGMENT THAT 30 OF THESE EXECUTIONS ARE "UNCONFIRMED" PRESS REPORTS IS MOST UNUSUAL. THE VALIDITY OF THE NET OCTOBER NUMBER THEREFORE IS PARTICULARLY QUESTIONABLE.) THE COORDINATOR'S NEWEST FIGURES SHOW THAT TOTAL POLITICAL ASSASSINATIONS AND EXTRAJUDICIAL

5. DISAPPEARANCES: THE COORDINATOR REPORTS A CONTINUED DECLINE IN DISAPPEARANCES SINCE JULY, WITH 17 IN AUGUST, 7 IN SEPTEMBER AND 13 IN OCTOBER. THIS COMPARES WITH AN AVERAGE OF 36 PER MONTH FOR THE PRECEDING SEVEN MONTHS. THE SPECIAL HUMAN RIGHTS PROSECUTOR'S OFFICE, MEANWHILE, REPORTS 29 DISAPPEARANCES IN AUGUST, 3 IN SEPTEMBER AND 10 IN OCTOBER. THIS COMPARES WITH AN AVERAGE OF 38 OVER THE PRECEDING SEVEN MONTHS. THE COORDINADORA'S POLITICAL VIOLENCE FIGURES FOR NOVEMBER ARE NOT COMPLETE YET. HOWEVER, AS OF DECEMBER 12, THEY HAVE RECEIVED NO/NO REPORTS OF ANY DISAPPEARANCES IN NOVEMBER.

6. FOR BOTH THE COORDINATOR AND THE SPECIAL HUMAN RIGHTS PROSECUTOR, THE FIGURES USED ARE GROSS DISAPPEARANCES SINCE SUBSEQUENT "RESOLUTIONS" CANNOT BE REFLECTED IN THE MOST RECENT NUMBERS. EVEN SO, SO FAR THIS YEAR, SOME 20 PERCENT OF GROSS DISAPPEARANCES HAVE BEEN "RESOLVED," GENERALLY BY THE PERSON BEING FOUND ALIVE.

9. THE PERUVIAN MILITARY HAVE BEEN REVIEWING THEIR LEGAL SYSTEM SINCE EARLY IN 1991. THIS REVISION WAS MOTIVATED BY THE PERCEPTION WITHIN THE PERUVIAN MILITARY THAT MILITARY JUSTICE IS TOO SLOW (CASES CAN DRAG ON FOR 5 TO TEN YEARS), SENTENCES ARE TOO LENIENT, AND THE SYSTEM HAS NOT BEEN ADJUSTED TO THE REALITY OF INTERNAL WAR. THE PROPOSED NEW SYSTEM WOULD:

- A. GIVE THE MEMBERS OF THE SUPREME COUNCIL OF WAR (THE COURT MARTIAL OF LAST APPEAL) THE SAME POWERS AS THE SUPREME COURT.
- B. GIVE GREATER PARTICIPATION IN MILITARY JUSTICE TO THE CIVILIAN ATTORNEY GENERAL (PUBLIC MINISTRY) IN CASES OF ACCUSATIONS OF HUMAN RIGHTS VIOLATIONS BY THE MILITARY.
- C. SPECIFY CRIMES AGAINST LIFE, BODY AND HEALTH WHICH WERE NOT PREVIOUSLY CONSIDERED CRIMES IN THE MILITARY CODE.
- D. ADD THE SPECIFIC CRIME OF "DENYING A

10. THE FOLLOWING IS THE STATUS OF FIVE OF THE NINE CASES BASED ON MFA AND OTHER INFORMATION:

- SANTA BARBARA: THIS CASE HAS BEEN OPENED BEFORE THE PERMANENT WAR COUNCIL OF THE SECOND JUDICIAL ZONE. IT IS IN THE INSTRUCTIONAL PHASE. A MILITARY INVESTIGATION HAS CHARGED A LIEUTENANT AND FIVE NON-COMMISSIONED OFFICERS WITH RESPONSIBILITY. THE PROSECUTOR IS ASKING A SENTENCE OF 15 YEARS IF FOUND GUILTY.

- CALLAO: MFA ONLY CONFIRMED THE CASES ARE GOING FORWARD. SEE LIMA 16981 FOR DETAILS. WE CAN ALSO CONFIRM THAT THE COURTS HAVE RULED AGAINST THE DEFENDANT'S PETITION THAT THE CASES BE TRIED IN MILITARY COURT. PROSECUTION WILL CLEARLY PROCEED IN CIVILIAN TRIBUNALS.

- CAYARA: THIS CASE IS NOW BEFORE THE INTER-AMERICAN COURT OF HUMAN RIGHTS. ALL PROCEDURES WITHIN PERUVIAN LAW HAVE BEEN EXHAUSTED, BUT THE PERUVIAN SYSTEM ALLOWS APPEAL TO THE INTER-AMERICAN COURT, AND THE MFA SAYS THAT THE GOP WILL ABIDE BY THE DECISION OF THAT COURT.

12. WE HAVE JUST EXECUTED AN AGREEMENT TO PROVIDE THE FOLLOWING ASSISTANCE TO THE SPECIAL HUMAN RIGHTS PROSECUTORS IN THE EMERGENCY ZONES:

- A RADIO COMMUNICATIONS LINK CONNECTING THE SEVEN PROVINCIAL SPECIAL HUMAN RIGHTS PROSECUTORS WITH THE PARENT OFFICE WITHIN THE PUBLIC MINISTRY IN LIMA.

- A COMPUTER SYSTEM, LOCATED IN LIMA, TO AUTOMATE ALL DENUNCIATIONS OF HUMAN RIGHTS VIOLATIONS RECEIVED BY THE SPECIAL PROSECUTORS.

- AN EXPANDED RADIO COMMUNICATIONS NETWORK WHICH WOULD CONNECT ALL OF THE PROSECUTORS' OFFICES IN THE EMERGENCY ZONES TO THE PUBLIC MINISTRY IN LIMA. THIS WOULD EFFECT ROUGHLY 60 PROVINCIAL PROSECUTORS.

- INSTALL A CENTRAL COMPUTER WITHIN THE OFFICE OF THE SPECIAL HUMAN RIGHTS PROSECUTOR IN LIMA TO INTEGRATE THE TWO SEPARATE REGISTRIES OF DETAINEES TO BE MAINTAINED BY THE POLICE AND MINISTRY OF DEFENSE. INFORMATION WOULD BE INTEGRATED INTO ONE COMBINED LISTING AND MADE AVAILABLE TO PROSECUTORS THROUGHOUT THE NET.

- BUDGET CONSIDERATIONS PERMITTING, WE WOULD LIKE TO PROVIDE SOME KIND OF ASSISTANCE WITH TRANSPORTATION TO ALLOW THE PROSECUTORS GREATER ACCESS TO MILITARY INSTALLATIONS AND SITES OF REPORTED VIOLATIONS. THE CURRENT BUDGET OF UNDER USD 400,000 WILL PROBABLY NOT ALLOW US TO

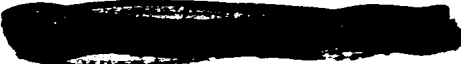
