JUSTICE (CSJM) ISSUED A COMMUNIQUE JUNE 3  
INFORMING THAT IT HAD DETERMINED THAT A DOCUMENT  
PROVIDED BY SELF-EXILED GENERAL RODOLFO ROBLES  
WAS NOT WRITTEN BY GENERAL WILLY CHIRINOS, AS  
ROBLES HAD ALLEGED. THE DOCUMENT IN QUESTION  
ACCUSES CERTAIN MILITARY OFFICIALS OF  
PARTICIPATING IN OR KNOWING ABOUT THE ABDUCTION  
AND EXECUTION OF TEN INDIVIDUALS FROM LA CANTUTA  
UNIVERSITY IN JULY 1992. IT WAS SUBMITTED TO  
THE CSJM AND TO A WEEKLY NEWS MAGAZINE BY ROBLES

IN LATE MAY (REFTEL); ROBLES CLAIMED THE HANDWRITING ON THE DOCUMENT BELONGED TO CHIRINOS, ONE-TIME HEAD OF ARMY INTELLIGENCE AND NOW AT PERU'S NATIONAL WAR COLLEGE.

2. (U) THE CSJM'S COMMUNIQUE ASSERTS THAT A HANDWRITING ANALYSIS BY THE NATIONAL POLICE'S CRIMINOLOGY LABS HAD DETERMINED THAT CHIRINOS WAS NOT THE AUTHOR OF THE DOCUMENT. THE CSJM CONCLUDED FROM THIS RESULT THAT "GENERAL ROBLES HAS FAILED TO SPEAK THE TRUTH."

3. [REDACTED] COMMENT: THE COMMUNIQUE WAS CLEARLY ISSUED TO FURTHER DISCREDIT ROBLES. THE DOCUMENT MIGHT BE COUNTERFEIT, BUT THAT ISSUE IS ALMOST IRRELEVANT. CHIRINOS PROBABLY PASSED INFORMATION TO ROBLES ABOUT THE INTELLIGENCE DEATH SQUAD THAT CARRIED OUT THE LA CANTUTA DISAPPEARANCES. WHATEVER THE TRUTH ABOUT THE DOCUMENT, THE MILITARY SEEMS TO HAVE DECIDED NOT TO TAKE OBVIOUS PUNITIVE ACTION AGAINST
