OFFICERS ACTING IN DEFENSE OF THE MILITARY INSTITUTION, RELEASED YET ANOTHER DOCUMENT TO "INFORM" THE PUBLIC ABOUT THE ARMY'S ALLEGED "DEATH SQUAD." THE DOCUMENT PURPORTS TO LINK FORMER ARMY INTELLIGENCE SERVICE CHIEF COL. ALBERTO PINTO CARDENAS TO THE DEATH SQUAD AND IDENTIFIES PINTO AS A CLOSE FRIEND OF PRESIDENTIAL SECURITY ADVISOR MONTESINOS. IT FURTHER CLAIMS INVOLVEMENT BY PINTO, MONTESINOS, AND FORMER DIRECTOR OF ARMY INTELLIGENCE GEN. RIVERO LAZO, AMONG OTHERS, IN THE NOVEMBER 1991 BARRIOS ALTOS MASSACRE AND THE JULY 1992 LA CANTUTA DISAPPEARANCES. END SUMMARY.

 ABOUT AN ARMY "DEATH SQUAD" (SEE REFTELS FOR REPORTS OF PREVIOUS "SLEEPING LION" DOCUMENTS). ENTITLED "ON THE DEATH SQUAD," THE FIRST PART OF THE DOCUMENT TIES YET ANOTHER SENIOR ARMY OFFICER, COL. ALBERTO PINTO CARDENAS (FORMER HEAD OF ARMY INTELLIGENCE SERVICE - SIE), TO THE DEATH SQUAD. PINTO IS DESCRIBED AS VERY CLOSE TO PRESIDENT FUJIMORI'S SECURITY ADVISOR VLADIMIRO MONTESINOS - BOTH COME FROM AREQUIPA (A MAJOR CITY IN SOUTHERN PERU), BOTH ATTENDED THE CHORRILLOS MILITARY ACADEMY (ONE YEAR APART), AND BOTH LATER SERVED TOGETHER IN AREQUIPA. PREVIOUS "SLEEPING LION" DOCUMENTS HAVE LINKED OTHER SENIOR ARMY OFFICERS, INCLUDING ARMY COMMANDER GEN. NICOLAS HERMOZA AND SPECIAL FORCES DIVISION HEAD GEN. LUIS PEREZ DOCUMET, EVEN MORE CLOSELY TO THE DEATH SQUAD.

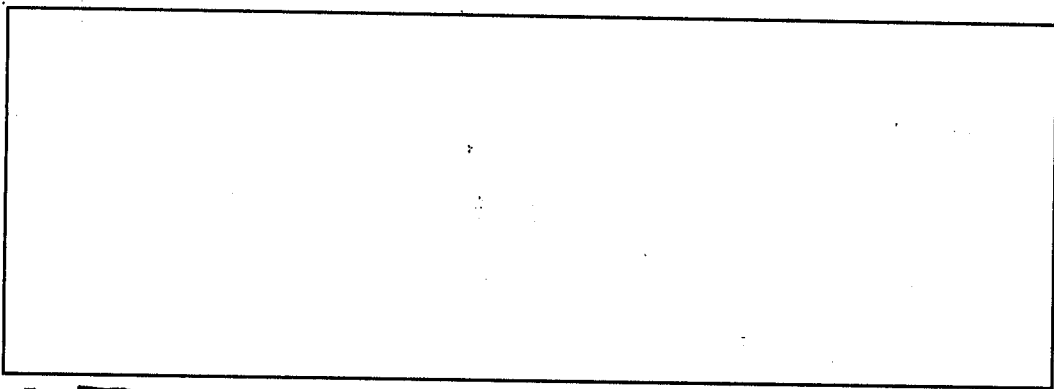

ACCORDING TO THE LATEST "SLEEPING LION" DOCUMENT, THE DEATH SQUAD WAS FORMED IN 1989 AT THE ARTILLERY BRANCH INSTALLATIONS OF THE ARMY INSTRUCTION AND TRAINING COMMAND FACILITIES (COINDE), AT THE BEHEST OF MONTESINOS AND WITH THE TACIT APPROVAL OF DEFENSE MINISTER GEN. MALCA VILLANUEVA (THEN HEAD OF COINDE), AMONG OTHERS. EARLY DEATH SQUAD OPERATIONS WERE CONDUCTED BY MEMBERS OF THE NATIONAL INTELLIGENCE SERVICE (SIN), THE SIE, AND

TEAM PROVIDED PERIMETER SECURITY FOR THE NOVEMBER 1991 BARRIOS ALTOS MASSACRE IN CENTRAL LIMA. (COMMENT: A MILITARY DEATH SQUAD IS WIDELY SUSPECTED OF HAVING CARRIED OUT THE STILL-UNRESOLVED MASSACRE.) THE DOCUMENT ALSO CLAIMS THAT PINTO, GEN. JUAN RIVERO LAZO (FORMER DIRECTOR OF ARMY INTELLIGENCE), AND A COL. NAVARRO PLANNED THE JULY 1992 DISAPPEARANCE OF NINE STUDENTS AND A PROFESSOR FROM THE LA CANTUTA UNIVERSITY. THE PLAN WAS APPROVED BY MONTESINOS AND EXECUTED BY MAJOR MARTIN RIVAS. PERIMETER SECURITY FOR OPERATION WAS CARRIED OUT BY TROOPS PROVIDED BY SPECIAL FORCES DIVISION HEAD GEN. PEREZ DOCUMET. THE DOCUMENT ALSO NAMES A MAJOR FELIPE LA ROSA GUEVARA AS HAVING PLAYED AN ACTIVE ROLE IN THE LA CANTUTA DISAPPEARANCES.

IT WAS PAMPAQUILLA WHO PROVIDED THE ADDRESS IN BARRIOS ALTOS WHERE SL HELD MEETINGS AND WHO ALSO PROVIDED INFORMATION THAT LED TO THE

PAMPAQUILLA IS ALSO ACCUSED OF HAVING HELPED MAJ. MARTIN RIVAS WITH THE ASSASSINATION OF MANUEL FEBRES, A LAWYER WHO DEFENDED PROMINENT SENDERO LEADER OSMAN MOROTE, WHO WAS KILLED ON A LIMA BEACH IN 1988.
