1. (U) THE MRTA RELEASED 38 HOSTAGES AT 1930 12/20, INCLUDING THE AMBASSADORS OF BRAZIL, EGYPT, AND SOUTH KOREA. NO AMERICANS WERE FREED, BUT A RELEASED HOSTAGE SAID THE DETAINED AMERICANS WERE TOGETHER AND IN GOOD SPIRITS. ABOUT 340 HOSTAGES REMAIN. (EMBASSY LIMA, CNN)

2. (U) IN A STATEMENT RELEASED WITH THE HOSTAGES, THE TERRORISTS DESCRIBED THE RELEASE AS A GOODWILL GESTURE AND ASKED THE GOP TO NEGOTIATE. THE STATEMENT SAID THAT, IF THE TERRORISTS ARE PERMITTED TO TELEPHONE JAILED MRTA LEADERS TO DETERMINE THEIR HEALTH, THEY WILL RELEASE A LARGE NUMBER OF ADDITIONAL HOSTAGES WHO ARE "NOT CONNECTED WITH THE GOVERNMENT.", (CNN, EMBASSY LIMA)

3. (U) ONE RELEASED HOSTAGE TOLD THE PRESS A SMALL GROUP OF FREED HOSTAGES WOULD RETURN TO THE RESIDENCE AT [REDACTED]
