GENERAL

Dr. Raul Jeri, member of the GOP Sub-Committee on Drug Abuse, has provided the Embassy with copies of the preliminary findings in the UNFDAC funded epidemiology survey being conducted by his staff in Lima. He also included copies of a companion study on Treatment and Rehabilitation Centers in Peru.

The 2 week IMPACT PROJECT, renamed "The Green Sea" by the Police was completed and considered very successful, experiences gained will be useful in future operations. This Project involved the joint services of the Guardia Civil, PIP, ENACO and DEA personnel in a special coca control operation in the Tingo Maria area, the main source of illicit coca in Peru. (Lima 10522 NOTAL).

As a direct result of the IMPACT PROJECT, ENACO advises us that coca producers from Tingo Maria, Aucayacu, Monzón, Uchiza, etc., have visited the ENACO's Central Office in Lima requesting that they be registered as coca producers as required by law. These include:

- a.-Aucayacu Agrarian League which represents more than 2,500 coca producing members;
- b.-Coca Producing Committee from the Province of Leoncio Prado that represents more than 1,000 members, which includes the largest producers in the area and,
- c.-Approximately 6 additional individual coca producers in that area.
- d.-In Tingo María, an average of 100 persons per day have presented themselves at the Local ENACO Office for the same purpose.

To date, ENACO has denied all these requests on the grounds that registration of new coca producers closed in 1978, but there does exist the possibility of this being overruled by the Ministry of Agriculture.

On December 13, at the request of ENACO, Embassy representatives met with the General Manager to initiate informal discussions for possible USG assistance. It was agreed that ENACO would prepare a draft project that would be officially presented to the Embassy for consideration.

GUARDIA CIVIL' (GC)

On November 28, the GC General Director made a formal request for US assistance for its plan to establish a Mobile Rural Police Section to coordinate with the Forestry Police, with nationwide jurisdiction and utilizing personnel presently assigned to the GC Rescue Squad (50-60 men).

The GC plan is very similar to the recommendations made in the recently completed MASI Report and includes most of the objectives to be treated. Upon completion of narcotics training by the GC instructors, the team would be assigned to the specific duties of controlling coca production, transportation and commercialization in coordination with ENACO, PIP and the Ministry of Agriculture personnel.

The Director is ready to take immediate action in order to continue the momentum gained with the Coca IMPACT OPERATION and requested prompt positive replies to this request.

On December 11, the Ambassador and the Embassy Narcotics Coordinator, met with the GC Director again and it was agreed that the quickest manner to accomplish this purpose would be by adding new objectives to the existing project agreement that is designed specifically for expansion.

Through the use of amendments, vehicles and other equipment now on hand could be diverted to this priority objective. This would also be advantageous to us in maintaining proper end use of commodities.

The imbassy plans to cooperate by incorporating the required objectives into the Agreement as soon as possible to be followed by the required amendments.

Training

GC Mobile Training Teams are conducting narcotics training course in Cuzco, Huacho and Chimbote.

On November 30, the Guardia Civil personnel in Chirly o seized more than 500 kilos of coca paste in one single operation; the largest and most significant seizure made by the GC to date. (See Lima 10342). Since receiving narcotics training by the GC Mobile Teams, GC personnel from Chiclayo and other northern cities have improved significantly their interdiction capabilities.

PIP

PIP Communications Chief advises that telecommunications equipment has been installed in Lina, Iquitos, Tingo Maria, Ayacucho, Tumbes and Puno as planned in the FY/1978 Agreement.

The objective of establishing a teletype network within PIP as called for in the 1979 Agreement is progressing satisfactorily with total completion expected within 90 days. The first two locations, Tingo Maria and Tumbes are operational.

At the request of public schools, private erganizations and other interested persons, the PIP developed a booklet on drug abuse funded principally by the copies are presently being printed with distribution planned for the near

As a follow-up to the recent PIP/DEA Narcotics control efforts in the Iquitos area, DINTID investigators made the most significant drug seizures to date in that city when they discovered 130 kilos of cocaine base.

On December 1, as a result of a narcotics investigation, DINTID investigators in Callao seized 100 kilos of cocaine base, arrested 7 suspects, both Peruvian and Colombians, confiscated \$15,000, 5 million soles, 7 cars and one

ATTORNEY GENERAL

The Attorney General has requested a change in supporting the objectives within the Project Agreement. He feels that his immediate and priority objective is to reduce the more than 4,000 narcotics cases that are presently needing judicial attention, and we agree.

He proposes the contracting of 6 lawyers on a part time basis to do the specific task of presenting narcotics cases to the judiciary for a limited period of time. This on the job training would allow these young lawyers the opportunity to specialize in the handling of narcotics cases and at the serious bottleneck for the A/G Office.

It has been mutually agreed that in order to support this plan, we will amend the agreement to eliminate the U.S. Technician (\$5,000) and send only 4 participants on the pending observation training in U.S. (Amendment will be pourched when signed).



We are waiting from the Begartment (IBM) configuration dates on the US observation training for a lawyers and for evaluability dates of DEA training team to give a specialized course in Lima to lawyers and judges.

CUSTOMS

UNIVERSITY OF TINGO MARIA

During the reporting period, the first 4 Agricultural Specialists contracted last month continued with training prior to assignment in the field.

A short term secretary was contracted to assist with the increased administrative duties.

Five laborers were contracted for a period of 5 months to work the lands at the experimental farm located at Pilot Center #I in Tingo Maria.

The banana, cacao and coffee technological packages were implemented at Pilot #1.

The Rector of the University, Dr. Juan de Dios Zúniga, has been invited to participate in the Embassy's IV Program. He will travel to US in March, 1980, on an observation tour of selected Universities and Organizations involved in agricultural programs. The knowledge gained from this training will be useful to him in carrying out the objectives of the Project Agreement.
