SUMMARY: IN MEETING WITH AMBASSADOR LUIGI EINAUDI AND CATHOLIC UNIVERSITY CONFERENCE U.S. PARTICIPANTS, PRESIDENT FUJIMORI DESCRIBED HIS MISSION AS ENDING THE SCOURGE OF TERRORISM AND SETTING PERU ON COURSE ECONOMICALLY. HE BLAMED "TRADITIONAL LEADERS" FOR 500 YEARS OF EXPLOITATION IN PERU, WHICH HE IS SEEKING TO CORRECT THROUGH GOVERNMENT REFORM AND SOCIAL ACTION PROJECTS. HE JUSTIFIED HIS STRONG

5. FUJIMORI DESCRIBED HIS GOVERNMENT'S NUMBER ONE GOAL AS FIGHTING THE TERRORISM OF SENDERO LUMINOSO AND MRTA IN ORDER TO PACIFY SOCIETY. THIS, HE SAID, HAS BEEN THE ONLY WAY IN WHICH THE COUNTRY COULD END THE SCOURGE OF VIOLENCE AND LAY THE BASIS FOR NATIONAL RECOVERY. HE BLAMED THE PAST POLITICAL SYSTEM FOR HAVING CREATED THE CONDITIONS THAT LED TO TERRORISM GRIPPING THE COUNTRY -- GENERAL VELASCO FOR HAVING CREATED A POLITICAL VACUUM IN HIS "REVOLUTION" AND "TRADITIONAL POLITICIANS" FOR HAVING DONE NOTHING BUT GIVE PERU BAD GOVERNMENT AND CORRUPTION. HE SAID THESE TRADITIONAL LEADERSHIP GROUPS -- IN THE MILITARY, THE POLITICAL POWERS, AND THE CHURCH -- HAD BEEN RESPONSIBLE FOR 500 YEARS OF EXPLOITATION OF THE MASS OF PERUVIANS. 8. FUJIMORI ACKNOWLEDGED PAST RESORT TO ABUSES BY THE SECURITY FORCES, NOTING THAT IN PAST YEARS THE MILITARY WOULD CARRY OUT SAVAGE MASSACRES, IN MANY CASES BECAUSE OF RACIAL HATRED FOR INDIAN PERUVIANS. THAT HAS ENDED. HE INSISTED THAT, DUE TO HIS DIRECTION, THE ABUSES HAVE STOPPED AND THE POLICE AND ARMY NOW HAVE LEARNED TO IDENTIFY WITH THE PEOPLE BY CARRYING OUT SMALL PROJECTS AND DELIVERING FOOD TO THE POOR. THIS HAS MADE THE AVERAGE CITIZEN IDENTIFY WITH THE GOVERNMENT AND WILLING TO COOPERATE IN FIGHTING THE TERRORISTS THROUGH "RONDAS" AND OTHER POPULAR GROUPS.

9. FUJIMORI NOTED THAT ERRORS ARE INEVITABLE IN THE PURSUIT OF TERRORISTS, BUT SAID HE PERSONALLY SEEKS TO SAFEGUARD AGAINST THAT. HE HAS CREATED A GROUP OF FIVE LAWYERS UNDER HIS AUTHORITY WHO WORK THROUGH THE NATIONAL INTELLIGENCE SERVICE TO REVIEW CASES TO PROTECT THE INNOCENT WHO ARE ARRESTED. HE IS SEEKING FROM CONGRESS A SPECIAL AUTHORITY TO AUTHORIZE HIM TO FREE THOSE IMPROPERLY ARRESTED, SIMILAR TO THE LAW OF REPENTENCE. HE CITED, HOWEVER, A NUMBER OF CASES IN WHICH PEOPLE WHO CLAIMED TO BE INNOCENT WERE TRULY LINKED TO THE TERRORISTS OR CASES IN WHICH TERRORISTS WHO "REPENTED" FALSELY ACCUSED INNOCENT PEOPLE IN ORDER TO CREATE PROBLEMS FOR THE GOVERNMENT. FUJIMORI SAID THAT HIS TEAM OF LAWYERS PAY SPECIAL ATTENTION TO MAKING SURE THAT PEOPLE ARE TREATED

BUILDING INSTITUTIONS

10. EINAUDI SAID WE RECOGNIZED THAT PERU HAS MADE GREAT STRIDES IN SOLVING ITS PROBLEMS SINCE 1990, BUT ASKED FUJIMORI IF THE COUNTRY WAS BUILDING THE KIND OF INSTITUTIONS THAT WOULD ENSURE THAT THE ACCOMPLISHMENTS LAST BEYOND THE TIME THAT FUJIMORI IS PRESIDENT. HE SAID THAT WHILE MANY PEOPLE RECOGNIZE THAT THE MOST SERIOUS OF HUMAN RIGHTS ABUSES ARE DECLINING, THERE ARE STILL MANY CRITICISMS THAT NEW LAWS ARE BEING USED TO DENY FAIR TRIALS IN SECRET, MILITARY COURTS. PROF. VALENZUELA NOTED THE CASE OF A FORMER STUDENT, JAMES GAGEL, WHO STILL SEEMED TO BE THE VICTIM OF A MISGUIDED JUDICIARY. EINAUDI ALSO SAID THAT MANY PEOPLE ASSERT THAT THE LACK OF "TRANSPARENCY" IN THE INVESTIGATION OF SOME IMPORTANT HUMAN RIGHTS CASES HAS CREATED THE IMPRESSION THAT THERE IS "IMPUNITY" FOR THOSE WHO ABUSE THE PEOPLE. LIKEWISE, EINAUDI NOTED THAT MANY VIEW THE NEW CONSTITUTION AS GIVING TOO MUCH POWER TO THE PRESIDENT AND THUS PUTS TOO MUCH EMPHASIS ON THE ROLE OF ONE MAN IN CARRYING FORWARD NATIONAL POLICY.

15. EINAUDI SAID HE WANTED TO HAVE FUJIMORI'S VIEWS ON HOW WE COULD BETTER STRUCTURE OUR BILATERAL RELATIONS. NOTING THE CHARGE HAD WORKED HARD TO BUILD A STRONG RELATIONSHIP, EINAUDI SAID WE CLEARLY NEED A PERMANENT AMBASSADOR IN LIMA. HE WENT ON THAT A KEY ELEMENT IN IMPROVING OUR RELATIONS HAD TO BE THE WAY IN WHICH PERU ADDRESSED HUMAN RIGHTS ISSUES. THIS WAS A MAJOR CONCERN OF BOTH THE U.S. ADMINISTRATION AND CONGRESS. WE NEED NOT JUST POSITIVE COOPERATION BUT CONCRETE EVIDENCE TO DISPEL STRONG FEARS THAT HUMAN RIGHTS ABUSERS HAVE "IMPUNITY." INVESTIGATION OF CASES SUCH AS LA CANTUTA AND CIENEGUILLA WILL CLARIFY PERU'S IMAGE. WITHOUT THIS, PEOPLE WILL SAY THAT THE ADVANCES IN HUMAN RIGHTS WILL NOT LAST. EINAUDI SAID WE WANT TO HELP PERU BUT WE NEED TO ADDRESS

16. FUJIMORI REPLIED THAT IT WAS AN ERROR FOR THE U.S. TO PUT RESTRICTIONS ON ITS COOPERATION WITH PERU JUST AS THE SECURITY PROBLEM IS BEING SOLVED. THE U.S. HAS NOT RECOGNIZED THE DANGER THAT SENDERO REPRESENTS IN THE REGION AND THE WORK THAT PERU HAS DONE TO STOP THIS SCOURGE FROM SPREADING TO COUNTRIES SUCH AS BOLIVIA, ECUADOR, AND BRAZIL. THE LAST COUNTRY, WITH MANY SOCIAL PROBLEMS, COULD BECOME DISASTROUS IF AFFECTED BY SENDERO, THE NUMBER ONE ENEMY. FUJIMORI SAID HE WAS CONFIDENT THAT THE U.S. WOULD RECOGNIZE WHAT HE HAS ACCOMPLISHED IN PERU AND WHAT IT MEANS FOR THE REGION.
