COLINA'S ORIGINS AND ITS CARRYING OUT OF THE NOVEMBER 1991 BARRIOS ALTOS EXECUTIONS OF SUSPECTED TERRORISTS. ARMY COL. RODRIGUEZ ZABALBEASCOA WAS THE LINK BETWEEN THE GEN. RIVERO, HEAD OF DINTE, AND MAJOR (THEN CAPTAIN) SANTIAGO MARTIN. ONE OF THE GROUP'S NAMES WAS "SPECIAL INTELLIGENCE ANNIHILATION GROUP," BUT WAS ALSO CALLED "LOS MAGNIFICOS" OR "EL EQUIPITO." THE DOCUMENT CLAIMS THAT SIN ADVISER VLADIMIRO MONTESINOS APPROVED OF THE GROUP'S OPERATIONS IN GENERAL, AND GAVE THE GO-AHEAD ON THE BARRIOS ALTOS KILLINGS. INFORMATION PROVIDED TO EMBASSY BY "SI" MAGAZINE FROM A DEBRIEF OF A COLINA SOURCE, AND MAY BE THE SAME ITEM. THE DOCUMENT PROVIDES MANY DETAILS ON THE ALLEGED PREPARATIONS FOR AND CONDUCTING OF THE BARRIOS ALTOS ATTACK. WHETHER MONTESINOS IN FACT GAVE APPROVAL FOR THE OPERATION, OR THAT HUAMAN ASSISTED IN PLANNING IT, CANNOT BE CONFIRMED. THE APPEARANCE OF THIS DOCUMENT MAY REFLECT CERTAIN INDIVIDUALS' EFFORTS TO PROTECT THEMSELVES AND TO SHIFT BLAME TO OTHERS, OR CREATE PROBLEMS FOR RIQONS. WHILE THE DOCUMENT IS NOT PUBLIC, IT COULD BECOME SO. LA CANTUTA AND RELATED EVENTS ARE FAR FROM OVER. END SUMMARY.

4. THE DOCUMENT ALLEGES THAT THE GROUP'S LEADER, MAJOR SANTIAGO MARTIN, BEGAN HIS WORK IN ARMY INTELLIGENCE IN JANUARY 1988. HE REPORTEDLY WAS PLACED IN A LIAISON POSITION WITH THE NATIONAL INTELLIGENCE SERVICE (SIN). ALLEGEDLY AFTER CONSULTATIONS BETWEEN MARTIN AND THE SIN, THE DOCUMENT CLAIMS THAT MARTIN RECOMMENDED THAT THE SIE CREATE AUTONOMOUS "WORKING GROUPS FOR SPECIAL INTELLIGENCE OPERATIONS." THIS WAS APPROVED. MARTIN FORMED A SMALL SIE GROUP THAT EXECUTED SENDERO LUMINOSO LAWYER MANUEL FEBRES IN JULY 1988. FEBRES DEFENDED OSMAN MOROTE. MARTIN ARRANGED FOR THE KILLING TO BE ATTRIBUTED TO THE "COMANDO RODRIGO FRANCO," A PARAMILITARY

7. ACCORDING TO THE DOCUMENT, AS OF NOVEMBER 1991, THERE WERE 30 AIO'S IN THE GROUP, OF WHICH SIX WERE FEMALE. THEY WERE DIVIDED INTO THREE GROUPS, HEADED BY NCO'S SUPO, SOSA, AND MIGUEL ANGEL PINO.

8. THE DOCUMENT CLAIMS THAT THE OPERATION RESPONDED TO INFORMATION DEVELOPED BY NCO AIO JUAN PAMPAQUILLA ("ABADILLA"), WHO HAD INFILTRATED SENDERO LUMINOSO'S LEGAL ASSISTANCE FRONT, "ABOGADOS DEMOCRATICOS," AND THE UMBRELLA SL SUPPORT GROUP "SOCORRO POPULAR." ABADILLA HAD BEEN TRANSFERRED TO "COLINA" IN OCTOBER 1991. ON OCTOBER 27, ABADILLA INFORMED MARTIN THAT THE CENTRAL COMMITTEE OF SOCORRO POPULAR, SOUTHERN LIMA, WAS ORGANIZING A BARBEQUE FOR NOVEMBER 3 IN THE BARRIOS ALTOS SECTION OF LIMA.

9. THE DOCUMENT ALLEGES THAT MARTIN DECIDED TO SEND COLINA TO ITS CAMP AT "LA TIZA" BEACH SOUTH OF LIMA TO TRAIN FOR A "SPECIAL OPERATION." MARTIN REPORTEDLY STAYED IN LIMA TO COORDINATE WITH THE SIN AND DINTE. ON OCTOBER 29, MARTIN REPORTEDLY TOLD MEMBERS OF THE GROUP THAT HE HAD

RECEIVED A "GREEN LIGHT" FOR THE OPERATION IN BARRIOS ALTOS. A COLINA MEMBER RECONNOITERED THE SITE ON OCTOBER 30. ON OCTOBER 30, 31 AND NOVEMBER 1, THE COLINA MEMBERS AT LA TIZA TRAINED BY USING A MOCK-UP OF THE SITE IN BARRIOS ALTOS. THE GROUP SPENT NOVEMBER 2 CLEANING WEAPONS AND RESTING, WHILE MARTIN WENT TO SIE TO CARRY OUT FINAL COORDINATION WITH SIN AND DINTE. MEMBERS FROM THE TWO VEHICLES INTO THE BARBEQUE. MARTIN WENT FIRST WITH ABADILLA, WHO CONFIRMED THAT THE PERSONS AT THE PARTY WERE SL MEMBERS. MARTIN THEN ORDERED HIS MEN TO ENTER AND TO LINE UP THE PERSONS AGAINST A WALL. THE DOCUMENT SAID THIS WAS EASILY ACCOMPLISHED SINCE THE PEOPLE WERE QUITE DRUNK AND PUT UP NO RESISTENCE, EXCEPT FOR ONE PERSON WHO "BECAME EMBOLDENED." HE WAS BEATEN "TO SHOW WHO WAS IN CHARGE." ONE AGENT TOOK A BABY FROM ONE OF THE WOMEN AND PUT IT TO ONE SIDE. A SMALL BOY WAS PLACED IN A SEPARATE ROOM. ONE PART OF THE GROUP SECURED THE SECOND FLOOR OF THE BUILDING. A FEMALE AGENT TURNED UP THE VOLUME ON THE MUSIC PLAYING AT THE PARTY. THE AUTHOR OF THE DOCUMENT DOES NOT REMEMBER WHO ORDERED THE GROUP TO OPEN FIRE; USING

SUBMACHINEGUNS WITH SILENCERS, THE SHOOTING TOOK 20 SECONDS. THE DOCUMENT SAID THE NOISE WAS BARELY HEARD AS THE SILENCERS DID THEIR WORK WELL. AFTERWARDS, THE SMALL BOY CAME OUT OF THE ROOM, SURPRISING MARTIN WHO THOUGHT SOMEONE COULD BE ATTACKING THEM. HE KILLED THE CHILD. THE GROUP EXITED. ONCE IN THE VEHICLES, THEY TURNED ON SIRENS TO APPEAR LIKE POLICE, AND DEPARTED QUICKLY. THEY DIVIDED INTO SEVERAL GROUPS, AND THEN MET AT LA TIZA BEACH. THE DOCUMENT SAYS THE COLINA MEMBERS WERE NERVOUS AND ONE OF THE TRUCKS NEARLY OVERTURNED IN CHORRILLOS. THIS VEHICLE, HOWEVER, STOPPED IN CHORRILLOS TO BUY BEER. BACK AT LA TIZA THE GROUP HELD AN ALL-NIGHT PARTY TO CELEBRATE THE OPERATION AS WELL AS MARTIN'S BIRTHDAY. THEY HAD TO SEND OUT FOR MORE BEER FROM NEARBY PUCUSANA AND DANCED AS IF GIRLS HAD BEEN PRESENT. LT. COL. RODRIGUEZ ANNOUNCED THAT COLINA WAS AN ELITE FORCE WITHIN THE ARMY TO COMBAT TERRORISM WHOSE GOAL WAS TO CAPTURE ABIMAEI GUZMAN, TERMINATE SUBVERSION, AND AVENGE ARMY CASUALTIES. THE NEXT DAY THE GROUP SLEPT FOR A FEW HOURS BUT STARTED THE PARTY AGAIN WHEN THEY AWOKE. IT WAS AT THIS STAGE THAT ONE OF THE MEMBERS SUGGESTED THEY CALL THEMSELVES THE COLINA GROUP IN HONOR OF AN ARMY OFFICER INFILTRATED INTO SENDERO WHO DIED UNDER ARMY ATTACK RATHER THAN IDENTIFY HIMSELF AND PUT OTHER INFILTRATED

14. AS IN THE CASE OF THE "SI" SOURCE, THIS SOURCE IS CONVINCING ON DETAILS OF WHICH HE PURPORTS TO HAVE FIRST-HAND KNOWLEDGE -- THE ESTABLISHMENT OF COLINA, THE LEAD-UP TO BARRIOS ALTOS, AND THE ATTACK ITSELF. IT IS NOT CLEAR,

HOWEVER, THAT HE HAS FIRST-HAND KNOWLEDGE OF MONTESINOS' AND HUAMAN'S ALLEGED ROLES. THE ALLEGATION THAT COLINA CARRIED OUT BARRIOS ALTOS IS NOT NEW, AND IT IS ALMOST CERTAINLY CORRECT. BARRIOS ALTOS WAS NEVER PORTRAYED AS AN OPERATION TO DETAIN TERRORISTS THAT SOMEHOW WENT AWRY (LA CANTUTA HAS BEEN PORTRAYED AS SUCH, BUT THE VERDICT IS STILL OUT). THE OPERATION'S RESULTS AND THE DETAILS CONTAINED IN THIS DOCUMENT AND BY THE SOURCE IN REFTEL DEMONSTRATE THE INTENT WAS TO ELIMINATE A TERRORIST CELL.

15. THE TWO MAJOR QUESTIONS ARE: WHO APPROVED, OR KNEW ABOUT, THE CREATION AND GENERAL OPERATIONS OF COLINA; AND, WHO APPROVED, OR OTHERWISE SUPPORTED, COLINA'S BARRIOS ALTOS KILLINGS. THE DOCUMENT'S SPECIFIC ALLEGATIONS AGAINST THE SIN AND VLADIMIRO MONTESINOS, WHILE NOT IMPOSSIBLE, CANNOT BE PROVEN. IT IS NOT, FOR EXAMPLE, CLEAR AT ALL WHY THE DE FACTO INTELLIGENCE CHIEF FOR PERU WOULD TAKE TIME TO APPROVE OR OVERSEE WHAT WAS A FAIRLY SMALL OPERATION. COLINA'S GENERAL SCOPE OF ACTIVITIES, HOWEVER, IS ANOTHER MATTER. WE BELIEVE IT QUITE PLAUSIBLE THAT THE SENIOR OFFICIALS IN THE SIE AND THE SIN HAD TO BE AT LEAST AWARE OF WHAT COLINA WAS UP TO, AND WHAT IT WAS TRAINED TO DO.

THE FACT THAT THE DOCUMENT HAS BEGUN TO CIRCULATE, AT LEAST ON A VERY RESTRICTED PRIVATE BASIS, MAY REFLECT AN ATTEMPT BY SOME IN COLINA, OR THE SIE, TO PLACE SOME RESPONSIBILITY FOR COLINA ON THE SIN, WHICH AVOIDED ANY LEGAL RESPONSIBILITY IN THE LA CANTUTA TRIAL. IN ADDITION, OFFICERS IN CLANDESTINE MILITARY OPPOSITION GROUPS (COMACA, LEON DORMIDO) AND THOSE ALLIED WITH JAILED COUP-LEADER GEN. SALINAS WOULD LIKE ADDITIONAL DETAILS ON COLINA TO SURFACE AND EMBARRASS THE ARMY LEADERSHIP AND THE GOP. LA CANTUTA AND RELATED CASES HAVE NOT BEEN LAID TO REST BY THE MILITARY COURT TRIAL OF SANTIAGO MARTIN AND OTHER AND WILL SURELY CONTINUE TO REVERBERATE IN POLITICAL CIRCLES. THE PRESSURES TO THIS END WILL BECOME ALL THE MORE INTENSE AS PERU ADVANCES INTO THE ELECTORAL SEASON WHEN A VARIETY OF FUJIMORI ADVERSARIES, INCLUDING GENERAL SALINAS' FRIENDS, WILL HAVE EVERY INTEREST IN HITTING ON THIS ACHILLES HEEL AND FURTHER EMBARRASSING THE PRESIDENT BEFORE THE INTERNATIONAL COMMUNITY, IF NOT HIS OWN ELECTORATE.
