



PRISON POPULATION CONTINUES TO GROW

CASTRO CASTRO WAS COMPLETELY RENOVATED IN THE LATTER HALF OF 1993, AT A COST OF 4.9 MILLION SOLES (APPROXIMATELY 2.3 MILLION USD). THIS WORK CONTINUED THE REBUILDING WHICH TOOK PLACE AFTER THE FACILITY WAS EXTENSIVELY DAMAGED IN THE MAY 1992 TAKE-DOWN THAT WRESTED CONTROL OF THE PRISON AWAY FROM SENDERO LUMINOSO AND MRTA INMATES. SECURITY IS TIGHT, WITH MINE FIELDS AROUND THE FACILITY AND A NUMBER OF CHECK POINTS ON THE ROAD (IN CONTRAST, NEARBY LURIGANCHO PRISON FOR COMMON CRIMINALS HAD ONE UNMANNED CHECK POINT THE DAY OF POLOFF'S VISIT). INSIDE, THE CELL BLOCKS ARE SURROUNDED BY LUSH FLOWER AND VEGETABLE GARDENS, TENDED BY REPENTANT AND OLDER INMATES AS A REWARD FOR GOOD BEHAVIOR. GARDENS CONTRIBUTE FRESH VEGETABLES TO THE PRISONERS' DIET. 6. THE MAIN PROBLEM FACING CASTRO CASTRO PRISON IS OVERCROWDING, A PROBLEM THAT CURRENTLY PLAGUES EVERY PRISON IN THE COUNTRY. THE CELLS (ABOUT 1.5 METERS BY 2.5 METERS), BUILT FOR TWO PEOPLE, ALL HOLD THREE INMATES; TWO HAVE CEMENT BUNK BEDS AND ONE MUST SLEEP ON THE FLOOR. PRISONERS ARE

ALLOWED THIRTY MINUTES OF EXERCISE AND FRESH AIR OUTSIDE THEIR CELLS EACH DAY. DURING THE HALF HOUR OF EXERCISE, INMATES USE A SMALL, WALLED-IN, CEMENT SOCCER COURT.

7. HEALTH PROBLEMS ARE ANOTHER MAJOR CONCERN. TUBERCULOSIS, WHILE NOT RAMPANT, HAS STRUCK A NUMBER OF INMATES (TB IS COMMON AT NEARLY ALL PERUVIAN PRISONS). OTHER BRONCHIO-PULMONARY CONDITIONS, SUCH AS ASTHMA AND BRONCHITIS, ARE COMMON. MOST OF THE PRISONERS POLOFF MET WERE BAREFOOT AND CLEARLY HAD MYCOTIC INFECTIONS ON THEIR FEET; ONE COMPLAINED THAT THE FUNGUS HAD INFECTED HIS EYE. SEVERAL PRISONERS COMPLAINED (AND PRISON OFFICIALS ADMITTED) THAT THERE WAS A SEVERE SHORTAGE OF MEDICINE. THE ONLY MEDICINE IN THE HEALTH FACILITY HAD BEEN DONATED BY ONE OF THE PRISON CHAPLAINS.

- 8. THE OVERCROWDING IS A RESULT OF THE LARGE NUMBER OF CAPTURES OF TERRORISM SUSPECTS AND THE SLOW PACE WITH WHICH THEY ARE BROUGHT TO TRIAL (IN THE CIVILIAN COURTS). ONE INMATE, WHO SAID HE WAS A REPENTANT SENDERO LUMINOSO TERRORIST, COMPLAINED THAT HE HAD BEEN AT THE PRISON FOR TWO-AND-A-HALF YEARS WITHOUT A TRIAL. HE GUESSED THAT UP TO SIXTY PERCENT OF THE TOTAL PRISON POPULATION WAS INNOCENT.
- 9. COMMENT: ONLY TWO YEARS AGO, CASTRO CASTRO WAS CONSIDERED TO BE ONE OF THE WORST PRISONS IN PERU. NOW, DESPITE ITS PROBLEMS, IT IS ONE OF THE BEST. FOR INSTANCE, IN CONTRAST TO MOST OF THE COUNTRY'S JAILS, THIS ONE HAS RUNNING WATER IN EVERY CELL. EMBASSY WILL CONTINUE TO REPORT ON PRISON CONDITIONS IN PERU AS PART OF AN ONGOING SERIES.
