POSSESS THE REQUISITE FOCUS AND ASSETS EFFECTIVELY TO DIRECT THE WORK OF DINCOTE AGAINST THE SENDERO LUMINOSO. THE CAPTURE OF GUZMAN, HOWEVER, HAS VALIDATED THE PRIMACY OF INTELLIGENCE IN COMBATTING THE SENDERO VERSUS PURSUING THE TACTICS OF MORE INDISCRIMINATE FORCE. 5. CONCERNING ABIMAEEL GUZMAN, EXPRESSED SKEPTICISM OF HIS SINCERITY IN RENOUNCING VIOLENCE AS THE ROAD TO POWER. HE BELIEVES THAT IN HIS LETTERS LAST FALL, GUZMAN DELIBERATELY CHOSE TO SACRIFICE AND DISCREDIT HIMSELF IN ORDER TO INSPIRE VIGOROUS NEW SENDERO LEADERSHIP WHICH, HE HOPED, WOULD CONTINUE THE WAR. HOWEVER, GUZMAN'S SUCCESSOR, FELICIANO, LACKS MUCH OF THE LATTER'S INTELLIGENCE AND IDEOLOGICAL STRENGTH. WHILE THE MILITARY ARMY OF THE SENDERO LUMINOSO HAS LOST MANY OF ITS EXPERIENCED CADRE, BELIEVES THAT IF THE GOP WEAKENS ITS INTELLIGENCE FOCUS, IN TIME THE YOUNGER CADRE WILL GAIN THE REQUISITE EXPERIENCE TO POSE MORE SERIOUS CHALLENGES TO THE GOP.
