BEEN DIRECTLY LINKED TO A MAY 1990 BOMBING NEAR THE HOME OF AN OPPOSITION CONGRESSMAN.

THE ALLEGATIONS OFFER ADDITIONAL INSIGHT -- POSSIBLY COLORED BY THE SOURCE'S KNOWN ANTAGONISM TOWARDS MONTESINOS -- BY SOMEONE WHO KNOWN TO HAVE BEEN CLOSE TO FUJIMORI AND MONTESINOS. WHILE IN THEORY PLAUSIBLE, WE CANNOT JUDGE THE VERACITY OF THESE ACCUSATIONS. THEY ARE BY THEIR VERY NATURE ALMOST IMPOSSIBLE

1990 BOMBING RAISES LINKS TO MONTESINOS IN 1994

3. THE EMBASSY'S ORIGINAL CABLE (REF B) ON THE MAY 30, 1990 BOMBING AGAINST OPPOSITION CONGRESSMAN FERNANDO "POPPY" OLIVERA (FIM) REPORTED THE FOLLOWING:

"UNKNOWN TERRORISTS EXPLODED A MODERATE-SIZED DYNAMITE CHARGE NEAR THE HOME OF INDEPENDENT CONGRESSMAN FERNANDO OLIVERA. THE BLAST DESTROYED TWO VEHICLES PARKED ON THE STREET IN FRONT OF OLIVERA'S HOME, BUT THERE WERE NO KNOWN INJURIES... PRESS SOURCES ARE ALTERNATELY ATTRIBUTING THE ATTACK TO SENDERO LUMINOSO AND MRTA... OLIVERA IS A CONTROVERSIAL AND POPULAR FIGURE, KNOWN FOR HIS CRUSADES AGAINST GOVERNMENT CORRUPTION AND WASTE. HIS LATEST

TARGET HAS BEEN CAMBIO 90 PRESIDENTIAL CANDIDATE ALBERTO FUJIMORI WHOM OLIVERA HAS ACCUSED OF INCOME TAX EVASION... OLIVERA WAS NOT HOME AT THE TIME OF THE ATTACK... COMMENT: WE ARE STILL AWAITING ADDITIONAL INFORMATION FROM THE ANTI-TERRORISM POLICE (DICOTE) ON THE ATTACK ON OLIVERA'S HOME. DICOTE CHIEF BLANCO TOLD US THAT MRTA WAS SUSPECTED BECAUSE OF THE UNVERIFIED BUT REPORTED USE OF ALUMINUM POWDER AS AN EXPLOSION-ENHANCER." (COMMENT: DINCOTE WAS CALLED DICOTE IN 1990. MONTESINOS FRIEND TURNED FOE MAKES A CHARGE

4. DURING THE COURSE OF A BRIEF CONVERSATION WITH POLOFF IN LATE JULY, SOURCE TURNED TO THE PERENNIAL TOPIC OF VLADIMIRO MONTESINOS AND COMMENTED THAT THE USG COULD NOT BE SO NAIVE AS TO BE UNAWARE OF MONTESINOS' ROLE IN A VARIETY OF CRIMES, ESPECIALLY HUMAN RIGHTS VIOLATIONS SUCH AS BARRIOS ALTOS AND LA CANTUTA. IT WAS POINTED OUT TO THE SOURCE THAT DESPITE NEAR-UNIVERSAL PERSISTENCE OF SUCH ALLEGATIONS

6. ACCORDING TO THE SOURCE, MONTESINOS TOLD AN ASTONISHED FUJIMORI "NOT TO WORRY," THAT HE HAD "TAKEN CARE OF" OLIVERA. "WE HAVE GIVEN HIM A LITTLE BOMB" (LE HEMOS METIDO UNA BOMBITA), MONTESINOS REPORTEDLY TOLD FUJIMORI. THE SOURCE ADDED THAT MONTESINOS ALSO MENTIONED THE BOMBING OF TWO FOOD DISTRIBUTION TRUCKS BELONGING TO THE OPPOSITION "FREDEMO" CAMPAIGN'S SOCIAL EMERGENCY PROGRAM (PES) EFFORT AS THEY HEADED OUT OF LIMA. ACCORDING TO THE SOURCE, A SOMEWHAT DISCONCERTED FUJIMORI TURNED TO MONTESINOS AND TOLD HIM THAT HE (FUJIMORI) "DID NOT WANT TO KNOW" ABOUT SUCH THINGS. SOURCE THEN REMINDED POLOFF THAT HE HAD NEVER MADE THESE ALLEGATIONS PUBLIC AND HAD NOT MENTIONED THEM TO ANYONE ELSE. HE ASKED THAT THE CONVERSATION BE KEPT IN THE STRICTEST CONFIDENCE.

7. AT ANOTHER MEETING SEVERAL DAYS LATER, SOURCE REITERATED THE ALLEGATIONS TO POLOFF. THE SOURCE AGAIN CONFIRMED THAT HIS RECOLLECTION OF THE TONE, CONTEXT AND MEANING OF MONTESINOS' COMMENTS LED HIM TO CONCLUDE THAT MONTESINOS HAD HAD A DIRECT ROLE OR KNOWLEDGE OF THE BOMBINGS. SOURCE SEES THE OLIVERA BOMBING AS A RATCHETING UP IN A "DIRTY TRICKS" CAMPAIGN AGAINST FREDEMO BY THE APRA GOVERNMENT, WHICH INCLUDED OTHER

CAMPAIGN, NOR DOES THE SOURCE CLAIM TO KNOW WHO IN FACT CARRIED OUT THE ACTIONS OR WHAT THE CHAIN OF COMMAND IN THESE ACTIONS MIGHT HAVE BEEN. THE SOURCE CAREFULLY EXPLAINED THAT GIVEN THE CONTEXT AND MANNER IN WHICH MONTESINOS MADE HIS STATEMENTS, THE LOGICAL CONCLUSION WAS THAT MONTESINOS WAS CLOSELY IMPLICATED IN THE OLIVERA BOMBING. THE SOURCE REPEATED HIS COMMENTS THAT THE ALLEGATIONS HAD NOT BEEN MADE PUBLIC AND ASKED AGAIN THAT THE INFORMATION BE KEPT STRICTLY CONFIDENTIAL. POLOFF ASSURED THE SOURCE THIS WOULD BE THE CASE.

8. COMMENT: THE SOURCE OF THESE ALLEGATIONS IS KNOWN TO HAVE HAD A DIRECT RELATIONSHIP TO BOTH PRESIDENT FUJIMORI AND MONTESINOS DURING THIS PERIOD IN 1990. THE SOURCE HAD EXTENSIVE DAILY CONTACTS WITH FUJIMORI, INCLUDING CLOSED CONVERSATIONS AT WHICH MONTESINOS MAY WELL HAVE ALSO BEEN PRESENT. THE SOURCE HAS ALSO HAD AN INTERMITTENT WORKING RELATIONSHIP WITH MONTESINOS FOR OVER 20 YEARS AND HAS, SINCE 1992, TAKEN A CONSISTENT, STRONG PUBLIC STANCE CRITICAL OF MONTESINOS AND WHAT THE SOURCE CONSIDERS IS MONTESINOS' SINISTER CORRUPTING ROLE WITHIN THE FUJIMORI ADMINISTRATION (SEPTTEL).
