

B. (U) PERUVIAN INTELLIGENCE SERVICE ACCUSED OF POLITICAL ESPIONAGE

(1) (U) IN MID-OCTOBER, A LIMA NEWSPAPER PRINTED TWO ARTICLES DESCRIBING POLITICAL ESPIONAGE ACTIVITIES CONDUCTED BY THE PERUVIAN NATIONAL INTELLIGENCE SERVICE (SIN) AGAINST PERUVIAN CITIZENS ABROAD. ACCORDING TO THE ARTICLES, A PERUVIAN CONGRESSMAN HAS ACCUSED SIN AGENTS AND SPECIALLY TRAINED PERUVIAN ATTACHE OFFICERS OF RUNNING ESPIONAGE ACTIVITIES IN THE US FROM THE INTER-AMERICAN DEFENSE BOARD (IADB) IN WASHINGTON, DC. IN ADDITION, THE CONGRESSMAN ACCUSED SIN OF SURVEILLING MEMBERS OF PRESIDENT FUJIMORI'S OPPOSITION. THE ARTICLES EDITORIALIZED THAT THE CURRENT ADMINISTRATION CONSIDERS OPPOSITION CONGRESSMEN, JOURNALISTS, AND INTELLECTUAL DISSIDENTS IN PERU AND ABROAD ENEMIES OF THE STATE, WHILE SIN SHOULD BE TARGETING FOREIGN AGGRESSORS, NARCOTRAFFICKERS, AND TERRORISTS.

(2) (U) ANALYST COMMENTS:

(A) (SZME) PREVIOUS REPORTING DESCRIBED AN OVERSEAS SIN INTELLIGENCE NETWORK MANAGED BY A CLOSE FUJIMORI ADVISOR, VLADIMIRO MONTESINOS. THE COLLECTION EFFORT IS STAFFED BY AT LEAST 17 RETIRED MILITARY OFFICERS NOW WORKING FOR SIN. THESE COLLECTORS OPERATE FROM DIPLOMATIC MISSIONS, SOME UN ER COMMERCIAL ATTACHE COVER. SIN NETWORKS ARE ACTIVE IN BOLIVIA, BRAZIL, CHILE, COLOMBIA, ECUADOR, SOUTH KOREA, AND THE US. THE CLOSE RELATIONSHIP BETWEEN FUJIMORI AND MONTESINOS SUGGESTS THAT THIS NETWORK RESPONDS DIRECTLY TO PRESIDENTIAL REQUIREMENTS. THE NETWORK COULD ALSO HAVE OTHER RESPONSIBILITIES, SUCH AS WEAPONS ACQUISITION AND DISINFORMATION. (ANALYST:







D. (U) PERU: DOES FUJIMÓRI'S UNOFFICIAL ADVISOR CONTROL THE PERUVIAN NATIONAL INTELLIGENCE COMMUNITY?

(1) (C/NF) (L) ACCORDING TO PERUVIAN PRESIDENT ALBERTO FUJIMORI, VLADIMIRO MONTESINOS TORRES, PERUVIAN EX-ARMY ARTILLERY CAPTAIN AND NOW AN ATTORNEY, ONLY ACTS AS A PERSONAL LEGAL ADVISOR TO THE PRESIDENT. YET FROM THE START OF FUJIMORI'S PRESIDENCY LAST JULY, PERU'S MILITARY LEADERS AND MEDIA HAVE SPECULATED THAT MONTESINOS IS PLAYING A MUCH MORE INFLUENTIAL ROLE IN MATTERS OF STATE THAN FUJIMORI HAS BEEN WILLING TO ADMIT.

(2) CC/NF(W) ONE HYPOTHESIS IS THAT MONTESINOS HAS INFLUENCED PRESIDENTIAL APPOINTMENTS TO HIGH POSITIONS IN BOTH THE CIVILIAN AND MILITARY SECTORS OF GOVERNMENT. AS A RESULT, HE NOW ENJOYS DIRECT AND INDIRECT CONTROL OVER MAJOR NODES OF THE PERUVIAN INTELLIGENCE AND SECURITY SERVICES. DURING FUJIMORI'S FIRST YEAR IN OFFICE, PERUVIAN ARTILLERY OFFICERS WERE APPOINTED TO FILL THE THREE TOP POSITIONS OF THE NATIONAL INTELLIGENCE SERVICE (SIN), WHICH INCLUDE THE CHIEF, DEPUTY CHIEF, AND SECRETARY-GENERAL. A FOURTH ARTILLERY OFFICER WAS APPOINTED TO HEAD THE PERUVIAN ARMY INTELLIGENCE DIRECTORATE. OTHER ARTILLERY OFFICERS WERE NAMED TO HEAD VARIOUS ARMY POSTS. IN ADDITION, THE MINISTRIES OF DEFENSE AND INTERIOR ARE

HEADED RESPECTIVELY BY RETIRED AND ACTIVE DUTY ARTILLERY OFFICERS.

(3) (C) REL UK/CA) (MONTEIINOS HAS NOT LIMITED HIMSELF TO PROMOTING ARTILLERY OFFICERS. ALTHOUGH NOT AN OFFICIAL PRESIDENTIAL APPOINTEE, HE MAINTAINS AN OFFICE AT SIN HEADQUARTERS AND HAS USE OF A GOVERNMENT CAR WITH PROTECTIVE ESCORTS.

(4) (C/NF) (L) MONTESINOS GRADUATED FROM THE PERUVIAN MILITARY ACADEMY (ESCUELA MILITAR DE CHORRILLOS) AND WAS COMMISSIONED AS AN ARTILLERY OFFICER ON 1 JANUARY 1966. HOWEVER, HIS MILITARY CAREER WAS DERAILED IN THE 1970'S WHEN HE SERVED TIME IN PRISON IN CONNECTION WITH CHARGES OF ESPIONAGE. HIS LINKS TO THE FUJIMORI FAMILY ARE SAIDED PRECEDE THE ELEVATION OF ALBERTO FUJIMORI TO THE PRESIDENCY.

RODRIGUEZ, FORMER ARMY INSPECTOR GENERAL, EMERGED AS A SOMEWHAT IMPROBABLE LEADER OF AN EVENTUAL ANTI-MONTESINOS MOVEMENT. WEARING BULLETPROOF VEST AND CARRYING A SIDE ARM, HE PAID A VISIT TO THE RESIDENCE OF A MEMBER OF THE USDAO, LIMA, TO WARN AGAINST MONTESINOS' INTENTIONS TO FRUSTRATE JOINT US-PERUVIAN COUNTERDRUG EFFORTS. MONTESINOS' VISIT OCCURRED ONLY ONE DAY AFTER HE HAD BEEN ORDERED BY THE PRESIDENTIAL PALACE TO LEAVE PERU AND RETURN TO HIS ASSIGNMENT IN THE MIDDLE EAST, WHICH HE IS OFFICIALLY SCHEDULED TO COMPLETE BY
