- 3. (C) SUMMARY: THE GOP ANNOUNCED IT WILL COOPERATE WITH THE SWISS IN AN INVESTIGATION OF MONEY LAUNDERING CHARGES AGAINST FUGITIVE EX-NATIONAL INTELLIGENCE CHIEF VLADIMIRO MONTESINOS. REPORTEDLY HAVING NO CONFIDENCE IN THE ATTORNEY GENERAL, PRESIDENT ALBERTO FUJIMORI HAS ASKED A WELL-RESPECTED PRIVATE ATTORNEY TO BE APPOINTED AS A SPECIAL PROSECUTOR TO HANDLE THE INVESTIGATION. ALLEGATIONS OF MONEY LAUNDERING CHARGES AGAINST MONTESINOS HAVE ALREADY TRIGGERED GOP QUERIES FOR INFORMATION

(U) LATE NOVEMBER 2 MINISTER OF JUSTICE ALBERTO BUSTAMANTE ANNOUNCED THAT THE SWISS GOVERNMENT HAD ADVISED THE GOP BY DIPLOMATIC NOTE THAT THREE BANK ACCOUNTS IN SWITZERLAND BELONGING TO EX-NATIONAL INTELLIGENCE CHIEF VLADIMIRO MONTESINOS AND TOTALING \$48 MILLION HAD BEEN FROZEN WHILE AN INVESTIGATION OF POSSIBLE MONEY LAUNDERING WAS CARRIED OUT. (C) SEPARATE FROM THE SWISS CASE, THE ANTI-NARCOTICS DIRECTORATE OF THE PERUVIAN NATIONAL POLICE (PNP) REQUESTED OCTOBER 31 PROM DEA-LIMA INFORMATION TO SUPPORT AN ONGOING INVESTIGATION INTO MONTESINO'S POSSIBLE LINKS TO MONEY LAUNDERING OR OTHER ILLEGAL ACTIVITIES. THE REQUEST CITES AN INVESTIGATION BEGUN BY A SPECIAL ANTI-NARCOTICS TRAFFICKING PROSECUTOR IN OCTOBER. WE HAVE NOT REPLIED TO THE REQUEST; SEPTEL WILL FOLLOW OUTLINING CHARGE'S CONVERSATION WITH FOREIGN MINISTER'S CHIEF OF STAFF ON THIS SUBJECT.


