- (U) JOSE UGAZ, SPECIAL PROSECUTOR INVESTIGATING VLADIMIRO MONTESINOS, REVEALED NOVEMBER 7 THAT A DETENTION ORDER HAD BEEN ISSUED NOVEMBER 6. UGAZ SAID HIS INVESTIGATION WILL COVER SEVEN CRIMES: MONEY LAUNDERING; ILLEGAL ENRICHMENT; EXTORTION; INFLUENCE PEDDLING; TAX FRAUD; TORTURE AND MURDER. UGAZ STATED THAT THE AWAITED JUDICIAL ORDER CAME FROM A TRUSTWORTHY JUDGE WITH NO KNOWN TIES TO MONTESINGS. THE JUDGE ALSO ORDERED THE FREEZING OF ALL ASSETS AND BANK ACCOUNTS BELONGING TO MONTESINGS.
