

3. (C) THE PRESIDENT SHOWED THE AMBASSADOR A CARD WITH ONLY THE FOLLOWING HANDWRITTEN INFORMATION:

"THE BANK OF NEW YORK, 51 WEST 51ST STREET, NEW YORK, NEW YORK, 10019. TELEPHONE (212) 408-4194. IN CARE OF BILL PAYING DEPARTMENT, BEVERLY JONES."

FUJIMORI HAD NO OTHER INFORMATION BUT ASKED WHETHER WE COULD INVESTIGATE AND PROVIDE ANY INFORMATION. AMBASSADOR SAID HE WOULD TRANSMIT THIS INFORMATION PROMPTLY TO WASHINGTON, WHILE NOTING THAT WE WOULD REQUIRE A FORMAL REQUEST ORIGINATING WITH JUDICIAL AUTHORITIES IN ORDER TO ACT. AMBASSADOR SUBSEQUENTLY ELABORATED WITH PRESIDENTIAL CHIEF OF STAFF KAMIYA THAT WE WOULD NEED TO ACT VIA LETTERS ROGATORY AND THAT WE WOULD PURSUE THE MATTER WITH JUSTICE

- 5. (C) IN THE PRESS CONFERENCE, FUJIMORI, SIMILARLY, MENTIONED THAT THE GOVERNMENT HAD LEARNED OF A MONTESINOS ACCOUNT IN A MONTEVIDEO BANK. HE HAD ALSO PROVIDED THE AMEASSADOR WITH THE FOLLOWING CURSORY INFORMATION ON THAT ACCOUNT:

"BANCO SUDAMERIS, MONTEVIDEO, URUGUAY, TEL 915-0095, EXT. 2230; RINCON 500"

FUJIMORI INDICATED TO US THAT ANY INFORMATION THE USG COULD OBTAIN REGARDING MONTESINOS ACTIVITY WITH THAT BANK WOULD BE APPRECIATED, BUT HIS REQUEST FOR ASSISTANCE WAS DIRECTED PRIMARILY AT THE U.S. BANK.

(C) ACTION: PER REFTEL, WE UNDERSTAND THAT PRESIDENT FUJIMORI'S QUESTION DOES NOT CONSTITUTE A "REQUEST" AND, AS WE HAVE NO MUTUAL LEGAL ASSISTANCE TREATY WITH PERU, SUCH A REQUEST WOULD LIKELY HAVE TO BE MADE VIA LETTERS ROGATORY. 7. (C) THAT SAID, THERE IS EARNEST INTEREST ON THE PART OF THE PRESIDENT IN PURSUING THIS INVESTIGATION AND POSSIBLE U.S. CONNECTION. WE WOULD LIKE TO RESPOND TO HIM WITH ANY FURTHER APPROPRIATE ADVICE, BEYOND WHAT IS CONTAINED IN THE GUIDANCE REFTEL. ADDITIONALLY, IT WILL BE IMPORTANT TO BE ABLE TO ASSIST THE PERUVIANS IN THE APPROPRIATE FORMULATION OF REQUESTS AS THEY PURSUE THE INVESTIGATION. AN INITIAL STEP WOULD BE CONSULTATIONS HERE BY LEGATT RESIDENT IN SANTIAGO. ASSISTANCE FROM DOJ/OIA MIGHT ALSO BE APPROPRIATE. PLEASE ADVISE.
