(C) SUMMARY: THE DISCOVERY IN MARCH OF THE DECAPITATED BODY OF PERUVIAN ARMY INTELLIGENCE AGENT (SIE) MARIELA BARRETO AND REPORTS ABOUT HER INVOLVEMENT WITH THE COLINA DEATH SQUAD HAVE CAUSED AN UPROAR IN PERU. THIS SHOCKING STORY CAME ON THE HEELS OF PUBLICITY SURROUNDING THE TORTURE BY SUPERIORS OF FELLOW SIE AGENT LEONOR LA ROSA. DEFENSE MINISTER CASTILLO TOLD CONGRESS APRIL 9 THAT THE ARMED FORCES WERE NOT INVOLVED IN BARRETO'S MURDER, AND THEREFORE IT WAS UP TO THE CIVILIAN COURTS TO FIND AND PUNISH THOSE RESPONSIBLE. COLINA DEATH SQUAD LEADER SANTIAGO MARTIN RIVAS, THE FATHER OF ONE OF BARRETO'S CHILDREN, HAS PUBLICLY DENIED INVOLVEMENT IN THE MURDER. EVEN SO, HE AND OTHER MEMBERS OF THE COLINA DEATH SQUAD ARE BEING INVESTIGATED BY POLICE. A FORMER SIE AGENT HAS PUBLICLY EXPRESSED THE VIEW THAT BARRETO WAS KILLED BY THE COLINA DEATH SQUAD IN RETALIATION FOR HAVING LEAKED TO THE PRESS INFORMATION REGARDING THE 1992 LA CANTUTA MASSACRE. THIS AGENT WAS DETAINED ON DISLOYALTY AND DESERTION CHARGES THE FOLLOWING DAY. END SUMMARY.

3. (U) THE MUTILATED BODY OF PERUVIAN ARMY INTELLIGENCE OFFICER MARIELA BARRETO WAS FOUND MARCH 23. BARRETO'S HEAD AND THE LOWER PARTS OF HER LEGS AND ARMS HAD BEEN CHOPPED OFF, PROBABLY IN ORDER TO PREVENT IDENTIFICATION. BARRETO WAS 28 YEARS OLD AND HAD TWO DAUGHTERS. "COLINA" DEATH SQUAD LEADER SANTIAGO MARTIN RIVAS, WHO PARTICIPATED IN THE NOTORIOUS 1992 LA CANTUTA UNIVERSITY MASSACRE, IS THE FATHER OF MARIELA'S FOUR-YEAR-OLD DAUGHTER, NATALY. BARRETO'S BODY WAS IDENTIFIED MARCH 25 AND SHE WAS BURIED IN A MILITARY CEMETERY MARCH 26. REVELATIONS REGARDING BARRETO'S MURDER COINCIDED WITH THE APRIL 6 TELEVISED INTERVIEW OF SIE AGENT LEONOR LA ROSA, WHO WAS SUFFERING FROM THE EFFECTS OF BEING TORTURED BY HER SUPERIORS, AND GENERATED PUBLIC OUTRAGE.

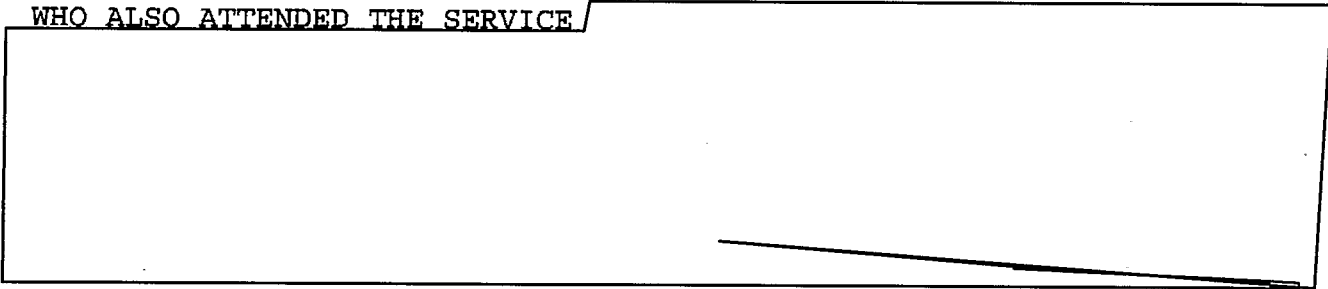

7. (C) MARIELA'S BODY WAS FOUND MARCH 23, AFTER A 14-YEAR-OLD GIRL WITNESSED TWO MEN LEAVE A BAG AT 8:30 A.M. BY A HIGHWAY NORTH OF LIMA. SHE AND HER FRIENDS LATER INVESTIGATED AND FOUND WHAT TURNED OUT TO BE MARIELA'S BODY. THE GIRL'S FATHER THEN ALERTED POLICE. WHEN THE POLICE BEGAN THEIR INVESTIGATION THEY INITIALLY SUSPECTED MARIELA'S FIANCE, ELMER VALDIVIESO, A DRIVER WITH ARMY INTELLIGENCE. HOWEVER, SHOWN A PHOTO OF VALDIVIESO, THE EYEWITNESS SAID HE WAS NOT ONE OF THE MEN WHO LEFT THE BODY. [REDACTED] BELIEVES VALDIVIESO IS INNOCENT. THERE HAVE BEEN PRESS REPORTS THAT THE 14-YEAR-OLD EYEWITNESS HAS RECEIVED DEATH THREATS. HOWEVER, THE GIRL'S FATHER, CONCERNED ABOUT HER SAFETY, HAS NOT

8. (U) RUMORS THAT MEMBERS OF ARMY INTELLIGENCE, SPECIFICALLY MEMBERS OF THE COLINA DEATH SQUAD, WERE INVOLVED IN MARIELA'S DEATH BEGAN APRIL 6 WHEN VARIOUS WEEKEND NEWS PROGRAMS RAN REPORTS ON HER MURDER. EARLY PRESS REPORTS SPECULATED THAT MARIELA HAD BEEN KILLED BY COLINA DEATH SQUAD MEMBER JUAN SOSA SAAVEDRA ON ORDERS OF MARTIN RIVAS. (SOSA DENIED THIS IN AN APRIL 17 MAGAZINE INTERVIEW.) THE EXTENSIVE PRESS COVERAGE ABOUT MARIELA'S MURDER COINCIDED WITH NEWS THAT FELLOW AGENT LEONOR LA ROSA'S HAD BEEN TORTURED. ON APRIL 9, DEFENSE MINISTER TOMAS CASTILLO, IN A PRESENTATION TO CONGRESS ON BOTH CASES, STATED THAT THE CIVILIAN COURTS HAD JURISDICTION OVER FINDING THOSE WHO MURDERED MARIELA, SINCE THE ARMED FORCES WERE NOT INVOLVED (REF B). THAT NIGHT AT 11:30, A CIVILIAN PROSECUTOR SHOWED UP AT THE BARRETO RESIDENCE FOR THE FIRST TIME AND INTERVIEWED HER FAMILY UNTIL TWO IN THE MORNING. THE BARRETOS NOTICED A STRANGE VEHICLE DRIVING AROUND THEIR HOME ON THE EVENING OF APRIL 8 AND ARE VERY CONCERNED ABOUT THEIR SAFETY. THROUGH APRODEH THEY HAVE SENT A LETTER TO THE HUMAN RIGHTS OMBUDSMAN EXPRESSING THIS CONCERN.

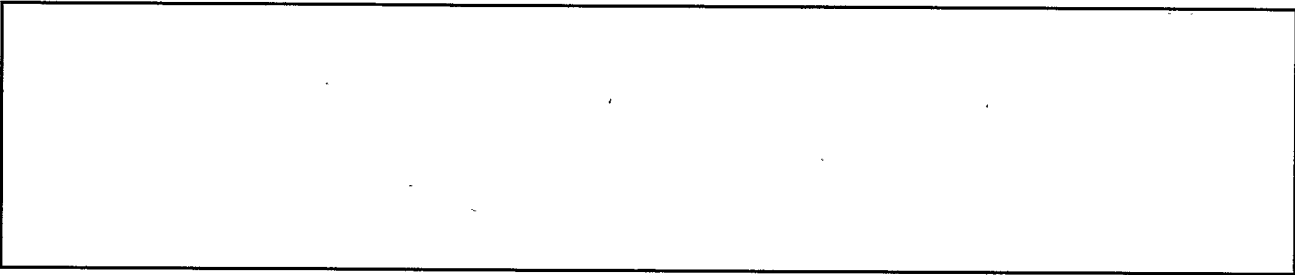

(U) AS FOR [REDACTED] RELATIONSHIP WITH MAJOR SANTIAGO MARTIN RIVAS, THE LEADER OF THE "COLINA" DEATH SQUAD, [REDACTED] SAID [REDACTED] HAD NEVER MET HIM AND DID NOT THINK HE HAD EVER SEEN HIS DAUGHTER NATALY, WHO WAS BORN IN JULY 1993. [REDACTED] DID SHOW [REDACTED] A PHOTO OF MARTIN RIVAS FROM A NEWSPAPER WHEN NEWS EMERGED OF MARTIN RIVAS'S INVOLVEMENT IN THE JULY 1992 MASSACRE OF A PROFESSOR AND NINE STUDENTS AT LA CANTUTA UNIVERSITY, FOR WHICH HE WAS SENTENCED BY A MILITARY COURT TO 20 YEARS IN PRISON. MARTIN RIVAS WAS RELEASED FROM PRISON IN JUNE 1995 AS A RESULT OF THE AMNESTY GRANTED TO MILITARY PERSONNEL WHO COMMITTED HUMAN RIGHTS ABUSES DURING THE WAR ON TERRORISM.

HIGHLY-RATED SUNDAY PROGRAM "PANORAMA." HE CATEGORICALLY DENIED ANY INVOLVEMENT IN MARIELA'S MURDER, ADDING THAT HE HAD BEEN IN TRUJILLO WHEN SHE WAS KILLED. MARTIN RIVAS SAID HE HAD NOT SEEN MARIELA IN OVER A YEAR AND A HALF. HE ADMITTED TO SPEAKING TO HER A FEW DAYS BEFORE HER DEATH REGARDING SOME FINANCIAL NEEDS OF MARIELA, AND SAID HE HAD DEPOSITED MONEY IN A BANK. MARTIN RIVAS EXPRESSED ADMIRATION FOR MARIELA, SAYING SHE DID NOT DESERVE TO DIE IN SUCH A FASHION. HE SAID HIS RELATIONSHIP WITH HER HAD BEEN "FLEETING" AND THAT HE HAD NEVER LIVED WITH HER NOR MET HER PARENTS. IN ADDITION TO DENYING INVOLVEMENT IN MARIELA'S MURDER, MARTIN RIVAS, WHO DESCRIBED HIMSELF AS AN "ANALYST," SAID HE HAD NEVER KILLED ANYONE AND WAS NOT INVOLVED IN THE 1992 LA CANTUTA UNIVERSITY MASSACRE DESPITE HAVING BEEN SENTENCED TO 20 YEARS IN PRISON FOR THAT OFFENSE BY A MILITARY COURT. HE ALSO DENIED THE EXISTENCE OF THE COLINA DEATH SQUAD. THE INTERVIEW REPORTEDLY TOOK PLACE AT THE HEADQUARTERS OF THE NATIONAL INTELLIGENCE SERVICE (SIN) AND LED TO THE RESIGNATION OF A "PANORAMA" PROGRAM EMPLOYEE FOR ETHICAL REASONS. (NOTE: THE SIN, WHOSE DE FACTO CHIEF IS VLADIMIRO MONTESINOS, COORDINATES ALL PERUVIAN INTELLIGENCE

12. (U) ON APRIL 15 AND 16, MARTIN RIVAS WAS INTERVIEWED BY CRIMINAL POLICE INVESTIGATING MARIELA'S DEATH. A FELLOW COLINA DEATH SQUAD MEMBER, MAJOR CARLOS PICHILINGUE GUEVARA, HAS ALSO BEEN QUESTIONED. POLICE PLAN TO INTERVIEW SIE AGENT IRIS CHUMPITAZ, WHO ACCORDING TO APRODEH IS "MAYRA." MARIELA'S PARENTS BELIEVE MAYRA ALSO BE THE MOTHER OF ANOTHER OF MARTIN RIVAS'S CHILDREN. POLICE ALSO PLAN TO QUESTION ARMY COMMANDER RAFAEL ALCANDRE, WHOM MARIELA'S PARENTS HAVE TOLD POLICE THEIR DAUGHTER OFTEN SPOKE ABOUT. MARIELA'S FIANCE, ELMER VALDIVIESO, IS ALSO STILL BEING QUESTIONED. ACCORDING TO APRIL 17 PRESS REPORTS, POLICE HAVE ALSO PREPARED DESCRIPTIONS OF TWO MEN, ONE WHO SAID HE WAS AN ARMY CAPTAIN, WHO ASKED ABOUT MARIELA AFTER SHE REPORTEDLY ENTERED AN AMUSEMENT PARK SEEKING A JOB AS A SECURITY GUARD MARCH 22. THE CAPTAIN REPORTEDLY ASKED WHY MARIELA HAD VISITED THE AMUSEMENT PARK. SHORTLY AFTER MARIELA'S DISAPPEARANCE, SOME SIE AGENTS TOLD VALDIVIESO THAT SHE WAS SEEN ENTERING SIE OFFICES ON MARCH 22.

(U) IN AN APRIL 10 TELEVISION INTERVIEW, JOSE BAZAN, A FORMER SIE AGENT, STATED THAT MEMBERS OF THE COLINA DEATH SQUAD, WHOM HE SAID HE HAD BEEN CLOSE TO, ALWAYS SUSPECTED THAT MARIELA HAD PASSED INFORMATION TO THE PRESS AND THEREFORE, IN HIS VIEW, THEY KILLED HER IN REVENGE. HE SAID HER KILLING WAS NOT SANCTIONED BY THE SIE. BAZAN ADDED THAT HE HAD SPOKEN TO ACTIVE DUTY SIE AGENTS WHO DEPLORED MARIELA'S MURDER. 14. (U) BAZAN SAID IT WAS NOT DIFFICULT FOR SOMEONE TO LEAVE THE SIE, BUT MANY AGENTS KNOW A LOT OF CLANDESTINE INFORMATION AND WORRY THAT THEY WILL BE WATCHED OR "DISAPPEARED" SHOULD THEY LEAVE. FOR THIS REASON THEY REMAIN WITH THE SIE DESPITE RECEIVING A LOW SALARY. BAZAN SAID MOST OF THE 1200 TO 1400 SIE EMPLOYEES ARE PAID ONLY 800 SOLES A MONTH (EQUIVALENT TO ABOUT USD 310). HE INDICATED THAT

THERE WERE MANY CASES INVOLVING SIE PERSONNEL BEING TORTURED WHEN THEY WERE SUSPECTED OF DISLOYALTY AND ASSERTED THAT ARMED FORCES CHIEF GENERAL NICOLAS HERMOZA RIOS KNEW OF THIS PRACTICE AND THAT HERMOZA ALSO KNEW THAT THE TORTURE OF CIVILIAN DETAINEES WAS COMMON ON ALL MILITARY INSTALLATIONS.

(C) BAZAN SAID THAT THERE ARE FISSURES WITHIN THE NATIONAL INTELLIGENCE SERVICE (SIN) AND THAT THOSE WHO ARE UNHAPPY WITH THE WAY THINGS ARE HAVE BEEN PASSING INFORMATION TO THE PRESS IN ORDER THAT ABUSES NOT BE REPEATED. BAZAN ALSO ADMITTED THAT, AS A SIE AGENT, HE PARTICIPATED IN THE BOMBING OF CONGRESSMAN DIEZ CANSECO'S HOME A FEW YEARS AGO. AS FOR DE FACTO SIN CHIEF MONTESINOS, BAZAN CLAIMED THAT MONTESINOS WAS A CLOSE FRIEND OF MARTIN RIVAS AND THAT IT WAS MONTESINOS WHO WAS RESPONSIBLE FOR THE CREATION OF THE COLINA DEATH SQUAD. 17. (C) HOWEVER, WE ARE NOT READY TO DECLARE THAT JUSTICE WILL TRIUMPH AND THE WRONGDOERS WILL BE PUNISHED. EVEN IF A HANDFUL OF INTELLIGENCE TYPES ARE CONVICTED OF EITHER INCIDENT, THE SYSTEM WILL HAVE SOUGHT OUT AND PUNISHED ONLY THOSE WHO COMMITTED THE CRIME, NOT THOSE GUILTY OF PERMITTING THE EVOLUTION OF A CULTURE WITHIN THE INTELLIGENCE SERVICES OR SECURITY FORCES WHICH ALLOWS HUMAN RIGHTS VIOLATIONS TO OCCUR. ON THE SURFACE, THE ANSWER IS YES. DESPITE THE MRTA RESURGENCE IN DECEMBER 1996, THE WAR AGAINST TERRORISM HAS BEEN LARGELY SUCCESSFUL AND MANY PERUVIANS ARE STILL ABLE TO RATIONALIZE HARSH MEASURES TAKEN TO DEFEAT AN EVIL WHICH THREATENED THE VERY INTEGRITY OF THE NATION-STATE. BUT WE DO NOT YET KNOW IF THE PUBLIC REVULSION AT THESE INCIDENTS IS DEEP ENOUGH TO BLOCK ANY POTENTIAL EFFORTS TO SWEEP THEM ASIDE AS ONLY THE WORK OF A FEW EMPLOYEES OF THE PERUVIAN STATE. WE HAVE SEEN, THOUGH, THAT THERE HAS BEEN SERIOUS DAMAGE TO THE IMAGE OF PRESIDENT FUJIMORI FOR THOSE PERUVIANS WHO WERE STILL WILLING TO FORGIVE HIS DEMOCRATIC SHORTCOMINGS IN EXCHANGE FOR HIS HAVING SAVED PERU FROM ITSELF.
