

THE CENTER FOR THE STUDY AND PROMOTION OF DEVELOPMENT (DESCO), PERU'S LEADING THINK TANK ON TERRORISM, COUNTED 30 CIVILIAN DEATHS RELATED TO POLITICAL VIOLENCE DURING THE FIRST EIGHT MONTHS OF 1997 COMPARED TO 88 DURING THE FIRST EIGHT MONTHS OF 1996 (OR 139 FOR ALL OF

THE DROP IS EVEN MORE SIGNIFICANT GIVEN DESCO'S FINDING THAT THE NUMBER OF TERRORIST ATTACKS IN PERU IS RUNNING ONLY SLIGHTLY BEHIND LAST YEAR'S NUMBER OF INCIDENTS. DESCO COUNTED 381 TERRORIST ATTACKS IN THE FIRST EIGHT MONTHS OF 1997 VERSUS 383 FOR THE SAME TIME FRAME IN 1996.

(U) SENDERO CONTINUES TO TARGET MEMBERS OF THE SECURITY FORCES, HOWEVER. DESCO REGISTERED 14 POLICE DEATHS RELATED TO TERRORIST ATTACKS DURING THE FIRST EIGHT MONTHS OF 1997 COMPARED TO 15 POLICE DEATHS DURING ALL OF 1996. MOST RECENTLY, SL TERRORISTS GUNNED DOWN THE UPPER HUALLAGA COUNTERNARCOTICS POLICE CHIEF AND TWO OTHER NATIONAL POLICE OFFICERS AS THEY WERE DRIVING FROM AGUAYTIA TO THEIR BASE IN TINGO MARIA ON OCTOBER 18. THE ATTACK DOES NOT APPEAR PREMEDITATED, BUT RATHER THE POLICE CAR RAN INTO AN SL ROADBLOCK AT MIDDAY. SL CADRES WERE RANDOMLY COLLECTING "WAR TAXES" FROM MOTORISTS, BUT DID NOT HARM ANY CIVILIANS.

6. (SBU) SENDERO LUMINOSO APPEARS TO BE PRIORITIZING POLITICAL REORGANIZATION OVER MILITARY ATTACKS, ACCORDING TO SL WATCHERS. WITH THE "CORRELATION OF FORCES" CLEARLY FAVORING THE GOP SINCE THE 1992 CAPTURE OF SL'S ALL-IMPORTANT FOUNDER AND NUMEROUS OTHER PARTY LEADERS, SL HAS BEEN ENDEAVORING TO RESTORE ITS BASES. 

- TRAFFICKERS, PARTICULARLY IN THE UPPER HUALLAGA VALLEY. SL CADRES PROVIDE PROTECTION IN EXCHANGE FOR CASH, WEAPONS, AND OTHER RESOURCES PROVIDED BY DRUG RINGS. EMBASSY LIMA RECEIVED A THREAT IN SEPTEMBER, FOR EXAMPLE, THAT SL CADRES PAID BY DRUG TRAFFICKERS PLANNED TO AMBUSH NAS-FUNDED CORAH ERADICATION OPERATIONS IN WESTERN UCAYALI DEPARTMENT (REF A).
- DEVELOPMENT PROJECTS. USAID FOLLOWS A RIGOROUS TRAVEL CLEARANCE PROCESS WITH THE EMBASSY AND PERUVIAN MILITARY AND POLICE DETACHMENTS IN PROGRAM AREAS. USAID ALSO CHARTERS PLANES TO REACH ITS ALTERNATIVE DEVELOPMENT PROJECTS IN THE APURIMAC VALLEY, AVOIDING THE TAMBO-SAN FRANCISCO ROAD WHERE SL MILITANTS FREQUENTLY EXTORT "WAR TAXES." IN AUGUST, SENDERISTAS STOPPED AND BURNED A FOUR-WHEEL DRIVE VEHICLE BELONGING TO A PERUVIAN GOVERNMENT AGENCY (PEAH) SUPPORTING ALTERNATIVE DEVELOPMENT PROJECTS WHILE IT WAS PLYING THE ROAD BETWEEN AGUAYTIA AND TINGO MARIA (THE DRIVER WAS NOT HARMED).




