ACCOMPANIED BY HER HUSBAND AND AMERICAN-BORN SON, ZANATTA REPORTEDLY FLED TO MIAMI ON DECEMBER 15, 1997, WHERE SHE CLAIMS TO BE SEEKING POLITICAL ASYLUM. IN INTERVIEWS

WITH A NUMBER OF PERUVIAN AND U.S. TELEVISION CHANNELS AND PRINT MEDIA, ZANATTA HAS ALLEGED THAT PERUVIAN INTELLIGENCE SERVICES HAVE, AMONG OTHER THINGS, PRACTICED TORTURE, WIRE-TAPPED A WIDE VARIETY OF OPPOSITION POLITICIANS, JOURNALISTS, AND MILITARY PERSONNEL, AND INFILTRATED THE NATIONAL VOTER REGISTRATION ORGANIZATION.

3. (U) SPECIFICALLY, ZANATTA, WHO IS 27 AND HAD WORKED FOR THE SIE FOR FIVE YEARS, CLAIMS THAT PRESIDENTIAL ADVISOR VLADIMIRO MONTESINOS HAS BEEN THE MOVING FORCE BEHIND THE SIE'S NOTORIOUS WIRE-TAPPING OPERATION, WHICH WAS ORIGINALLY BROUGHT TO LIGHT IN MAY 1997 BY THE INVESTIGATIVE REPORTAGE OF TELEVISION CHANNEL 2. AT THAT TIME, CHANNEL 2 WAS STILL COMMITTED TO BROADCASTING HEADLINE GRABBING REVELATIONS OF HUMAN RIGHTS AND OTHER ABUSES BY THE GOP AND ITS OFFICIALS. ZANATTA SAYS SHE WAS ONE OF 18 SIE AGENTS ENGAGED, ROUND-THE-CLOCK, IN TAPPING THE TELEPHONES OF OPPOSITION CONGRESSMEN, MEMBERS OF THE MILITARY SUSPECTED OF DISLOYALTY, AND

OTHER KNOWN CRITICS OF THE PERUVIAN GOVERNMENT. DAILY, ZANATTA AND
HER COLLEAGUES WOULD RECORD POTENTIALLY INCRIMINATING TELEPHONE
CONVERSATIONS AND PERSONALLY DELIVER THE TAPES TO MONTESINOS'
OFFICE. IN ADDITION, ZANATTA TOLD INTERVIEWERS OF CONVERSATIONS
SHE HAD HAD WITH SIE AGENT MARIELA BARRETO, WHOSE DECAPITATED AND
DISMEMBERED BODY WAS FOUND IN MARCH 1997, WHO CONFIRMED TO HER NOT
ONLY THE EXISTENCE OF THE COLINA DEATH SQUAD BUT ITS DIRECT
INVOLVEMENT IN VARIOUS MASSACRES, INCLUDING THE 1992 MURDER OF A LA

DEFENSE MINISTER CESAR SAUCEDO SANCHEZ IMMEDIATELY DENIED THAT
PRACTICES AND ABUSES SUCH AS THOSE ALLEGED BY ZANATTA WERE A NORMAL
PART OF PERUVIAN MILITARY AND INTELLIGENCE OPERATIONS, ALTHOUGH HE
DID SAY THAT ZANATTA'S CHARGES SHOULD BE PROPERLY INVESTIGATED.
OTHER MEMBERS OF CONGRESS, TOO, INCLUDING HUMAN RIGHTS COMMITTEE
CHAIRMAN ANSELMO REVILLA, AS WELL AS PRESIDENT FUJIMORI HIMSELF,
CALLED FOR AN INVESTIGATION OF THE ALLEGATIONS AND ASSURED THE
MEDIA THAT, SHOULD ZANATTA RETURN TO PERU FOR ANY SCHEDULED
INVESTIGATION, HER SAFETY WOULD BE GUARANTEED. HOWEVER, WHEN
FUJIMORI WAS POINTEDLY ASKED IF HE THOUGHT ZANATTA SHOULD RETURN TO
PERU FOR THIS PURPOSE, HE WAS REPORTED TO HAVE REPLIED: "IT IS UP
TO HER."
