ON MAY 11, A LIMA TELEVISION NEWS MAGAZINE BROADCAST A VIDEO OF PARTS OF A MEETING AT THE MINISTRY OF THE DRUG CONTROL POLICY DIRECTOR GENERAL BARRY M. MCCAFFREY (SEE PMNR FOR APRIL). THE VIDEO CLIP FEATURED CONTROVERSIAL PERUVIAN NATIONAL INTELLIGENCE SERVICE (SIN) ADVISOR DR. VLADIMIRO MONTESINOS'S ROLE IN THE MEETING (NOTE: THIS WAS THE FIRST TIME THAT MONTESINOS HAD SPOKEN ON TELEVISION). ON MAY 14, GENERAL MCCAFFREY HELD A TELEVISED NEWS CONFERENCE IN THE U.S. AND COMPLAINED OF MONTESINOS'S MANIPULATION OF THE MEETING TO INDICATE THAT HE HAD CHAIRED IT( IN FACT, CONTRADROGAS PRESIDENT/HEALTH MINISTER COSTA BAUER DID) AND THAT THE SIN ADVISOR AND THE U.S. DRUG CZAR SHARED AN INTIMATE WORKING RELATIONSHIP. MCCAFFREY DECLARED THAT NOT TO BE THE CASE, POINTING OUT THAT MONTESINOS HAS BEEN ACCUSED OF SANCTIONING HUMAN RIGHTS VIOLATIONS BY SIN AGENTS.
