CIENEGUILLA REMAINS MOVED TO BIRMINGHAM

1. THE PERUVIAN PROSECUTOR IN CHARGE OF INVESTIGATING THE CASE OF CHARRED HUMAN REMAINS DISCOVERED IN JULY NEAR CIENEGUILLA (JUST OUTSIDE LIMA) ANNOUNCED OCTOBER 12 THAT THE REMAINS, TAKEN TO LONDON OCTOBER 4 (REFTEL), HAD BEEN TRANSFERRED TO A NEW LABORATORY IN BIRMINGHAM.

DNA FROM THE REMAINS WILL NOW BE EXAMINED BY THE "CENTRAL RESEARCH SUPPORT ESTABLISHMENT FOR FORENSIC SCIENCE," THE SAME INSTITUTE THAT EARLIER THIS YEAR ESTABLISHED THAT BONES FOUND IN A RUSSIAN FOREST WERE THOSE OF CZAR NICHOLAS II AND HIS FAMILY. THE DNA WILL BE COMPARED TO DNA FROM BLOOD SAMPLES OF RELATIVES OF THE LA CANTUTA DISAPPEARANCES TO DETERMINE IF THE BONES BELONG TO ANY OF THE NINE STUDENTS AND ONE PROFESSOR WHO WERE ABDUCTED FROM THAT UNIVERSITY IN JULY 1992. THE REASON FOR TRANSFERRING THE SAMPLES FROM THE LONDON HOSPITAL COLLEGE TO THE BIRMINGHAM LAB WERE, ACCORDING TO PROSECUTOR VICTOR CUBAS, BECAUSE THE LONDON CLINIC DID NOT HAVE THE NECESSARY EXPERTISE.

 2. THE DENTIST OF DISAPPEARED LA CANTUTA STUDENT BERTILA LOZANO, JUAN VASQUEZ, GAVE TESTIMONY TO CUBAS ON OCTOBER 14. VASQUEZ WAS SUMMONED TO LIMA FROM LOZANO'S JUNGLE HOMETOWN TO DETERMINE WHETHER A JAWBONE DISCOVERED IN CIENEGUILLA WITH EXTENSIVE DENTAL WORK MIGHT BE LOZANO'S. ACCORDING TO CUBAS, VASQUEZ WAS NOT PERMITTED TO VIEW THE JAWBONE, ONLY TO DESCRIBE THE WORK HE HAD DONE ON LOZANO'S TEETH. CUBAS SAID THAT POLICE FORENSIC DENTISTS WOULD MAKE THE DETERMINATION IF THE JAWBONE WERE LOZANO'S. UNFORTUNATELY, VASQUEZ DID NOT HAVE X-RAYS OR OTHER PROOF, ONLY NOTES HE KEPT ON THE WORK HE PERFORMED ON THE MISSING STUDENT.

3. HUMAN RIGHTS CONTACTS INFORMED US OCTOBER 19 THAT THEY HAD REPORTS THAT SEVERAL OF THE RELATIVES OF THE LA CANTUTA VICTIMS WERE BEING HARASSED AND THREATENED BY UNKOWN INDIVIDUALS. SOME HAD RECEIVED THREATENING TELEPHONE CALLS. RAIDA CONDOR, MOTHER OF ONE OF THE STUDENTS WHOSE KEYS WERE FOUND AMONG THE CIENEGUILLA
