





THE ATTORNEY PREDICTED THAT THE MILITARY COURT WOULD NOT PROSECUTE ANYONE IN A CASE THAT "IS ALMOST CLOSED NOW." THE SAME DAY CCD HUMAN RIGHTS COMMITTEE CHAIRMAN CACERES CALLED FOR CUBAS TO INDICT BOTH THE MILITARY PERSONNEL WHO WERE GUARDING LA CANTUTA THE NIGHT OF THE ABDUCTIONS AND THOSE WHO HAVE BEEN ACCUSED OF BELONGING TO THE ALLEGED DEATH SQUAD THAT CARRIED OUT THE OPERATION.
