A: WE CONGRATULATE THE GOVERNMENT OF GUATEMALA AND THE GUATEMALAN NATIONAL REVOLUTIONARY UNITY (THE GUERILLA UMBRELLA ORGANIZATION, URNG) ON THEIR JANUARY 10 AGREEMENT TO RESUME PEACE TALKS, BROKEN OFF LAST MAY.

WE HAVE STRONGLY SUPPORTED RESUMPTION OF THE TALKS AND STAND READY WITH THE GROUP OF FRIENDS TO ASSIST THE UNITED NATIONS AS MODERATOR AND THE PARTIES THEMSELVES IN ANY WAY POSSIBLE.
