THE PERUVIAN MEMBERS OF CONGRESS WHO SIGN BELOW WISH TO REQUEST YOUR COOPERATION IN THE DEPENSE OF DEMOCRACY AND FUNDAMENTAL RIGHTS, PRINCIPLES WHICH SHOULD BE GIVEN A FIRST PRIORITY STATUS IN THE RELATIONS MAINTAINED BY NATIONS. THIS IS PARTICULARLY OUR CASE SINCE WE ARE MEMBERS OF THE SAME ORGANIZATION OF AMERICAN STATES.

FOR THAT REASON WE WISH TO REQUEST, THROUGH YOUR PERSON, THAT THE UNITED STATES OF AMERICA MAKE PUBLIC ALL DOCUMENTS, BEGINNING IN JULY 1990, WHICH ARE RELATED TO HUMAN RIGHTS VIOLATIONS OR TO THE USE OF PERUVIAN INSTITUTIONS SUCH AS THE INTELLIGENCE SERVICES OR OTHER INSTITUTIONS AGAINST MEMBERS OF THE OPPOSITION OR THE INDEPENDENT PRESS, AND WHICH MIGHT HAVE BEEN ISSUED (THE DOCUMENTS) BY THE STATE DEPARTMENT, THE CENTRAL INTELLIGENCE AGENCY, THE NATIONAL ARCHIVES, THE FEDERAL BUREAU OF INVESTIGATION, THE DEFENSE DEPARTMENT, AND OTHER AGENCIES WHICH YOU DEEM APPROPRIATE.

WE ARE AWARE THAT AMERICAN LEGISLATION PERMITS THE DISCLOSURE OF THOSE DOCUMENTS, AND WE BELIEVE THAT THEY WILL BE MOST IMPORTANT IN STRENGTHENING PERUVIAN DEMOCRACY AND AVOIDING THAT IN THE FUTURE ACTS WHICH ARE CONTRARY TO OUR CONSTITUTION AND TO INTERNATIONAL REGULATIONS WHICH PROTECT HUMAN RIGHTS WHICH OUR NATION HAS SUBSCRIBED, MAY BE PERPETRATED. WE REGRET THAT U.S. AID TO PERU HAS BEEN REDUCED OR PLACED UNDER OBSERVATION DUE TO

n/a UNCLASSIFIED THE IMPROPER CONDUCT OF CERTAIN PUBLIC OFFICERS, WHICH IN TURN WILL AFFECT THE FINANCIAL STATUS OF ALL PERUVIANS. IN ORDER TO AVOID THIS FROM OCCURRING AGAIN IN THE FUTURE, WE BELIEVE THAT IT IS ESSENTIAL FOR YOUR COUNTRY TO DISCLOSE ALL THE INFORMATION IT HAS ON THE SUBJECT, AS IT HAS ALREADY BEEN THE CASE, FOR EXAMPLE, UNCLASSIFIED
