(S) SUMMARY: MONTESINOS' RETURN AND THE RESIGNATION OF FIRST VICE PRESIDENT TUDELA HAVE TURNED A RELATIVELY PROMISING SITUATION UPSIDE DOWN--AT LEAST TEMPORARILY OBSCURING WHAT APPEARS TO US TO BE A FORWARD-LEANING COMPREHENSIVE GOVERNMENT PROPOSAL. KEY POLITICAL FIGURES, HOWEVER, SEE THE GOP PROPOSAL AS "ELACKMAIL." TUDELA SEES THE PROPOSAL (ESSENTIALLY, AMNESTY IN EXCHANGE FOR CLEAN ELECTIONS CUM TRUTH COMMISSION AND INDEMNIFICATION) AS MONTESINOS AND THE GOVERNMENT HOLDING ELECTIONS HOSTAGE TO SECRET

3. (S) MONTESINOS' RETURN

THE GOVERNMENT WAS DEEPLY CONCERNED LAST WEEK THAT MONTESINOS MIGHT DECIDE ON HIS OWN TO RETURN. THIS WAS WEIGHING ON THE PRESIDENT'S MIND WHEN AMBASSADOR AND DCM MET WITH HIM OCTOBER 16 AND, ON OCTOBER 18, FOREIGN MINISTER DE TRAZEGNIES TOLD THE AMBASSADOR OF TAKING A CALL THAT DAY FROM AN EMOTIONALLY WRUNG-OUT MONTESINOS WHO WAS THREATENING TO RETURN HOME THIS SUNDAY, OCTOBER 22, IF PANAMA DID NOT GRANT HIM ASYLUM. WHEN THE AMBASSADOR PHONED DE TRAZEGNIES CIRCA 8:00 P.M. LOCAL TIME OCTOBER 22 WITH THE NEWS THAT MONTESINOS HAD LEFT PANAMA 90 MINUTES EARLIER, HOWEVER, HE SEEMED GENUINELY SURPRISED. AS DID PALACE AIDES PHONED BY THE DCM. THE AMBASSADOR SPOKE SEVERAL TIMES WITH A HAND-WRINGING PRESIDENT PUJIMORI IN THE NEXT SEVERAL HOURS. FUJIMORI HAD APPARENTLY GOTTEN (FROM WHATEVER SOURCE IS UNCLEAR) THAT PANAMA WAS ABOUT TO

PAGE 03 LIMA 06323 01 OF 03 2319537 ACT FAVORABLY ON MONTESINOS' ASYLUM REQUEST AND SEEMED PARTICULARLY UNABLE AT FIRST TO FOCUS ON THE URGENT TASKS AT HAND. HE DID AQREE TO PHONE ECUADORIAN PRESIDENT NOBOA TO HAVE THE GOE KEEP MONTESINGS AT LEAST TEMPORARILY IN GUAYAQUIL BUT TOLD THE AMBASSADOR LATER IN THE EVENING THAT HE HAD BEEN UNABLE TO QET THROUGH. WITH OUITO'S HELP GETTING A PHONE NUMBER, HE ALSO SPOKE DIRECTLY WITH MONTESINGS IN GUAYAQUII. BUT PHONED THE AMBASSADOR BACK TO REPORT HE HAD BEEN UNABLE TO PERSUADE HIM NOT TO RETURN. AS REPORTED BY PHONE TO THE DEPARTMENT, MONTESINOS' PLANE LANDED AT AN AIR FORCE BASE AT PISCO, A HUNDRED MILES SOUTH OF LIMA AND MONTESINOS DEPARTED ALMOST IMMEDIATELY. WE DO NOT KNOW HIS EXACT WHEREABOUTS NOW BUT PUJIMORI ASSURED THE AMBASSADOR HE WOULD NOT BE PERMITTED TO RETURN TO HIS OLD OFFICES OR OTHER QOVERNMENT INSTALLATION. MONTESINOS HAS SEVERAL RESIDENCES AND COULD BE AT ANY ONE OF THEM; WE ARE ATTEMPTING TO RUN THIS TO GROUND.

4. (S) OCTOBER 23 CONVERSATION WITH FUJIMORI

AN EXHAUSTED AND DISPIRITED FUJIMORI SPOKE WITH THE AMBASSADOR BY PHONE FOR ALMOST AN HOUR THE MORNING OF OCTOBER 23. IN THIS RAMBLING CONVERSATION, HE SEEMED AT



LOOSE ENDS AS TO WHAT HE NEEDED TO DO NEXT. MIDWAY TRROUGH THE CONVERSATION, HE RECEIVED NEWS OF TUDELA'S RESIGNATION AND COMPLAINED MATTER OF FACTLY THAT HE HAD NO INKLING IT WAS COMING AND THAT IT "COMPLICATED MATTERS." FUJIMORI DID SAY HE WAS INTENDING TO SPEAK WITH OAS ENVOY EDUARDO LATORRE TO HAVE TODAY'S MEETING OF THE OAS POSTPONED, FIGURING THAT NOTHING COULD BE ACHIEVED IN THE CURRENT

THE AMBASSADOR ALSO URGED HIM TO GO BACK TO THE DRAWING BOARDS ON REMOVING MONTESINOS FROM THE SITUATION; PROGRESS IN THE CAS OR PRIVATE DIALOGUE WOULD OTHERWISE PROVE IMPOSSIBLE. PRESIDENT AGREED BUT INDICATED HE DIDN'T KNOW AT THIS POINT WHETHER MONTESINOS WOULD AGREE TO GO ANYWHERE ABROAD. WITHOUT SPECIFYING WHAT HE WANTED, HE ASKED FOR CONTINUING U.S. SUPPORT AND "INPUTS." FUJIMORI SAID HOW MUCH WASHINGTON'S SUPPORT MEANT TO HIM, SPOKE AGAIN OF HIS POSITIVE MEETINGS WITH THE SECRETARY AND NSC DIRECTOR BERGER AND WONDERED ANXIOUSLY HOW WASHINGTON WAS TAKING THESE LATEST DEVELOPMENTS. HE CONCLUDED THAT HE WANTED TO MEET WITH HIS CLOSE CABINET ADVISERS AND WOULD THEN BE BACK IN TOUCH.

5. (S) TELECON WITH VICE PRESIDENT TUDELA

WE WILL BE REPORTING SEPARATELY ON TUDELA'S RESIGNATION (ANNOUNCED 9:00 A.M., OCTOBER 23) AND HIS PUBLIC RATIONALE FOR IT, SET FORTH IN HIS LETTER TO THE PRESIDENT. TO THE AMBASSADOR, TUDELA SAID IT WAS A COMBINATION OF THREE FACTORS: MONTESINOS' RETURN; A COMMUNIQUE PUT OUT OVER THE WEEKEND BY THE MINISTERS OF DEFENSE AND INTERIOR (IN WHICH THEY CONFIRM MILITARY INTEREST IN AN AMNESTY WHILE DENYING THAT THEY ARE SEEKING IMPUNITY); AND THE GOVERNMENT'S PROPOSAL. ON THE LATTER, TUDELA BELIEVES THE GOVERNMENT IS IN ESSENCE HOLDING CLEAN ELECTIONS HOSTAGE TO AN AMNESTY

NOT ONLY FOR THE MILITARY BUT FOR MONTESINOS AS WELL AND SAID HE WANTED NO PART OF THAT. HE SAID HE ALSO WANTED TO REMOVE ANY POSSIBILITY THAT THE MILITARY MIGHT BE TEMPTED TO FORCE FUJIMORI OUT AND PUT HIM IN AND SAID HIS OWN RESIGNATION WOULD MAKE A FUJIMORI RESIGNATION EVEN LESS LIKELY. COMMENT: AS OUR PREVIOUS REPORTING HAS DOCUMENTED, TUDELA HAS BEEN UNHAPPY WITH HIS OWN POSITION ON THE MARQINS OF THE PUJIMORI GOVERNMENT FOR SEVERAL MONTHS AND HAS BEEN LOOKING FOR AN EXCUSE TO EXIT. 6. (S) VIEWS OF HUMAN RIGHTS OMBUDSMAN SANTISTEVAN

SANTISTEVAN TOLD THE AMBASSADOR HE IS ADAMANTLY OPPOSED TO ANY AMNESTY WHATSOEVER BEING ADOPTED BY THE OUTQOING, DISCREDITED GOVERNMENT. HE BELIEVES THERE IS PLENTY OF TIME TO ADOPT AN AMNESTY, IF ONE IS NEEDED, ONCE A NEW GOVERNMENT AND CONGRESS, ELECTED IN A CLEAN PROCESS, TAKES OFFICE. HE SENSES NO IMPENDING "WITCHHUNT" OF MILITARY LEADERS AND BELIEVES TALK OF ONE AS A WAY OF JUSTIFYING AMNESTY IS SIMPLY A SMOKE SCREEN FOR QETTING MONTESINGS SOME PROTECTION. 
