(S) SUMMARY: A NEWLY CONFIDENT PRESIDENT FUJIMORI TOLD AMBASSADOR OCTOBER 24 THAT HE WAS USING HIS AUTHORITY AS COMMANDER IN CHIEF OF THE ARMED PORCES PERSONALLY TO "RELOCATE" (NOT ARREST) OFFICERS CLOSE TO MONTESINOS TO TAKE CONTROL OF THE SITUATION CREATED BY MONTESINOS' UNDESIRED RETURN. FUJIMORI DOES NOT YET KNOW MONTESINOS' EXACT WHEREABOUTS BUT APPARENTLY DOES NOT/NOT



INTEND TO ARREST HIM WHEN HE FINDS HIM. FUJIMORI WAS DEEPLY OFFENDED BY OAS SECRETARY GENERAL'S OCTOBER 23 PRESS STATEMENT ON MONTESINOS' RETURN AND SAID HE WOULD NOT/NOT MAKE HIS MEETING WITH GAVIRIA OCTOBER 25 THE OCCASION FOR RECOMMITTING HIMSELF PUBLICLY TO THE OAS DIALOGUE. HE WAS CATEGORICAL, HOWEVER, IN SAYING THAT HE IS AS DETERMINED AS EVER TO HOLD CLEAN ELECTIONS AND TURN THE GOVERNMENT AND COUNTRY OVER TO HIS SUCCESSOR IN GOOD SHAPE. END SUMMARY.

5. (S) FUJIMORI WAS OTHERWISE RELATIVELY FORTHCOMING ON EVENTS CONCERNING MONTESINGS. HE SAID HE HAD PERSONALLY TAKEN CHARGE OF EFFORTS TO LIMIT MONTESINGS' CAPACITY TO INFLUENCE EVENTS BY "RELOCATING" OFFICERS LOYAL TO MONTESINGS. HE HAD FIVE OF THEM IN THE PALACE ITSELF BUT HAD ALREADY DECIDED IT WAS NECESSARY TO KEEP ONLY TWO THERE. FUJIMORI SAID HE HAD ARRESTED NO ONE BUT, RATHER, HAD USED HIS AUTHORITY AS COMMANDER IN CHIEF TO "REASSIGN OFFICERS." (COMMENT: THIS IS MAKING AN ART FORM OF EUPHEMISM. THE OFFICERS WERE LED AWAY IN HANDCUFFS. END COMMENT.) HE HAD ALSO ORDERED A NUMBER OF OTHER PERSONNEL REASSIGNMENTS, WHICH WERE BEING CARRIED OUT. ASKED BY THE AMBASSADOR ABOUT THE LOYALTY OF SECOND MILITARY REGION COMMANDER CUBAS (MONTESINOS' BROTHER-IN-LAW), A SMILING FUJIMORI SAID CUBAS IS TOTALLY LOYAL AND PROFESSIONAL, THAT THE COMMON

PERCEPTION THAT HE IS BEHOLDEN TO MONTESINOS IS DEAD WRONG. TO CLEAN OUT MONTESINOS' INFLUENCE IN THAT COMMAND, A PHONE CALL TO CUBAS HAD SUFFICED. (NOTE: THIS IS IN CONTRAST TO FUJIMORI'S COMMENT OF FOUR WEEKS AGO THAT IMPLIED HE COULD NOT COUNT ON CUBAS' LOYALTY.)

(S) THE AMBASSADOR TOLD THE PRESIDENT THAT THE USG WAS DEEPLY CONCERNED AT THE DISRUPTIVE EFFECT ON DEMOCRATIZATION THAT MONTESINOS HAD ALREADY ENGENDERED AND THAT WE WERE DELIGHTED THAT HE WAS NOW MOVING FORCEFULLY TO TAKE CHARGE. BUT COULDN'T THE PRESIDENT SPEAK TO THE ISSUE PUBLICLY OR TAKE EXECUTIVE ACTION TO MAKE HIS BREAK WITH MONTESINOS CLEARER? FOR EXAMPLE, THE PRESIDENT COULD PROHIBIT ANY CONTACT BY ARMED FORCES, INTELLIGENCE OR OTHER PUBLIC EMPLOYEE WITH MONTESINOS AND BAN MONTESINOS' ENTRY INTO ANY MILITARY OR INTELLIQENCE FACILITY. FUJIMORI SAID HE DID NOT WANT TO JEOPARDIZE THE ACTIONS UNDERWAY BY ACTING IN SUCH A PUBLIC MANNER. THE AMBASSADOR PERSISTED, NOTING THAT MONTESINOS WAS UNDOUBTEDLY WELL AWARE OF THE PRESIDENT'S ACTIONS; ONLY THE PERUVIAN PUBLIC WAS NOT. HOW WOULD PUBLIC ACTIONS PUT THE SECURITY OF THE PRESIDENT'S INTENTIONS AT RISK? FUJIMORI STILL DEMURRED, OBSERVING THAT HE DID NOT GOVERN ONE DAY AT A TIME BUT ALWAYS LOOKING AHRAD. HE HAD ENDURED 120 DAYS OF HARSH CRITICISM DURING THE JAPANESE

- 7. (S) RESPONDING WITHOUT MUCH ELABORATION TO A SERIES OF QUESTIONS, FUJIMORI SAID HE DID NOT YET KNOW MONTESINOS' EXACT WHEREABOUTS, BUT SAID "WE KNOW THE AREA (OF LIMA) HE IS IN." DETERMINING MONTESINOS' WHEREABOUTS IS CLEARLY A PRIORITY BUT HE INDICATED HE WAS NOT THINKING OF HAVING MONTESINOS ARRESTED, AS HE KNEW OF NO LEGAL BASIS TO DO SO, OR OF REASSUMING A SEARCH FOR A COUNTRY THAT WOULD TAKE HIM. THE CURRENT EMPHASIS IS ON "LIMITING HIS CAPABILITY TO INFLUENCE." FUJIMORI VOLUNTEERED THAT THERE WAS PROBABLY NOTHING TO BE DONE ABOUT THE 4-5 CONGRESSMEN LOYAL TO MONTESINOS OR THE FERSONAL TIES HE HAD TO THE WINTER BROTHERS, THE FORMER BUSINESS PARTNERS OF BARUCH IVCHER, WHO NOW CONTROL TV CHANNEL TWO. RUT HE WAS CONFIDENT THAT HE WAS WELL ON HIS WAY TO GETTING MONTESINOS' CAPABILITY FOR GREATER MISCHIEF UNDER CONTROL.
- 8. (S) THE AMBASSADOR TURNED TO THE OAS DIALOGUE. HE TOLD THE PRESIDENT FLATLY THAT U.S. SUPPORT FOR HIS GOVERNMENT IS NOT UNCONDITIONAL. RATHER, IT IS SUPPORT FOR HIS DECLARED INTENTIONS TO HOLD NEW, CLEAN ELECTIONS, STAND DOWN THE NATIONAL INTELLIGENCE SERVICE AND PROCEED AT AN ACCELERATED PACE WITH DEMOCRATIZATION. OUR WILLINGNESS TO WORK WITH HIM WOULD EVAPORATE IF WE CONCLUDED HE WAS NOT SERIOUS ABOUT FOLLOWING THROUGH TO ACHIEVE THESE GOALS. THE AMBASSADOR SAID RECENT DIFFICULTIES IN THE TALKS, COMBINED WITH MONTESINOS' RETURN, HAD CREATED DOUBTS THAT HE NEEDED TO DISPEL AND THAT THE VISIT WITH OAS SECRETARY GENERAL GAVIRIA

9. (S) THE AMBASSADOR URGED FUJIMORI TO MEET PERSONALLY WITH SOME MEMBERS OF THE OPPOSITION AS A WAY TO RE-ESTABLISH CONFIDENCE. FUJIMORI REJECTED THIS, TOO, RECALLING HOW THE BEST OF THE OPPOSITION LEADERS, RAFAEL REY, HAD COMPLETELY MISREPRESENTED A PRIVATE CONVERSATION THEY HAD TO THE PRESS. IF THAT HAPPENS WITH REY, FUJIMORU SAID, IT WILL BE WORSE WITH THE OTHERS. THE AMBASSADOR PERSISTED FOR A FEW MORE EXCHANGES ON THIS TOPIC WITHOUT GETTING ANY MOVEMENT. FUJIMORI DID POINT OUT, HOWEVER, THAT THE GOVERNMENT HAS PUT A FORWARD-LEANING ELECTIONS PROPOSAL ON THE TABLE, NOTINO THAT IT INCLUDED A TRUTH COMMISSION AND INDEMNIFICATION. THE AMBASSADOR AGREED BUT SAID THAT, IN THE ATMOSPHERE CREATED BY MONTESINOS' RETURN, THE PROPOSAL DOES NOT SPEAK ADEQUATELY FOR ITSELF. FUJIMORI ALSO STATED EMPHATICALLY (WHILE MAINTAINING THAT THE APRIL/MAY 2008 BLECTIONS HAD NOT INVOLVED "FRAUD") THAT HE WAS COMMITTED TO MAKING THE FORTHCOMING ELECTIONS IN THE CLEANEST IN PERUVIAN HISTORY. HE ALSO REPEATED WHAT HE HAS TOLD US BEFORE: THAT HIS GOAL IS TO TURN OVER THE GOVERNMENT AND COUNTRY TO HIS SUCCESSOR IN GOOD SHAPE. THIS MEANS STABILITY IN THE INTERIM, DEBT REDUCTION AND A STRONG RELATIONSHIP WITH THE MILITARY. HE DID NOT WANT HIS SUCCESSOR TO FACE A CRISIS WITH THE MILITARY HIS FIRST DAY IN OFFICE, AS HE HAD IN 1990.

HOWEVER, LIMA'S NEWSPAPER OF RECORD, EL COMERCIO, HAS AN ESSENTIALLY ACCURATE FRONT PAGE STORY OCTOBER 25 ON THE "DETENTIONS" OF KEY MONTESINGS' ASSOCIATES. THIS WILL TEMPORARILY HELP KEEP THE LID ON THE "WHO'S IN CHARGE?" FUROR UNTIL THE WHOLE MONTESINOS SITUATION BECOMES CLEARER.
