SPECIFICALLY CITING TERRORIST KILLINGS OF POLICE OFFICIALS (REFTEL), THE PERUVIAN COUNCIL OF MINISTERS VOTED SEPTEMBER 21 TO DECLARE A SIXTY-DAY STATE OF EMERGENCY IN THE AYACUCHO PROVINCE OF HUAMANGA. CONDITIONS (I. E., SPECIFIC CONSTITUTIONAL GUARANTEES SUSPENDED, PUBLIC ORDER REMAINING A POLICE FUNCTION) ARE THE SAME AS THOSE IN EFFECT IN THE OTHER THREE AYACUCHO PROVINCES WHERE STATES OF EMERGENCY ARE CURRENTLY IN EFFECT (SEE LIMA 8364).
