1. (U) ON DECEMBER 29, PRESIDENT BELAUNDE ISSUED A DECREE ESTABLISHING A NEW STATE OF EMERGENCY IN THE FOLLOWING PROVINCES; CANGALLO, HUAMANGA, HUANTA, LA MAR, VICTOR.

APURIMAC DEPARTMENT), AND ANGARAES (HUANCAVELICA DEPARTMENT).

THE SUPREME DECREE (NO. Ø68-82-IN) AUTHORIZES THE ARMED PROVINCES. THE DECREE, PUBLISHED IN THE DECEMBER 30 ISSUE OF THE OFFICIAL GAZETTE "EL PERUANO", WAS APPROVED BY THE MINISTERS OF INTERIOR, WAR, AIR FORCE, AND NAVY.

BE IN EFFECT FOR 60 DAYS BEFORE RENEWAL IS REQUIRED.

WERE PREVIOUSLY UNDER STATE OF EMERGENCY DECREE.

- 2. (U) TEXT OF THE DECREE POINTS OUT THAT THE PRESIDENT IS AUTHORIZED UNDER ARTICLE 231 (A) OF THE CONSTITUTION OF ESTABLISH A STATE OF EMERGENCY WHENEVER INTERNAL INTERIOR MINISTRY, ALSO ISSUED ON DECEMBER 29, STATES OF PUBLIC OPINION" AND THE "FAILURE OF ALL GOOD FAITH AND END THEIR CRIMINAL ACTIVITIES".
- 3. (C) COMMENT: THE TIMING OF THE ANNOUNCEMENT IS RELATED TO PRESIDENT BELAUNDE'S 72-HOUR DEADLINE. SET ON DECEMBER 26 (REF B). CALLING ON ALL TERRORISTS TO SURRENDER TO THE POLICE. THE DEADLINE EXPIRED AT NOON ON THE 29TH, NO LUMINOSO (SL) TOOK OVER THE RADIO HUAMANGA STATION IN AYACUCHO CITY AT 5:45 A. M. ON THE 29TH AND BROADCAST A ARMY LEAVE AYACUCHO WITHIN 72 HOURS. THE STATION IS TWO HEADQUARTERS BUT THE POLICE DID NOT ARRIVE UNTIL THE BLOCKS FROM THE CITY'S PERUVIAN INVESTIGATIVE POLICE (PIP) BROADCAST ENDED AND THE SL HAD GONE, LEAVING A COUPLE ORTIZ
