4. (U) DELETION OF GROUPS THAT NO LONGER MEET CRITERIA FOR PROSCRIBED ORGANIZATIONS: NONE.

5. (U) CHANGE IN ORGANIZATIONS' CLASSIFICATION: NONE.

6. (C) STATUS OF THE UNITED LEFT (IZQUIERDA UNIDA-IU): WE DELIBERATELY EXCLUDED THE IU FROM THE LIST IN PARA 2. THE IU WAS FORMED IN 1980 AS AN ELECTORAL FRONT BY A NUMBER OF MARXIST PARTIES (WHICH WE HAVE ADDED IN PARA 2) ONE NON-MARXIST PARTY, AND INDEPENDENTS. CONTROL OF IU IS DISPUTED BETWEEN THE MORE ORTHODOX AND RADICAL MEMBERS OF EXISTING MARXIST PARTIES, AND LEFTIST AND MARXIST INDEPENDENTS. AS A GUIDE TO IU MEMBERS' POTENTIAL INELIGIBILITY UNDER 212(A)(28), WE FIND IT FAR MORE USEFUL TO LOOK AT INDIVIDUAL PARTY AFFILIATIONS RATHER THAN IU MEMBERSHIP PER SE.
