



THE STRIKE BEGAN IN THE UCHIZA AREA AND DEA OF PERU: AND GUARDIA CIVIL (GC) PERSONNEL OBSERVED TREES AND VEHICLES TO BE OBSTRUCTING THE CARRETERA MARGINAL (MAIN UHV ROADWAY) BOTH NORTH AND SOUTH OF UCHIZA. NUMBERS OF PEOPLE WERE ALSO OBSERVED TO HAVE CONGREGATED. IHESE PERSONS SHOOK THEIR FISTS AND MADE OTHER DISPARACING CESTURES AT INM HELICOPTERS AS THEY FLEW OVERHEAD. THE PRO SENDERO LUMINDSO (SL) NEWSPAPER | EL DIARID " IS CLAIMING SL LEADERSHIP OF THE STRIKE AND THE MISSION IS ATTEMPTING TO CONFIRM THIS. REPORT' ANITIAL DESERVATIONS BY DEA PERSONNEL INDICATE NUMERBUS FRESHLY PAINTED COMMUNIST SLOGANS AND SYMBOLS WHICH WOULD SUPPORT SL LEADERSHIP OF THE STRIKE. 3. BY SATURDAY 20 AUGUST, THE STRIKE HAD SPREAD THROUGHOUT THE UNY. THE ROADBLUCKS WERE THEN EXTENSIVE AND EXTENDED FOR MORE THAN 140 NAUFICAL KILDMETERS .
FROM CAYUBA IN THE SOUTH TO TUCACHE IN THE NORTH. ROA
BLOCKAGES ARE ALSO KNOWN TO EXIST FROM TINGO MARIA TO RDAD AGUAYTIA ON THE EAST. THE HOADBLOCKS BEGIN ONLY FOUR KILOMETERS OUT OF TINGO MARIA TO BOTH THE NORTH AND SOUTH AND HAVE EFFECTIVELY CUT ALL RESUPPLY BY GROUND TO USG/GC PERSONNEL THERE. THE ROAD BLOCKS CONSIST DESTROYED BRIDGES, VEHICLES PARKED ACROSS THE ROADHAY, HOLES AND TRENCHES, FALLEN TREES, BURNING TIRES AND OFHER DEBR 15/ 11 : THE NIGHT OF 20 AUGUST USG PERSONNEL WERE ... REQUESTED BY THE GC TO MOVE FROM THEIR LODGINGS AT THE HOTEL TURISTA TO THE GC BASE IN TINGO MARIA BASED ON GC INTELLIGENCE THAT A GROUP OF 200 SENDERD LUMINOSO (SL) TERRORISTS WERE TO ATTACK THE HOTEL. ON 8/21 A HAMMER AND SICKLE WAS BURNED ON A HILLSIDE, CLEARLY VISIBLE FORM TINGO MARIA.



CONFIDENTIAL SUBSEQUENTLY AT APPROXIMATELY 5:30 AM ON THE MORNING OF AUGUST 22, INM HELICOPTERS WERE UTILIZED TO TRANSPORT REINFORCEMENTS TO NUEVO PROGRESO. .INSERTION OF TROOPS AT NUEVO PROGRESO WAS DONE IN AN EXTREMELY DUSTY FIELD. GREATLY REDUCING VISIBILITY: DURING INSERTION OF THE TROOPS ONE INM HELICOPTER MADE RELATIVELY HARD CONTACT WITH THE PROUND WHICH RESULTED IN DAMAGE TO BOTH SKIDS. THE HELICOPTER THEERTED TROOPS AND RETURNED TO TINGO MARIA HITHOUT INJURY TO PERSONNEL OR FURTHER INCIDENT. HOWEVER, THIS ATRICKAFT WILL BE GROUNDED UNTIL PARTS CAN BE OBTAINED AND REPAIRS MADE. A MORE DETAILED ACCOUNT OF DANGE TO THE HELICOPTER WILL BE REPORTED IN SEPTEL. SUBSEQUENTLY AT APPROX. 10:00AM ON THE SAME DATE. NO ADDITIONAL INM HELICOPTERS CONDUCTED AERIAL ECONNAISANCE ALONG THE CARRETERA MARGINAL TO DETERMINE .
HE EXTENT OF THE BLOCKAGE. JUST SOUTH OF NUEVO PROGRESO GROUP OF 3 OR 4 ARMED MEN WERE OBSERVED RUNNING ALONG HE ROADWAY: ONE OF THESE INDIVIOUALS KNELF AND FIRED THE HELICOPTERS. FIRE WAS RETURNED BY THE HELICOPTERS. NO INJURIES TO DEA/GC OR THE ATTACKERS WAS NOTED.

NO THE HELICOPTERS CONTINUED TO NUEVO PROGRESO TO PICK P'TROOPS. AFTER PICKING UP TROOPS IN NUEVO PROGRESO, HE GC COMMANDER FOR TINGO MARIA, WHO HAD JUST BOARDED THE IRCRAFT, REQUESTED TO BE SHOWN THE SPOT WHERE THE CONFIDENT ALE Confiden vige 04 02 DF 05 . 11223



-CONPIDENTIAL EVERGREEN CONTRACT FILOT RECEIVED A MINOR INJURY TO HIS LEFT ARM FROM FLYING SHRAPNEL OF THE AIRCRAFT: ONE OF THE GC TROOPS ONBOARD ALSO RECEIVED WHAT APPEARS TO BE A MINOR FLESH WOUND TO THE NECK. THE HELICOPTER TOOK ONE ROUND THROUGH THE FLOOR OF THE PILOT-IN-COMMAND (RIGHT) SIDE IN THE FRONT. THE ROUND DAMAGED PART OF THE ROTOR REDALT ANOTHER ROUND CAME THROUGH THE LEFT SIDE AND STRUCK THE FIRE EXTINGUISHER MOUNTED ON THE/SHIP THE BULKHEAD BEHIND THE CO-PILOT'S HEAD .: SHRAPNEL FROM THIS ROUND PROBABLY CAUSED THE SUPERFICIAL WOUND TO THE GC TROOP. A HOLE IN ONE OF THE MAIN ROTOR BLADES APPEARS
TO HAVE BEEN FROM A THIRD ROUND. THE HOLE IS POSITIONED
IN THE INBOARD CENTER PORTION OF THAT ROTOR BLADE: BASED ON THE DISTANCE SEPARATING THE TWO HELICOPTERS AND EVASIVE ACTION TAKEN AFTER THE LEAD SHIP CALL "TAKING FIRE,". IT IS PROBABLE THAT THE ATTACK WAS PLANNED SO THAT SEPARATE INDIVIDUALS OR TEAMS FIRED AT EACH OF THE TWO HELICOPTERS. INJURY TO THE PILOT HAS NOT DEBILITATING AND BOTH HELICOPTERS RETURNED SAFELY TO TINGO MARIA. **EMERGREEN MECHANICS HAVE MADE A CURSORY REVIEW OF DAMAGES AND STATED THAT ALL REPAIRS TO THIS AIRCRAFT CAN BE MADE IN THE FIELD AND THAT REPAIRS SHOULD TAKE LESS THAN ONE DAY TO COMPLETE. HOWEVER, IT NOW APPEARS THAT A PART REQUIRED TO COMPLETE THE REPAIRS WILL HAVE TO BE SENT FROM THE U.S. AS REGARDS THE CAUSE OF THIS GENERAL STRIKE, NUMEROUS PAMPHUETS HERE REPORTEDLY CIRCULATED TO ORGANIZE AND COURDINATE THE EFFORT.
