C' (U) PERU: A US CITIZEN REPORTER FOR THE TAMPA TRIBUNE WHOSE BODY WAS FOUND NEAR UCHIZA ON 22 NOVEMBER WAS REPORTEDLY KIDNAPPED BY MEMBERS OF THE SHINING PATH (SL) AND THEN RANSOMED TO NARCOTICS TRAFFICKERS, WHO, BELIEVING HE WAS AN AGENT FROM THE US DRUG ENFORCEMENT ADMINISTRATION (DEA), KILLED HIM. ACCORDING TO AN ARTICLE PUBLISHED IN THE LEFT-WING LA REPUBLICA, THE PERUVIAN NATIONAL POLICE INTELLIGENCE SERVICE BELIEVES THAT THE VICTIM MADE CONTACT WITH THE SL ON 16 NOVEMBER, SEEKING AN EXCLUSIVE INTERVIEW. ON 17 NOVEMBER, THE SL ABDUCTED HIM FROM THE UCHIZA AIRPORT AND ULTIMATELY DELIVERED HIM TO A COLOMBIAN NARCOTICS TRAFFICKER KNOWN AS THE MADMAN, WHO REPORTEDLY PAID THE SL \$30,000 FOR WHAT HE THOUGHT WAS A DEA AGENT. THE MADMAN REPORTEDLY TORTURED AND THEN STRANGLLED THE VICTIM. THE MEDELLIN CARTEL HAS REPORTEDLY PLACED A \$50,000 PRICE ON THE HEADS OF DEA AGENTS.
