SUMMARY: SECURITY SITUATION IN SATIPO NEAR MAZAMARI CONTINUES TO DETERTIORATE WITH SENDERO HOLDING UPPER HAND. TWO SMALL TOWNS HAVE BEEN DESTROYED ON 6 AND 12 APRIL; INHABITANTS TORTURED AND KILLED. SENDERO CAN MASS 300 EFFECTIVES IN REGION.

TEXT: 1. (U) SOURCES B AND C REPORT THAT ON 6 APR 90 THE TOWN OF ALTO PAURELI HAS ATTACKED BY SENDERO LUMINOSO (SL) BAND NUMBERING SOME 100 ARMED INDIVIDUALS. ATTACK WAS DIRECTED PRIMARILY AT THE TOWN'S RONDEROS (ARMED MILITIA) COOPERATING WITH THE NATIONAL POLICE. A TOTAL OF 26 INHABITANTS WERE KILLED BY GUNFIRE AND CLUBBING. SOME WERE BURNED ALIVE WITH GASOLINE. A FURTHER 35 INJURED HAVE BEEN TAKEN TO HOSPITALS IN SATIPO AND MAZAMARI. THE ATTACK OCCURRED AT 0500 HOURS AND APPARENTLY ACHIEVED TOTAL SURPRISE. HOMES, PUBLIC BUILDINGS, AND THE SCHOOL WERE SACKED AND THEN BURNED.

2- (U) SOURCE B REPORTS THAT AT 1900 HOURS ON 12

APRIL 90 THE TOWN OF NAYLAM DE SONOMORO

WAS ATTACKED BY 200-250 ARMED SL

TERRORISTS. ATTACK WAS ALSO AIMED AGAINST RONDERO

MILITIA- BETWEEN 35 AND 50 INHABITANTS WERE KILLED

AFTER BEING TORTURED. A TOTAL OF 27 WOUNDED HAVE BEEN

TREATED AT THE POLICE BASE IN MAZAMARI PRIOR TO BEING

TRANSFERRED BY AIR FORCE HELICOPTERS TO SATIPO AND

JAUJA HOSPITALS.

3. ACCORDING TO SOURCE C, THE POLICE COMMAND AT MAZAMARI BELIEVES THAT THE SL BAND WAS COMPOSED OF

ASSIGNED TO SL'S ENE RIVER COMMAND AND 100 LOCAL SL SURVIVORS HAVE IDENTIFIED SOME SL AS BEING FROM NEARBY TOWN OF SAN MARTIN DE PANGOA. WEAPONS INCLUDED AT LEAST ONE FN-FAL, SEVERAL AK-47'S, MGP'S, AND USUAL ASSORTMENT OF SHOTGUNS, OLD RIFLES, REVOLVERS, MACHETES, LANCES, ETC. ATTACK WAS WELL PLANNED AND ACHIEVED COMPLETE SURPRISE.

4. VICTIMS INCLUDED NUMEROUS SMALL CHILDREN, SEVERAL OF WHOM WERE BURNED ALIVE BY BEING DOUSED WITH GASOLINE AND THEN SET AFIRE-

AT LEAST NINE BUILDINGS WERE BURNED ALONG WITH SEVERAL VEHICLES- USABLE PERSONAL PROPERTY WAS LOOTED BUT LIVESTOCK AND PROVISIONS WERE NOT TOUCHED.

SL HAS BEEN ANXIOUS TO HIT NAYLAM FOR SOME
TIME. SL ATTEMPTED TO MARCH ON NAYLAM 12

MAR 90 BUT WAS DETERRED BY A POLICE PATROL

THE COLUMN INSTEAD HIT THE THREE SMALL


- REFUGEES ARE FLOODING THE MAJOR TOWNS OF SATIPO, MAZAMARI AND SAN MARTIN DE PANGOA. NAYLAM HAS BEEN VIRTUALLY ABANDONED- ON 17 APR 90 POLICE ENCOUNTERED TWO TRUCKLOADS OF REFUGEES FROM SAN ANTONIO DE SONOMORO FLEEING TO MAZAMARI-THERE ARE REFUGEES IN MAZAMARI FROM AS FAR AWAY AS ANDAMARCA-
- 7. (U) SOURCE B REPORTS THE PERUVIAN RED CROSS IS APPEALING FOR AID TO HANDLE THE NUMBERS OF CIVILIAN WOUNDED COMING OUT OF SATIPO PROVINCE- THE SATIPO DISTRICT HOSPITAL IS SWAMPED AND PATIENTS ARE BEING FURTHER EVACUATED TO JAUJA AND HUANCAYO. ACCORDING TO

THE RED CROSS, SATIPO PROVINCE IS A "WAR ZONE" WITH DAILY WOUNDED FROM THE CONSTANT TERRORIST ATTACKS. THE PROBLEM OF ORPHANS IS ALSO BECOMING ACUTE. MORE THAN 200 ARE UNDER THE CARE OF THE FRANCISCAN MISSION IN MAZAMARI, TEMPORARILY HOUSED WITH LOCAL FAMILIES. THE 12 APR 90 ATTACK ON NAYLAM YIELDED A FURTHER 50 ORPHANS AND THE 6 APR ATTACK ON ALTO PAURELI ANOTHER 30.

- 8. (U) ACCORDING SAME SOURCE, THERE ARE NOW 1,000 RONDEROS FROM THE PROVINCE IN TOWN OF SATIPO ASKING FOR ARMY ASSISTANCE. THEY CLAIM THAT SL TERRORISTS NUMBER MORE THAN 500 IN THE PROVINCE AND THAT WITHOUT ARMY AND POLICE ASSISTANCE, THEY ARE AFRAID TO RETURN TO THEIR HOMES FOR FEAR OF SL RETRIBUTIONS.
- 9. (U) SOURCE B ALSO REPORTS THAT ALL SCHOOLS IN SATIPO PROVINCE HAVE BEEN CLOSED FOR THE YEAR. OVER 900 TEACHERS HAVE REFUSED TO WORK DUE TO THE SECURITY SITUATION; 209 ARE IN HUANCAYO AND WILL NOT RETURN TO THE PROVINCE. OVER THE PAST THREE MONTHS 19 TEACHERS HAVE BEEN KILLED BY SL IN THE PROVINCE AND A FURTHER THREE ARE STILL BELIEVED TO BE HELD HOSTAGE. THE TEACHERS CLAIM THEY ARE BEING FORCED BY SL TO TEACH ONLY SUBVERSIVE PROPAGANDA, WHICH BRINGS THE RETALIATION OF LOCAL MILITIAS WHO ACCUSE THEM OF BEING TERRORISTS—

RONDEROS ARMED MILITIA WORKING WITH THE POLICE ARE POORLY ARMED VILLAGE SELF PROTECTION FORCES. THE GROUPS MAY HAVE A FEW OLD SHOTGUNS. IN THE RIO ENE AREA THE MAJORITY ARE ARMED WITH CRUDE BOWS AND ARROWS, MACHETES, AND CLUBS.
