- 1. (C) SUMMARY: FOUR INDIVIDUALS INVOLVED IN HUMAN P SHTS OR LEGAL WORK HAVE BEEN KILLED BY UNKNOWN ASSAILANTS IN THE CITY OF HUAMANGA, AYACUCHO DEPARTMENT, SINCE JULY 19. COMING FIVE MEEKS AFTER THE DETENTION/DISAPPEARANCE OF AYACUCHO HUMAN RIGHTS WORKER GUADALUPE CCALLOCCUNTO, THESE LATEST INCIDENTS HAVE LED A NUMBER OF NUMAN RIGHTS WORKERS TO FEAR THEY ARE NOW PRIME TARGETS IN THE STRUGGLE TO CONTROL THE UTOLENCE-WRACKED CITY, THE BIRTHPLAGE OF SENDERO LUMINOSO. END SUMMARY.
- 2. (C) HUMAN RIGHTS OFFICER HAS MET IN RECENT DAYS WITH A NUMBER OF LIMA-BASED NUMAN RIGHTS WORKERS AND RECENTLY-DISPLACED PERSONS FROM AYACUCHO. ALTHOUGH WE ARE UNABLE TO VERIFY DIRECTLY DETAILS OF THE STORIES CONING OUT OF AYACUCHO ISEVERAL OF WHICH HAVE APPEARED IN THE PRESS). THE PANORAMA IS CLEARLY ONE OF A CITY HOTLY CONTESTED. THE STRUGGLE IS WAGED CLANDESTINELY, IN THE SHADOWS. THERE ARE NO CLEAR BATTLE LINES. NO SANCTUARIES OR SAFEHAVENS. ONLY ONE SIDE WEARS A UNIFORM - AND EVEN INEN. NOT ALVAYS. THE WEAPON OF CHOICE IS A PISTOL, AND AT CLOSE RANGE. THE LATEST BATTLES APPEAR CENTERED AROUND THE UNIVERSITY OF SAN CRISTOBAL OF RUAMANGA BUNSCH). THE FOLLOWING RECOUNTING IS BASED ON POLOFF'S CONVERSATIONS IN LIMA, MINIMALLY SUPPLEMENTED BY PRESS ACCOUNTS.

FOUR KILLINGS

3. WE MAXIMO RICO BAZAN, A LEGAL ADVISOR WITH THE AYACUCHO DEVELOPMENT CORPORATION, WAS KILLED DURING THE EARLY HOURS (BEFORE SUNRISE) OF THURSDAY, JULY 19, WHEN MASKED GURMEN BROKE INTO HIS HOUSE. RICO, AGE 30. WAS SHOT THREE TIMES IN THE HEAD. HIS WIFE AND THREE CHILDREN, WHO WITNESSED THE KILLING, WERE NOT INJURED. FERNANDO LUIS COLONIO ARTEAGA, LANYER

SIMILARLY KILLED DURING THE FARLY HOURS OF FRIDAY,
JULY 28. A GROUP OF ARMED HEN BROKE INTO HIS HOUSE
AND SHOT BIM IN THE HEAD. COLONIO, AGE 35, ALSO
SERVED AS DIRECTOR OF PUBLICATIONS AND CONFERENCES
FOR THE AYACUCHO LAWYER'S ASSOCIATION (COLEGIO DE
ARDOGAGOS DE AVACUCHON ABOGADOS DE AYACUCHO).

- 4. (U) GABRIEL TUPIA HUAMANCUSI, A 25-YEAR-OLD MINING ENGINEERING STUDENT AT UNSCH AND THE PRESIDENT OF A PEASANT HOUSING RIGHTS GROUP, WAS KILLED EARLY SATURDAY, JULY 21. MASKED GUNNEH BROKE INTO HIS HOUSE AND SHOT HIM IN THE HEAD. EARLY TUESDAY, JULY 24, CIRO ARANBURU VILLANUEVA, UNSCH BIOLOGY PROFESSOR AND CHIEF OF THE UNIVERSITY'S SOCIAL WELFARE OFFICE, WAS MURDERED IN HIS BED. ARMED GUNNEN HAD BROKEN INTO MIS HOUSE AND SHOT HIM SEVEN TIMES. HE WAS 52 YEARS OLD. HIS DAUGHTER, ALCIRA ARAMBURU, WHO HAD BEEN SLEEPING IN THE NEXT ROOM, WAS INJURED. SHE IS NOW INTERNED IN AYACUCHO'S NOSPITAL.
- (C) HUMAN RIGHTS CONTACTS ALSO REPORT THAT, FOR THE SECOND TIME IN THREE WEEKS, ARMY TROOPS BROKE INTO THE RUAMANGA HOUSE OF MAURO VEGA, NUMAN RIGHTS WORKER WITH SERPAJ-AYACUCHO AND COLLEAGUE OF THE DISAPPEARED HUMAN RIGHTS WORKER GUADALUPE CCALLOCCUNTO. FAMILY MEMBERS ASSERT THAT ARMY PERSONNEL (WHO APPARENTLY DID NOT HIDE THEIR ARMY MEMBERSHIP) RETURNED TO THE HOUSE DURING THE EARLY HOURS OF FRIDAY, JULY 28, LOOKING FOR VEGA AND THREATENING TO KILL HIM. (AS REPORTED REFTEL, VEGA

SLIPPED OUT OF AVACUCHO FOR LIMA SEVERAL WEEKS AGO. AFTER ARMY TROOPS ENTERED HIS NOUSE ON JULY 6. HE HAS NO CURRENT PLANS TO RETURN TO AYACUCHO.) ALL OF THE ACTIONS DETAILED ABOVE OCCURRED BETWEEN THE HOURS OF MIDNIGHT AND FOUR A.M. ON THE DAYS IN QUESTION, DURING HOURS OF MILITARY-ENFORCED CURFEY.

IN A WAR ZONE

6. (U) AYACUCHO, AN EMERGENCY ZONE CONTINUALLY SINCE 1983. IS THE SINGLE MOST CONFLICTIVE DEPARTMENT IN ALL OF PERU. EIGHT YEARS OF MILITARY "CONTROL" HAVE FAILED TO PACIFY THE CITY OR DEPARTMENT. ALTHOUGH AYACUCHO HAS JUST 2.8 PERCENT OF PERU'S TOTAL POPULATION, THE HUMAN RIGHTS GROUP "APRODEH" REPORTS THAT AYACUCHO SUFFERED 12 PERCENT OF ALL TERRORIST ATTACKS IN 1989. ACCORDING TO FIGURES OF THE SENATE COMMISSION ON VIOLENCE, THESE ACTIONS (AND THE MILITARY RESPONSE) WERE PARTICULARLY FATAL: AYACUCHO PRODUCED 28 PERCENT OF ALL TERRORISM-RELATED DEATHS IN 1989. HEARLY ONE IN EVERY SOB "AYACUCHANOS" DIED IN 1989 ALONE. PARANGIA, SUSPICION AND DISTRUST ARE RUNNING AT ALL TIME HIGHS. A NEIGHBOR OF FRIEND BY DAY MAY BE A HILLTARY OR GUERRILLA INFORMANT TOR WORSE) BY NIGHT.

7. (CI THE LATEST ROUND OF VIOLENCE BECAN WITH SENDERO LUMINOSO'S CALL FOR THREE DAYS OF "ARMED STRIKE" JUST PRIOR TO THE JUNE 18 PRESIDENTIAL RUNOFF ELECTION. SENDERO IS ALSO SAID TO BE IN THE MIDDLE OF A BASE-BUILDING CAMPAIGN AT THE UNSCH. THE UNIVERSITY WHERE THE MOVEMENT WAS FIRST FOUNDED AND TOOK ROOT IN THE 1968S. SENDERO MONETHELESS MUST COMPETE TODAY WITH OTHER LEFTIST GROUPS FOR STUDENT SUPPORT - AND SENDERO CLEARLY SEES MURDER AND

8. (C) BOTH PRESS AND DISPLACED PERSONS REPORTS MAKE CLEAR THAT LAL SECURITY FORCES HAVE ALSO STEPPED UP THEIR OWN ACTIVITIES IN HUMMANGA, ESPECIALLY AROUND THE UNIVERSITY. ACCORDING TO THE MATIONAL COORDINATED FOR HUMAN RIGHTS, THERE ARE 111 UNRESO THE CASES OF "DISAPPEARANCES" MATIONNIDE DATING FROM THE MONTHS JANUARY-JULY, 1996 - A TOTAL WELL SELOM THE 1989 RATE. MORE THAN HALF OF THE CURRENT CASES (58 OF 1111), HOWEVER, ARE FROM AYACUCHO. BY COMPARISON, JUNIN AND APURINAC ARE THE ONLY TWO OTHER DEPARTMENTS TO REGISTER EVEN AS MANY AS TEN DISAPPEARANCES).

COMMENT:

18. C) BOTH COLONIO AND ARAMBURU WERE APPARENTLY WELL-KHOWN IN AYACUCHO AND TO SOME IN LIMA'S HUMAN RIGHTS COMMUNITY FOR THEIR WORK AT THE UNIVERSITY. WE, HOWEVER, HAVE NO BASIS FOR COMMUNITING ON THE POLITICAL ACTIVITIES OR BELIEFS GWASTEVER THEY MIGHT HAVE BEEND OF ANY OF THE FOUR KILLED. INITIAL PRESS REPORTS OUT OF AYACUCHO SAID, WITHOUT EXPLANATION, THAT MUNICIPAL LAWYER RICO BAZAN WAS KILLED BY SENDERO. LIMA-BASED NUMAN RIGHTS GROUPS CONCEDE THAT IS POSSIBLE (ESPECIALLY GIVEN SENDERO'S ATTACKS CHALL FACETS OF GOVERNMENT), BUT THEY BOURT IT. THE ACTIVISTS PRIVATELY BLAME THE MILITARY FOR THE CURRENT SPATE OF "BEDDROCH ASSASSINATIONS". IN OHE SENSE THEY DON'T CARE WHO IS CUILTY OF THE KILLINGS THEY JUST WANT THEM STOPPED.

11. (C) PRESIDENT FUJINOR1 ISSUED A RINGING ENDORSEMENT FOR HUMAN RIGHTS AS A TOP GOVERNMENTAL PRIORITY IN HIS JULY 28 INAUGURAL ADDRESS (REF B). EMBOFFS, ARMA AND MAAG PERSONNEL WILL BE STRESSING TO OUR NEW POLICE AND DEFENSE MINISTRY CONTACTS THE ABSOLUTE NECESSITY OF CONDUCTING MILITARY OPERATIONS, INCLUDING IN THE AYACUCKO REGION, IN A MANNER CONSISTENT WITH PERUVIAN AND INTERNATIONAL LAW.
