- 2. (U) PERU'S MUCKRAKING DEPUTY, FERNANDO "POPPY" OLIVERA, HAS DONE IT AGAIN. PERUVIAN POLITICAL CIRCLES HAVE BEEN ABUZZ IN RECENT WEEKS OVER AN EVER-GROWING SCANDAL CONCERNING ILLEGAL WIRETAPS. THIS TIME DEPUTY OLIVERA, PERU'S ANSWER TO JACK ANDERSON, HAS REVEALED THAT THE GOVERNMENTS OF BOTH ALAN GARCIA AND ALBERTO FUJIMORI HAVE TAPPED THE TELEPHONES OF THEIR POLITICAL OPPONENTS - AND FRIENDS.
- OLIVERA OPENED THIS VERY LARGE CAN OF WORMS 3. (U) BY STATING ON CESAR HILDEBRANDT'S "EN PERSONA" TELEVISION SHOW THAT THE GOVERNMENT OF PRESIDENT ALAN GARCIA (1985-JULY 1990) HAD TAPPED THE PHONES OF OPPOSITION MEMBERS OF CONGRESS. AS "PROOF" HE PRESENTED COPIES OF DOCUMENTS HE SAID WERE LEAKED TO HIM BY MEMBERS OF THE NATIONAL INTELLIGENCE SERVICE (SIN). HIS SOURCES, HE SAID, WERE MILITARY PERSONNEL, "BUT MILITARY WHO BELIEVE IN DEMOCRACY." THE DOCUMENTS PURPORTED TO SHOW LISTS OF POLITICAL AND MEDIA LEADERS WHO HAD BEEN THE TARGET OF WIRETAPS.
- OLIVERA RAISED THE HEAT FURTHER BY IMPLICATING THE BRAND-NEW "MORALIZING" GOVERNMENT OF ALBERTO FUJIMORI. OLIVERA PRESENTED A LIST OF SIN'S "TOP TEN TARGETS," DATED AUGUST 1990. BOTH OLIVERA AND HILDEBRANDT WERE AMONG THOSE TO BE TAPPED. TARGETS CAME FROM ACROSS THE POLITICAL SPECTRUM. PERHAPS MOST DAMAGING TO PRESIDENT FUJIMORI, HOWEVER, WAS TARGET NUMBER TEN: THE PRESIDENT'S OWN CAMBIO 90

PARTY. AMONG THOSE LISTED FOR TAPPING WERE CONSTITUTIONAL VICE PRESIDENTS MAXIMO SAN ROMAN AND CARLOS GARCIA GARCIA.

- IN HIS APPEARANCES BEFORE CONGRESS TO DEFEND THE NEW ECONOMIC REFORMS, PRIME MINISTER HURTADO MILLER DENIED THAT THE FUJIMORI GOVERNMENT WAS ENGAGED IN WIRETAPPINGS, ILLEGAL OR OTHERWISE. H POINTED OUT A NUMBER OF DISCREPANCIES, SOME QUITE OBVIOUS, IN OLIVERA'S DOCUMENTS; THIS LED SOME OBSERVERS TO CONCLUDE THAT OLIVERA HAD BEEN SET UP, "BAMBOOZLED" BY THE PEDDLERS OF FALSE DOCUMENTS.

READ ALOUD ON TELEVISION A SERIES OF TRANSCRIPTS OF TELEPHONE INTERCEPTS. AMONG THE TARGETS: LEFT-WING SENATOR JAVIER DIEZ CANSECO, LIBERTAD'S MIGUEL CRUCHAGA, PRESIDENTIAL CANDIDATE MARIO VARGAS LLOSA, AND TWICE-PRESIDENT FERNANDO BELAUNDE TERRY. MANY OF THE OUTRAGED TARGETS PUBLICLY CONFIRMED THAT THESE PRIVATE CALLS HAD INDEED BEEN MADE, JUST AS THE LEAKED TRANSCRIPTS INDICATED. 
