AND POLITICAL VIOLENCE WITH AYACUCHO EMERGENCY ZONE COMMANDER, GENERAL FERNANDEZ-DAVILA, AND WITH PUBLIC MINISTRY PROSECUTORS DURING HIS ONE-DAY TRIP TO THE CITY OF AYACUCHO, DECEMBER 5. FERNANDEZ-DAVILA CLAIMED THAT MOST CHARGES OF HUMAN RIGHTS ABUSES BY THE MILITARY WERE EITHER EXAGGERATIONS OR PURE FICTIONS INVENTED BY SENDERO LUMINOSO TERRORISTS. THE GENERAL ALSO CLAIMED THAT SENDERO WAS ON THE RUN IN AYACUCHO, HAVING BEEN BEATEN BY THE MILITARY AND LOCAL CIVIL DEFENSE PATROLS ("RONDAS CAMPESINAS"). PUBLIC MINISTRY FISCALES SPOKE OF RECENTLY IMPROVED RELATIONS WITH THE MILITARY, IN GENERAL, AND SUBSTANTIAL PROGRESS IN THE INVESTIGATION OF MILITARY RESPONSIBILITY FOR THE CHILCAHUAYCCO MASSACRE, IN PARTICULAR. END SUMMARY.

3. DURING A ONE-DAY VISIT TO THE CITY OF AYACUCHO ON DECEMBER 5, THE AMBASSADOR DISCUSSED HUMAN RIGHTS AND PACIFICATION ISSUES IN SEPARATE MEETINGS WITH THE MILITARY'S POLITICAL-MILITARY COMMANDER FOR THE AYACUCHO EMERGENCY ZONE, AND WITH THE PUBLIC

AFTER FIRST CALLING ON AYACUCHO'S CIVILIAN MAYOR AND CITY COUNCIL, THE AMBASSADOR (ACCOMPANIED BY SPOUSE AND POLOFF) MET FOR OVER AN HOUR WITH ARMY GENERAL PETRONIO FERNANDEZ-DAVILA CARNERO IN HIS OFFICE AT "LOS CABITOS" BARRACKS ON THE OUTSKIRTS OF THE CITY. (FERNANDEZ-DAVILA WILL FINISH HIS ONE-YEAR TOUR AS POLITICAL MILITARY COMMANDER FOR THE "AYACUCHO" EMERGENCY ZONE - ENCOMPASSING THE DEPARTMENTS OF AYACUCHO, APURIMAC AND HUANCAMELICA - AT THE END OF THE MONTH.) THE ANIMATED FERNANDEZ-DAVILA BEAMED WITH SELF-CONFIDENCE AND CHARM THROUGHOUT THE MEETING, CLEARLY ENJOYING HIMSELF. UPON LEARNING THE BROAD REASONS FOR THE

5. FERNANDEZ-DAVILA STATED THAT SENDERO LUMINOSO TERRORISM IN AYACUCHO (SL'S BIRTHPLACE) HAD GREATLY DIMINISHED AND WAS NOW VERY MUCH UNDER CONTROL. "THE [REDACTED] AL

NECESSITY SENDERO HAD THUS TURNED TO EMPHASIZING THE WORK OF ITS OTHER TWO ARMS: THE PARTY (THE "PCP") AND ITS FRONT GROUPS, BOTH IN PERU AND ABROAD (THE "FRENTE UNICA). THE PARTY, HE EXPLAINED, WAS NOW USING ITS FRONT GROUPS TO WAGE POLITICAL WAR AGAINST THE GOVERNMENT OF PERU - USING THE ISSUE OF "HUMAN RIGHTS" AS A CLUB.

7. THE GRAVITY OF THE HUMAN RIGHTS SITUATION HAD BEEN GREATLY EXAGGERATED, THE GENERAL ASSERTED. BUT SENDERO HAS LEARNED THAT IT CAN EFFECTIVELY TIE THE ARMY INTO KNOTS OVER THE ISSUE OF HUMAN RIGHTS. THE TACTICS ARE SIMPLE BUT EFFECTIVE: FILE FORMAL "DENUNCIAS" AGAINST THE MILITARY FOR ABUSES WHICH NEVER HAPPENED; INVENT THE "DISAPPEARANCES" OF PEOPLE WHOSE NAMES DO NOT EVEN APPEAR IN NATIONAL VOTER REGISTRIES; REPORT "MASSACRES" IN FARAWAY, INACCESSIBLE PLACES. WHILE THE MILITARY IS BUSY CHASING DOWN FALSE REPORTS (SENDING OUT ITS FEW HELICOPTERS TO THE SITES OF SUPPOSED INCIDENTS,

WRITING UP INVESTIGATIVE REPORTS, ETC.), FERNANDEZ-DAVILA LAMENTED, SENDERO IS PROVIDED GREATER FREEDOM OF ACTION (MILITARY AND POLITICAL) EVEN AS THE MILITARY INSTITUTION IS INCREASINGLY DEFAMED AND DEMORALIZED. "WE ARE SIMPLY SPENDING TOO MUCH TIME ON HUMAN RIGHTS CONCERNS."

THE AMBASSADOR POINTEDLY RAISED THE ISSUE OF TWO RECENT CASES IN AYACUCHO INVOLVING SUBSTANTIAL EVIDENCE OF MILITARY COMPLICITY: THE JUNE DISAPPEARANCE OF HUMAN RIGHTS WORKER GUADALUPE CCALLOCCUNTO AND THE OCTOBER DISCOVERY OF MASS GRAVES AT CHILCAHUAYCCO (REFS B AND C). WITHOUT ADMITTING MILITARY CULPABILITY IN EITHER CASE, FERNANDEZ-DAVILA ADDED THAT "OF COURSE, ALL THIS IS NOT TO SAY MY TROOPS ARE LITTLE ANGELS." AFTER ALL, THEY ARE FIGHTING HARD AGAINST A VICIOUS ENEMY WHICH PLAYS BY ITS OWN RULES. EXCESSES ARE BOUND TO OCCUR. BUT VIOLATIONS ARE INVESTIGATED AND PUNISHED, HE CLAIMED.

9. FERNANDEZ-DAVILA EXPLAINED THAT OVER SIXTY OF HIS TROOPS - INCLUDING MORE THAN A DOZEN OFFICERS - WERE CURRENTLY DOING TIME IN THE STOCKADE ON A VARIETY OF OFFENSES, INCLUDING HUMAN RIGHTS VIOLATIONS. OTHER CASES HAD BEEN REFERRED TO THE PUBLIC MINISTRY'S PROSECUTORS. BUT THE REAL PROOF OF HIS TROOPS' RESPECT FOR HUMAN RIGHTS, THE GENERAL ARGUED, IS THEIR PRESENCE IN THE COUNTRYSIDE AND THE CREATION OF THE "RONDAS CAMPESINAS" CIVIL DEFENSE GROUPS. "WE COULDN'T BE IN THE COUNTRYSIDE, DOING WHAT WE ARE DOING, IF THE 'CAMPESINOS' DIDN'T WANT US THERE OR ACCEPT OUR LEADERSHIP."

10. THE GENERAL SPOKE AT SOME LENGTH ABOUT THE MILITARY'S CIVIC ACTION EFFORTS AND THE NEED FOR STRONG CIVILIAN LEADERSHIP. "IT WAS MY SUGGESTION TO LIFT THE STATE OF EMERGENCY." HE COMMENTED, ADDING

TURNED OVER TO FORMAL CIVILIAN AUTHORITY IN THE COMING MONTHS. "IT IS TIME FOR THE POPULACE TO RE-LEARN HOW TO MAKE POLITICS ... THE CIVILIANS MUST AGAIN PLAY A ROLE IN THEIR OWN DEFENSE" AS THE ANTI-TERRORIST BATTLE IS INCREASINGLY BEING FOUGHT ON POLITICAL - NOT MILITARY - TERMS. POPULACE. THE PEASANTS HAVE BECOME ACCUSTOMED TO LOOKING TO THE MILITARY FOR HELP IN SOLVING THEIR PROBLEMS. NOW THAT HUAMANGA PROVINCE IS NO LONGER AN "EZ," FERNANDEZ-DAVILA EXPLAINED WITH A TOUCH OF IRONY, HE SENDS THE AID-SEEKING CAMPESINOS OFF TO SEE THE MAYOR AND OTHER CIVILIANS. "I'VE DONE MY JOB. NOW LET THE CIVILIANS DO THEIRS."

12. FERNANDEZ-DAVILA HAD LITTLE POSITIVE TO SAY ABOUT HIS CIVILIAN COUNTERPARTS. THERE IS NO PREFECT FOR THE REGION, THE GENERAL CLAIMED (ERRONEOUSLY). AND THE CURRENT MAYOR DOES NOT SPEAK FOR THE PEOPLE, HE ASSERTED, BECAUSE HE WAS NOT ELECTED TO THE POST. (UNITED LEFT MAYOR FERMIN AZPARRENT WAS KILLED BY SL ON SEPTEMBER 19, 1989. AYACUCHO'S NOVEMBER 1989 MUNICIPAL ELECTIONS WERE VOIDED AFTER MORE THAN TWO-THIRDS OF ALL VOTES CAST WERE NULL OR BLANK.) THE MAYORALTY, FERNANDEZ-DAVILA DECLARED, ROTATES EVERY TWO MONTHS AMONG THE "THREE" REMAINING TOWN COUNCILMEMBERS - AND ALL THEY DO IS SEEK FUNDING AND SUPPORT FOR THEIR OWN PET PROJECTS, WHICH ONLY BENEFIT THE PARTICULAR PARTIES OR LEADERS. ON THE OTHER HAND, HE ASSERTED, "I WORK FOR ALL THE PEOPLE." THE GENERAL BRUSHED OFF REPEATED ATTEMPTS TO GET HIM TO CONCEDE THAT THE LOCAL CIVILIAN LEADERS MERITED THE SUPPORT OF THE MILITARY - NOT ONLY

14. THE AMBASSADOR ALSO CALLED ON THE PUBLIC MINISTRY'S REPRESENTATIVES IN AYACUCHO. CHIEF PROSECUTOR JAVIER GONZALEZ TORRES (SERVING ONLY HIS THIRD DAY AS CHIEF "FISCAL") AND SPECIAL PROSECUTOR FOR HUMAN RIGHTS MARIO ALMONACID WERE JOINED BY A NEW ASSISTANT "FISCAL" FOR HUMAN RIGHTS (WHO HAD JUST ARRIVED IN AYACUCHO THAT MORNING FOR HER SWEARING-IN). GONZALEZ, WHO PREVIOUSLY HAD SERVED FOR SIX YEARS AS A MEMBER OF AYACUCHO'S SUPERIOR COURT, EXPLAINED THAT THE PUBLIC MINISTRY'S EFFORTS APPEARED TO BE GAINING SOME GROUND LOCALLY. NONE OF

THE FISCALES SPOKE OF THREATS OR INTIMIDATION FROM THE MILITARY. ALMONACID REPORTED, IN FACT, THAT WHILE MANY PROBLEMS STILL EXISTED, THEY HAD NOTICED INCREASED COOPERATION FROM MILITARY AUTHORITIES IN RECENT MONTHS.

15. THE AMBASSADOR ASKED THE FISCALES ABOUT THE STATUS OF THE CCALLOCCUNTO AND CHILCAHUAYCCO CASES. ALMONACID SPOKE OPTIMISTICALLY ABOUT HIS INVESTIGATION INTO THE CHILCAHUAYCCO MASSACRE, SAYING THE CASE WAS ALREADY QUITE ADVANCED AND MOVING FORWARD RAPIDLY. JUST THAT DAY, HE NOTED, THE FISCALES HAD RECEIVED A FORMAL LETTER FROM GENERAL FERNANDEZ-DAVILA (WHICH ALMONACID SHARED WITH THE

THE LETTER, WITHOUT EXPLICITLY IMPLICATING "CENTURION" IN THE CHILCAHUAYCCO INCIDENT, NONETHELESS IDENTIFIED HIM AS ARMY SERGEANT JHONNY JOSE ZAPATA ACUNA, ATTACHED TO THE ARMY UNIT AT HUANTA. THE GENERAL'S LETTER WILL PERMIT THE PROSECUTION TO MOVE THE INVESTIGATION EVEN FURTHER FORWARD.

16. THE AMBASSADOR CONGRATULATED THE FISCALES ON THEIR WORK, ATTEMPTING - AT GREAT PERSONAL RISK - TO ESTABLISH THE RULE OF LAW IN THE MIDST OF A WAR ZONE. THE FISCALES COMMENTED, IN EFFECT, THAT THEY WERE JUST DOING THEIR JOBS: NORMAL PEOPLE DOING NORMAL JOBS, EVEN IF THE CIRCUMSTANCES WERE LESS THAN IDEAL.

AROUND THE CITY RPT CITY OF AYACUCHO. A NUMBER OF OTHER CONTACTS, CIVILIAN AND MILITARY, REPORTED THE SAME IMPRESSION. BUT THE GENERAL'S VIEW WAS PERHAPS OVERLY ROSY. WE ARE NOT CONVINCED, FOR EXAMPLE, THAT SL'S LOWERED PROFILE IS ENTIRELY DUE TO THE ARMY'S EFFORTS WITH THE "RONDAS", WHICH IS A RURAL, NOT URBAN, PHENOMENON IN AYACUCHO. NOR ARE WE CONVINCED THAT SENDERO IS BEATEN IN THE CITY: THREE DAYS BEFORE THE AMBASSADOR'S VISIT UPWARDS OF FIFTY HEAVILY ARMED SENDERISTAS ATTACKED A GAS STATION SIX BLOCKS FROM THE PLAZA DE ARMAS DURING DAYLIGHT HOURS - AND THE SECURITY FORCES TOOK MORE THAN HALF AN HOUR TO RESPOND. THE MILITARY SITUATION IS WORSE IN OTHER PARTS OF THE DEPARTMENT, WHICH STILL HAS THE NATION'S HIGHEST PER CAPITA DEATH RATE FROM POLITICAL VIOLENCE.

18. WE HAVE PREVIOUSLY HEARD FROM OTHER HIGH MILITARY OFFICIALS (GENERAL ARCINIEGA, AMONG OTHERS) THAT SL FRONT GROUPS (NOT FURTHER DEFINED) "INVENT" UNVERIFIABLE CASES OF MILITARY ABUSE IN THE HINTERLANDS. AS FERNANDEZ-DAVILA WELL KNOWS,
