((EXCERPTS)) HORY CHLIMPER HALFIN, 70, A WELL-KNOWN BUSINESSMAN IN THE CHEMICAL-PHARMACEUTICAL SECTOR, WAS KIDNAPPED ON THE MORNING OF 3 DECEMBER BY A GROUP OF TUPAC AMARU REVOLUTIONARY MOVEMENT (MRTA) SUBVERSIVES AS HE WAS PARKING HIS CAR IN THE GARAGE OF ONE OF HIS ENTERPRISES IN LINCE.

AFTER VIOLENTLY CAPTURING HIM AND PUTTING HIM IN ANOTHER VEHICLE, THE TERRORISTS DETONATED A DEVICE IN HALFIN'S VEHICLE. THE SHRAPNEL FROM THE DEVICE WOUNDED A WORKER.

AS THEY LEFT THE GARAGE, WHICH IS USED ONLY BY EMPLOYEES, THE TERRORISTS SHOT AT THE GUARDS OF THE KAHAN DRUG STORE, WHICH LOCATED
