7. IN THE COURSE OF THE LAST THREE DAYS I HAVE CALLED ON THE MINISTERS OF INTERIOR, DEFENSE AND FOREIGN AFFAIRS. DUPING EACH MEETING, WHICH WILL BE REPORTED SEPTELS, I HAVE GONE OVER THE VARIOUS CONGRESSIONAL CONDITIONS GIVACHED TO THE DISBURSEMENT OF OUR AID. THE FOREIGN MINISTER THOSE CAREFUL NOTES; THE OTHERS POLITELY LISTENED TO MY PITCH. NONE SEFMED SURPRISED AT THE EXTENSIVE THE THE HUMAN RIGHTS OR



NARCOLICS ARENAS. IN PART THIS IS PROBABLY THE RESULT OF THEIR PERCEPTION THAT THESE ARE MATTERS ABOVE THEIR PAY GRADE, 1.E., A MATTER ONLY FOR THE PRESIDENT. THE FACT THAT THESE KEY MINISTERS (IN ADDITION TO THE MINISTER OF ECONOMY AND FINANCE, WHO HAD BEEN BRIEFED EARLIER - LIMA 15737) ACCEPT OUR CONDITIONS IS A POSITIVE SIGN AND SHOULD FACILITATE THEIR GIVING APPROPRIATE INSTRUCTIONS TO THEIR SUBORDINATES. SOME CONDITIONS, SUCH AS INVESTIGATION OF PENDING HUMAN RIGHTS CASES, ARE OUTSIDE THEIR PURVIEW. OTHERS, SUCH AS CONTROL OF AIRFIELDS AND MAJOR OPERATIONS, WILL DEPEND ON DIRECT PRESIDENTIAL GUIDANCE AND INSTRUCTIONS. I WILL BE WORKING ON THAT ASPECT OF THE PROBLEM WHEN FUJIMORI RETURNS FROM HIS ASIAN TOUR. QUAINTON##
