

7. (C) COMMENT: THE GOVERNMENT AND CIVIL SOCIETY FOR YEARS HAVE SOUGHT IN VAIN AN AGREEMENT WITH THE

- 13. (C) ONCE UNTOUCHABLE, PERUVIAN PRESIDENT FUJIMORI HEADS INTO THE APRIL 9 ELECTIONS WITH A GOOD CHANCE OF BEING FORCED INTO A SECOND ROUND WITH ALEJANDRO TOLEDO, WHOSE POPULARITY HAS BEEN SURPRISING. IF FACED WITH A RUNOFF, FUJIMORI MAY BE UNABLE TO RESIST TAMPERING TO RETAIN POWER, EVEN UNDER THE GLARE OF HEIGHTENED INTERNATIONAL ATTENTION.
- 14. (C) THE FRAUD FACTOR. THE FINAL PHASE OF A CAMPAIGN WHOSE INTEGRITY HAS ALREADY SUFFERED "IRREPARABLE DAMAGE," ACCORDING TO INTERNATIONAL OBSERVERS, HAS SEEN FUJIMORI SCRAMBLE TO INTRODUCE A SEMBLANCE OF FAIRNESS AND TRANSPARENCY. HE BUILT AN EARLY LEAD IN PART THANKS TO DIRTY TRICKS MASTERMINDED BY HIS NATIONAL SECURITY AND INTELLIGENCE ADVISER, VLADIMIRO MONTESINOS. HE PROMISES JOBS, EDUCATION, AND DIGNITY, IN CONTRAST TO FUJIMORI'S HANDOUTS. TOLEDO IS ALSO COMMITTED TO RESTORING DEMOCRACY AND UNDOING MONTESINOS' FIRM, IF UNOFFICIAL, HOLD ON THE COUNTRY'S INTELLIGENCE APPARATUS

AND ARMED FORCES. TOLEDO SHRUGS OFF SMEAR ATTEMPTS, SUCH AS ALLEGATIONS OF INVOLVEMENT IN A PYRAMID SCHEME AND FATHERING AN ILLEGITIMATE CHILD, AVOIDING THE KIND OF AD HOMINEM EXCHANGES THAT FUJIMORI'S FORCES USUALLY WIN.
