1. THE PERUVIAN CIVIL GUARD (GC) REPORTED THAT DURING THE EARLY MORNING HOURS OF MARCH 9, THE SMALL AYACUCHO HAMLET OF LA QUINUA WAS TAKEN OVER BY SOME 40 TO 50 ARMED TERRORISTS, WHO UNSUCCESSFULLY BESIEGED THE GC STATION THERE, AND THEN WITHDREW. DESPITE A FIREFIGHT THAT

AT APPROXIMATELY THE SAME TIME, THE REPUBLICAN GUARD (GR) REPORTED REPELLING AN ARMED ATTACK ON A MICROWAVE REPEATING TOWER IN THE NEIGHBORING DEPARTMENT OF APURIMAC, AND A BOMB EXPLODED AT A PLAINCLOTHES POLICE (PIP) OFFICE IN HUARAZ. THE PREVIOUS DAY, A PIP OFFICER'S HOUSE WAS DYNAMITED AND A BOMB WAS DEACTIVATED AT THE PIP OFFICE IN THR NORTHERN COASTAL CITY OF TRUJILLO.
