

INTERIOR MINISTER HAS ACKNOWLEDGED THAT LOCAL POLICE OFFICIALS WERE IMPLICATED IN SLAYING OF ONE SUCH "DESAPARECIDO."

- 2. (U) DISAPPEARANCE OF JESUS OROPEZA. IN AN INITIAL, WRITTEN REPORT TO SENATE OF AUGUST 13, INTERIOR MINISTER LUIS PERCOVICH PROVIDED RESULTS OF AN INTERNAL POLICE INVESTIGATION INTO DEATH OF CAMPESINO ORGANIZATION LEADER JESUS OROPEZA (REF A). REPORT ASSERTED THAT POLICE DETAINED ORPEZA IN PUQUIO ON JULY 27; ATTEMPTED TO TRANSFER HIM TO ARMY GARRISON SOME 90 KILOMZTERS DISTANT, LEAVING FOR THIS PURPOSE AT 4 A.M. FOLLOWING MORNING; FOUND GARRISON UNWILLING TO ACCEPT PRISONER, AFTER WHICH POLICE SET OFF ON RETURN TRIP TO PUQUIO WITH OROPEZA; STOPPED ALONG ROAD AT 11 A.M. TO ALLOW HIM TO ATTEND TO "PHYSIOLOGICAL NEEDS;" WITNESSED HIM ATTEMPT TO ESCAPE AFTER WALKING SOME 30 METERS FROM POLICE VEHILCLE; OPENED FIRE ON ESCAPEE, ONLY TO BE FORCED TO ABANDON LOCALE IN HASTE UPON SUDDEN APPEARANCE OF 25-30 ARMED MEN (APPAR-ENTLY TERRORISTS). REPORT CONCLUDED BY STATING THAT, WHEN POLICE WERE ABLE TO RETURN TO SITE AFTERWARDS, THEY ENCOUNTERED OROPEZA'S MUTILATED CORPSE--PRESUMABLY HAVING BEEN DONE IN BY THE MYSTERIOUS INTRUDERS.
- 3. (U) FACED WITH UNFAVORABLE SENATE REACTION PERCOVICH FOLLOWED UP WRITTEN REPORT WITH PERSONAL APPEARANCE, TESTIFYING BEFORE CLOSED SESSION AUGUST 16. AT CLOSE OF SESSION, SENATE ISSUED TERSE COMMUNIQUE NOTING THAT GROUNDS EXISTED "TO PRESUME THAT THE CITIZEN OROPEZA COULD HAVE BEEN VICTIMIZED BY (THOSE) FORCES RESPONSIBLE FOR HIS CUSTODY AND TRANSPORT." PERCOVICH HIMSELF, AFTER NOTING THAT HIS INITIAL REPORT HAD BEEN BUT A TRANSMITTED

COPY OF REPORT GIVEN HIM BY POLICE, ACKNOWLEDGED THAT PUQUIO POLICE WERE PRESUMABLY RESPONSIBLE FOR OROPEZA'S DEATH. IN FURTHER COMMENTS AUGUST 17, PERCOVICH DENIED THAT ANY PROOF EXISTED TO SUSTAIN CHARGE--MADE BY OROPEZA'S LOCAL ENEMIES IN PUQUIO -- THAT DECEASED CAMPESINO LEADER WAS LINKED TO TERRORISTS.



GENERAL ("FISCAL DE LA NACION") PERSONALLY SET OFF AUGUST 14 FOR AYACUCHO AND HUANTA TO INVESTIGATE DISAPPEARANCE OF NEWSPAPER REPORTED JAIME AYALA (REF A). RETURNING TO LIMA ON 15TH, A DISAPPOINTED FISCAL DIS-CLOSED THAT HIS TRIP HAD YIELDED NO CLUES AND THAT HE HAD UNCOVERED NO INFORMATION CONCERNING AYALA'S FATE OR WHEREABOUTS. AT MOMENT, THEREFORE, AYALA DISAPPEARANCE REMAINS SUBJECT FOR CONFLICTING RUMORS AND NEWSPAPER ACCOUNTS. HIS BODY, ACCORDING TO SOME, LIES AT BOTTOM OF HIGHLANDS LAKE; OR WAS ONE OF GROUP OF 10 (OR 17) CADAVERS DISCOVERED MORNING OF AUGUST 18 NEAR HUANTA. BUT AYALA'S EMPLOYER, LIMA DAILY "REPUBLICA," PERSISTS WITH "UPBEAT" REPORTS THAT JOURNALIST IS ALIVE, IF NOT WELL, AND RECOVERING FROM INJURIES SUSTAINED AT HANDS OF MARINE CAPTORS. AUGUST 20 LIMA DAILIES CARRIED STORY ASSERTING THAT GROUP OF "ARGENTINE AND PERUVIAN PRIVATE DETECTIVES" HAD LOCATED AYALA, SUPPOSEDLY NOW IN HANDS OF INVESTIGATIVE POLICE (PIP) AND STILL IN HUANTA.






