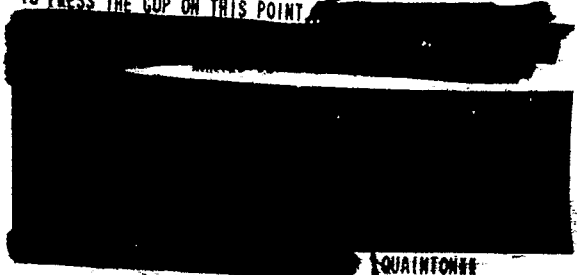

RETURN OF DEMOCRATIC INSTITUTIONS. IN A RECENT CONVERSATION WITH PRIME MINISTER DE LA PUENTE I HAD FOUND SOME WILLINGNESS TO ENGAGE IN A DIALOGUE WITH THE OPPOSITION. ON THE OTHER HAND, ALL POLITICAL PARTIES SEEMED VERY MUCH COMMITTED TO OPPOSE FUJIMORI. I THOUGHT THE FIRST GESTURE WOULD HAVE TO COME FROM THE PALACE OR FROM A SENIOR MEMBER OF THE GOVERNMENT. I URGED NISHIZAKI TO PRESS THE GOP ON THIS POINT.

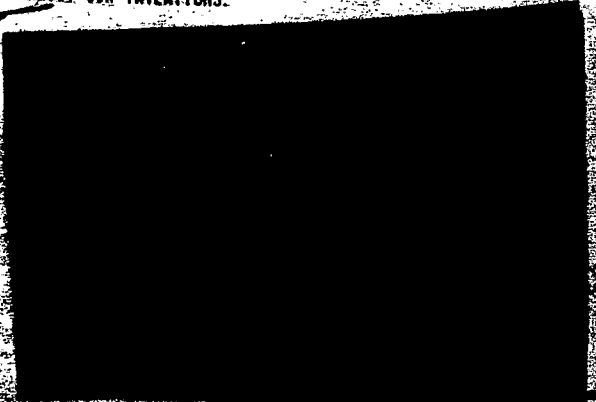

2. ON APRIL 13 I MET WITH JAPANESE AMBASSADOR NISHIZAKI TO DISCUSS TOKYO'S POSITION ON THE APRIL 5 COUP. NISHIZAKI HAD MET WITH PRESIDENT FUJIMORI EARLIER IN THE DAY. THE PRESIDENT, HE SAID, WAS EXTREMELY OPTIMISTIC, POINTING TO THE EXTRAORDINARY PUBLIC SUPPORT FOR HIS DISSOLUTION OF THE PARLIAMENT. FUJIMORI INDICATED THAT THIS SUPPORT WOULD CONTINUE TO INCREASE AS FURTHER REFORM MEASURES WERE CARRIED OUT. THE PRESIDENT WAS CONCERNED TO LEGITIMIZE HIS RULE THROUGH AN EARLY PLEBISCITE AND WAS COMMITTED TO CARRYING ONE OUT WITHIN SIX MONTHS AS HE HAD ANNOUNCED THE NIGHT BEFORE. NISHIZAKI ALSO COMMENTED THAT HE SEEMED WORRIED ABOUT THE US POSITION AND UNCERTAIN ABOUT OUR INTENTIONS.
