1. EPISCOPAL SOCIAL ACTION COMMITTEE (CEAS) HAS PROVIDED EMBASSY MATERIAL ON ALLEGED DISAPPEARANCES IN THE AYACUCHO EZ (REF A) IN ADDITION TO THAT PROVIDED IN REF B.

2. BASED ON RELATIVES' LETTERS TO MILITARY AND POLICE AUTHORITIES, AND FORMAL COMPLAINTS TO THE PUBLIC MINISTRY, FOLLOWING IS INFORMATION ON THESE FIVE CASES.

CESAR MITMA DE LA CRUZ: ACCORDING TO HIS DAUGHTER, ARMY PERSONNEL TOOK HIM FROM HIS HOME IN CUSIBAMBA, CANGALLO PROVINCE ON JANUARY 25, 1985.

JUAN ANTONIO LUYA CARRASCO: ACCORDING TO HIS WIFE, ARMED MASKED MEN TOOK HIM FROM THEIR HOUSE ON THE OUTSKIRTS OF AYACUCHO CITY. THE WIFE FURTHER CLAIMS THAT ANOTHER PRISONER TOLD HER THAT LUYA WAS HELD IN LOS CABITOS GARRISON IN AYACUCHO.
