1. (U) SUMMARY: PRESIDENT FUJIMORI REPORTEDLY
SELECTED EX-FOREIGN MINISTER BLACKER MILLER AS
HIS "PERSONAL REPRESENTATIVE" TO THE OAS. THE
PRESS SPECULATED THAT BLACKER WAS BEING GROOMED
AS THE NEW AMBASSADOR TO WASHINGTON. FUJIMORI
SPOKE WITH THE PRESS AND DISCARDED THE
POSSIBILITY OF A MILITARY COUNTER- COUP. HE

DEFENDED HIS TIMETABLE BUT AGREED TO STUDY ALTERNATIVES, IF THEY EXISTED. SAN ROMAN UNVEILED HIS PERSONAL TIMETABLE FOR A RETURN TO DEMOCRACY. HIS PLAN INCLUDED AN ELECTED CONSTITUENT ASSEMBLY, A TRANSITIONAL GOVERNMENT AND EARLY RESIGNATIONS OF THE PRESIDENT, VICE PRESIDENTS AND CONGRESS. A COURT FINALLY FORMALLY ORDERED EX-INTERIOR MINISTER MANTILLA'S DETENTION. A POSSIBLY DETAINED APRA YOUTH REAPPEARED. THE ARMY PUT DOWN RIOTS IN THE SENDERO LUMINOSO-DOMINATED LIMA SLUM RAUCANA - THE COST, ONE DEAD AND 12 INJURED. END SUMMARY.

FONMIN, AUGUSTO BLACKER MILLER, TO REPRESENT HIM AT THE MAY 1 OAS PERU MEETING. MEDIA SPECULATED THAT THIS POSITIONED BLACKER TO BE NAMED LATER AS AMBASSADOR TO WASHINGTON. FUJIMORI'S ANNOUNCEMENT SURPRISED LIMA'S POLITICAL AND MEDIA COMMUNITIES, GIVEN BLACKER'S LONG LIST OF MISTAKES DURING HIS TENURE AT MFA. THESE INCLUDED HIS OPEN RIVALRY WITH CARLOS BOLONA (WHICH COST HIM HIS CABINET POSITION,) HIS RUN-INS WITH THE IAHRIC, AND HIS PREMATURE DISCLOSURE OF A LONGER RETURN-TO-DEMOCRACY TIMETABLE THAT FUJIMORI LATER OVERTURNED.

3. (U) PRESIDENT FUJIMORI ANSWERED REPORTER'S QUESTIONS ON APRIL 28 WHILE AT THE AIRPORT AWAITING THE RETURN OF HIS SON KENJI FROM A KARATE TOURNAMENT IN-CALIFORNIA. (KENJI GOT A BRONZE MEDAL.) THE HIGHLIGHTS:

-- WHEN ASKED ABOUT THE POSSIBILITY OF A COUNTER-COUP HE REPLIED, "IT IS IMPOSSIBLE, THE PEOPLE WANT DEMOCRACY AND NOT EVEN ARMED FORCE CAN GO AGAINST POPULAR WILL."

-- HE SAID LATEST POLLS SHOW 91 PERCENT OF PERUVIANS SUPPORT A PLEBISCITE.

-- IN REFERENCE TO POSSIBLE CHURCH MEDIATION, HE ACCEPTED "OPEN DIALOGUE WITHOUT MEDIATION."

- JULY 28; THE NEWLY INSTALLED CONSTITUENT
ASSEMBLY ELECTS A "TRANSITIONAL GOVERNMENT,"
- OCTOBER 31; REFORMED CONSTITUTION PROMULGAT-
ED AND GENERAL ELECTIONS ANNOUNCED,
- NOVEMBER 8; THE TRANSITIONAL GOVERNMENT
HOLDS MUNICIPAL ELECTIONS,
- JANUARY 31, 1993; GENERAL ELECTIONS FOR

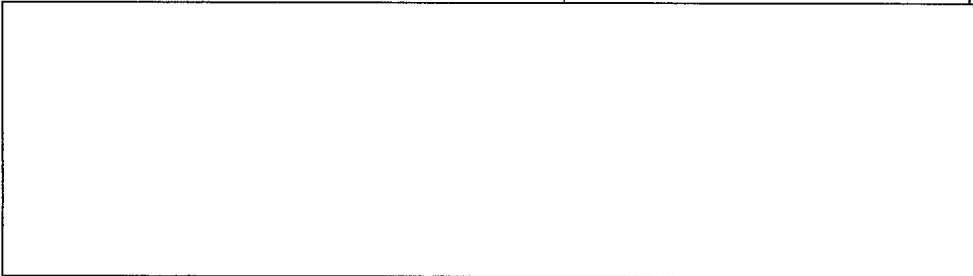

WOUNDING AT LEAST 12 OTHERS. APPROXIMATELY 200 TOWNS PEOPLE MARCHED ON THE MILITARY GARRISON IN THE PUEBLO JOVEN TO DEMAND THE IMMEDIATE RELEASE FROM DETENTION OF RAUCANA'S SECRETARY GENERAL AND ONE OTHER PERSON, BOTH OF WHOM WERE DETAINED BY THE GARRISON FOR SUSPECTED TIES TO SENDERO LUMINOSO. MEDIA ACCOUNTS SAID THE SOLDIERS OPENED FIRE WITHOUT AUTHORIZATION FROM THEIR OFFICERS WHEN THE CROWD BEGAN TO STONE THEM. COMMENT: RAUCANA IS ONE OF THE HOTTEST PUEBLO JOVENES, AND THE PREVIOUS RAUCANA SECRETARY GENERAL WAS CAUGHT RED-HANDED WITH SENDERO PROPAGANDA AND EXPLOSIVES. END COMMENT.

10. (U) THE PRESS REPORTED APRIL 28 THE PERUVIAN AIR FORCE (FAP) INTERCEPT AND FORCED LANDING OF A COLOMBIAN REGISTERED SUSPECTED DRUG PLANE. THE CESSNA WAS FORCED TO LAND AT ANDOAS. IT WAS IN-BOUND AND APPARENTLY NO DRUGS WERE FOUND. THE PRESS REPORTED THAT THIS AS THE 65TH FAP INTERCEPT, THE 64TH BEING THE USAF
