1. (U) THE THREE MEMBERS OF PERU'S PEACE COMMISSION ANNOUNCED THEIR RESIGNATIONS ON JULY 6. THE MEMBERS HAD BEEN ON THE VERGE OF THIS ACTION SINCE THE DENOUEMENT OF THE JUNE LIMA PRISON RIOTS, WHEN THE COMMISSION HAD ATTEMPTED TO NEGOTIATE WITH INMATES. GOP HAS NOT ANNOUNCED ACCEPTANCE OF RESIGNATIONS.
