WHILE ALL OF THIS WAS GOING ON, ACCORDING TO THE SL CAMARADA, THE POLICE DROPPED THEIR GUARD. SL MALE PRISONERS IN PAVILION 4B, USING PRIVATE KEYS TO THE INTERNAL DOORS, SHUCK UNDETECTED THROUGH THE CONNECTING HUB BETWEEN THE PAVILIONS AND CAUGHT THE POLICE BY SURPRISE, FORCING THEM TO RETREAT. BY THIS ACCOUNT, THE SL MEN BRANDISHING ONLY KNIVES OVERWHELMED THE HEAVILY ARMED POLICE, SEIZED SOME OF THEIR WEAPONS AND PERMITTED THE REST OF THE SL WOMEN TO FLEE TO PAVILION 4B. THE POLICE FELL BACK IN DISARRAY AFTER TAKING CASUALTIES AND LOSING SOME
WEAPONS. DID NOT NECESSARILY CREDIT THIS
SE ACCOUNT OF MAY 6, BUT HE THOUGHT IT WOULD GET WENT TO CASTRO CASTRO MAY 7 AND 8 SEEKING ENTRANCE UNSUCCESSFULLY, THE FIRST TIME BEING REFUSED ACCESS PERSONALLY BY MINISTER OF INTERIOR GENERAL BRIONES ON THE GROUNDS THAT HIS SECURITY COULD NOT BE ASSURED. AT 6 PM ON MAY 8. HOWEVER, POLICE DIRECTOR GENERAL CUBA Y ESCOBEDO CALLED SAYING THAT THE SL HAD AGREED TO BE TRANSFERRED PEACEFULLY, BUT ONLY UNDER ICRC SUPERVISION. AND AN ASSISTANT ARRIVED AT THE PRISON AN HOUR LATER, BLUFFING THE IR WAY THROUGH PERIMETER GUARDS WHO HAD NOT GOTTEN GENERAL CUBA'S ORDERS TO LET THEM PASS.

AT THE PRISON MET WITH A FEMALE PROSECUTOR AND HER ASSISTANT WHO HAD BEEN NEGOTIANG ALL DAY WITH THE SL FOR A PEACEFUL TRANSFER OF PRISONERS, PRESUMABLY WOMEN ONLY. THE PROSECUTOR, ANIMATED SAID BY A WELL MEANING BUT THE OFFICE OF THE OFFI ESTABLISHED PROCEDURES, INSISTED ON WAITING FOR MEDICAL EXAMINER. (THE DOCTOR'S JOB WAS TO EXAMINE EACH WOMAN TO ENSURE THAT SHE HAD NOT BEEN RAPED BY GOP FORCES.) AT 9:38 THE DELEGATION WAS COMPLETE: SEVERAL PROSECUTORS, THE TERRORISM DUTY JUDGE AND MEDICAL EXAMINER. <u>R</u>ESISTING PRESSURE TO WEAR A FLACK JACKET, ENTERED THE COMPOUND AND HAILED THE SL USING A MEGAPHONE TO ASSURE THE PRISONERS THAT AND PREPARED TO OBSERVE AND GUARANTEE THAT THE TRANSFER WOULD TAKE PLACE PEACEFULLY AS AGREED. WHILE WAITING FOR THE SL TO RESPOND, MET AGAIN IN A GARAGE WITH GENERAL CUBA. THE GENERAL INSISTED THAT THE TONLY OBSERVE AND NOT GET DRAWN INTO NEGOTIATIONS WITH THE SL. OTHERWISE THE DEAL WOULD COME APART. AGREED. FINALLY SIX SL WOMEN HEADED BY CYBEL ARREDONDO, THE CHILEAN WIDOW OF A FALLEN COMPADE, CAME INTO THE ROOM.

18. SUNDAY, MAY 18 AFTER THE SL PAVILIONS HAD BEEN TAKEN, THE POLICE HOSPITAL TOLD HAD 53 WOUNDED. COULD VISIT THEM WITH PERMISSION FROM THE MINISTER OF INTERIOR. NO LUCK, MINISTER BRIONES WAS PERMANENTLY IN CONFERENCE. LATE ON MONDAY MAY 11 (OR POSSIBLY ON TUESDAY) INTO THE POLICE HOSPITAL WHERE BY OFFICIAL FIGURES 28 BADLY WOUNDED SL MERE SUPPOSED TO BE HELD. PERSONNEL THERE TOLD THEM THAT THERE ORIGINALLY HAD BEEN 29 WOUNDED, OF WHICH NINE HAD BEEN TRANSFERRED BACK TO "A PRISON," LOCATION UNSPECIFIED. THREE OF THE REMAINING 28 HAD DIED AT THE HOSPITAL. WAS ALLOWED TO SEE THE REST (18 MEN AND 7 WOMEN) EXCEPT FOR ONE WOMAN WHO WAS IN THE OPERATING ROOM. THEY WERE IN BAD SHAPE AND HAD FIELD DRESSINGS; BUT MOST HAD NOT BEEN OPERATED ON FOR LACK OF MEDICINES. GUARANTEED TO MAKE UP ANY SUPPLIES THE MOSPITAL USED. THE HOSPITAL BEGAN OPERATING ON THE REST OF THE SL WOUNDED WEDNESDAY, MAY 13.  DID NOT KNOW THE STATUS OR NUMBER OF THE "LIGHTLY WOUNDED" STILL BEING HELD AT CASTRO CASTRO, NOR DID HE COMMENT ON THE DISCREPANCY BETWEEN THE 53 FIRST MENTIONED BY THE HOSPITAL AND THE FINAL COUNT.
