NEW FMS SALES: NO NEW LOANS WILL BE SIGNED FOR PERUVIAN ACQUISITION OF EQUIPMENT, TRAINING, OR SERVICES FUNDED BY FMF OR AS FMS CASH SALES USING PERUVIAN NATIONAL FUNDS.

EXISTING FMS CASES: WITH REGARD TO CASES FOR WHICH LOANS ALREADY EXIST, THE FOLLOWING GUIDELINES APPLY:

-- FMF-FUNDED CASES: ONWARD DELIVERIES TO PERU UNDER THE FMF CASES ARE DEFERRED INDEFINITELY.

-- FMS CASH CASES (I.E. PERUVIAN NATIONAL FUNDS)

---- LETHAL CASES: NO FURTHER PROCUREMENT ACTIONS WILL TAKE PLACE; DELIVERIES UNDER THE CASES ARE DEFERRED INDEFINITELY.

---- OTHER CASES: NO FURTHER PROCUREMENT ACTIONS WILL TAKE PLACE; DELIVERIES UNDER THE CASES ARE DEFERRED INDEFINITELY.

506 ITEMS: THE DRAWDOWN PACKAGE WHICH WAS UNDER CONSIDERATION FOR PERU UNDER FAA SECTION 506 WILL NOT BE NOTIFIED TO THE CONGRESS AT THIS TIME.

EDA MATERIALS: THE EDA PACKAGE WHICH WAS UNDER CONSIDERATION FOR PERU WILL NOT BE NOTIFIED TO THE CONGRESS AT THIS TIME.

IMET (OR FMS-CASE) TRAINING: STUDENTS ALREADY OUTSIDE PERU AS OF APRIL 7 WILL BE ALLOWED TO FINISH THEIR COURSES AND RETURN. NO NEW STUDENTS WILL BE ACCEPTED.

COMMERCIAL EXPORTS: NO NEW LICENSES FOR COMMERCIAL EXPORT OF ITEMS ON THE U.S. MUNITIONS LIST WILL BE APPROVED. EXISTING COMMERCIAL LICENSES WILL BE SUSPENDED WITH THE UNDERSTANDING THAT NON-LETHAL ITEMS WILL BE RELEASED FOLLOWING A CASE BY CASE REVIEW OF ANY APPEALS FOR WAIVER THAT MAY ARISE.
